The Legislative Rule-Making Review Committee met in the Senate Judiciary Committee Room at 11:00 a.m. on Tuesday, October 20, 2015. The meeting was called to order by the Chair, Delegate Kelli Sobonya. A silent roll call was taken by the Clerk as reflected above. Senator Karnes moved that the committee recommend the DEP to withdraw these three rules. Senator Karnes withdrew his motion.

Delegate Fleischauer moved to lay these three rules over until the next meeting of the Legislative Rule-Making Review Committee in November. The motion was adopted.

With no further business coming before the committee, Senator Maynard moved to adjourn. The motion was adopted.
