The Legislative Rule-Making Review Committee met in the Senate Judiciary Committee Room at 9:00 a.m. on Friday, October 25, 2019. The meeting was called to order by the Chair, Senator Maynard. A silent roll call was taken by the Clerk to establish a quorum, as reflected above. Staff present included: Max Wilkinson, House Counsel; Arlie Hubbard, House Counsel; James Fuerhoff, Director of Legislative Rule-Making Review Committee; and Beverly Douglas, Committee Clerk.

The first order of business was consideration of the following legislative rules:
