Standing Committee on the Judiciary

Minutes for February 25, 2025, 9:00 AM

Pursuant to the call of the Chair, the Standing Committee on the Judiciary met on Tuesday, February 25, 2025 at 9:00 AM in the House Judiciary Committee Room with Delegate Akers in the Chair.

Members absent: None.

A silent roll call being taken, the presence of a quorum was established.

On motion of Vice-Chairman Maynor, the minutes of the previous meeting were approved.

Chairman Akers recognized the clerk for purposes of receiving subcommittee reports:

The House Subcommittee on Courts has had under consideration House Bill 2117 and reports the same back to the Standing Committee on the Judiciary.

The House Subcommittee on Courts has had under consideration House Bill 2217 and reports back a Committee Substitute therefor to the Standing Committee on the Judiciary.

The House Subcommittee on Homeland Security has had under consideration House Bill 2362 and reports the same back to the Standing Committee on the Judiciary.

House Bill 2006, Defining Men and Women

Chairman Akers recognized Vice-Chairman Maynor for purposes of making a motion. Vice-Chairman Maynor moved for the committee to consider the proposed committee substitute in lieu of the introduced version. Chairman Akers put the question before the committee on adoption of the motion. The motion was adopted and the committee proceeded to consideration of the committee substitute.

Chairman Akers recognized counsel for purposes of explaining the committee substitute. Chairman Akers called for questions of counsel. Questions and discussion from the committee members followed. Chairman Akers called for amendments to the committee substitute. Hearing none, Chairman Akers recognized Vice-Chairman Maynor for purposes of making a motion.

Vice-Chairman Maynor moved to report Committee Substitute for House Bill 2006 to the floor with the recommendation that it do pass. Chairman Akers called for discussion on the motion. Chairman Akers put the question before the committee on adoption of the motion. The motion was adopted and the committee substitute will be reported as moved.

House Bill 2117, Relating to when Mail In Ballots are Due

Chairman Akers recognized Delegate Phillips as a cosponsor for purposes of explaining the bill. Chairman Akers called for questions of Delegate Phillips. Questions and discussion from the committee members followed. Chairman Akers recognized Delegate Fluharty for purposes of making a motion.

Delegate Fluharty moved to postpone the bill indefinitely. Chairman Akers called for discussion on the motion. Chairman Akers put the Question before the committee on adoption of the motion. The motion was rejected and the bill was not postponed indefinitely.

Chairman Akers advanced the bill to markup and discussion.

Committee Substitute for House Bill 2217, Relating to penalties for conspiracy to commit murder

Chairman Akers recognized Delegate Steele as the lead sponsor for purposes of explaining the bill. Chairman Akers called for questions of Delegate Steele. Questions and discussion from the committee members followed. Chairman Akers advanced the bill to markup and discussion.

House Bill 2362, Relating to recognizing the law-enforcement powers of correctional officers employed by the Division of Corrections and Rehabilitation

Chairman Akers recognized Delegate Kelly as the lead sponsor for purposes of explaining the bill. Chairman Akers called for questions of Delegate Kelly. Questions and discussion from the committee members followed. Chairman Akers advanced the bill to markup and discussion.

On motion of Vice-Chairman Maynor, the committee adjourned.
