Standing Committee on the Judiciary

Minutes for January 27, 2026, 11:00 AM

Pursuant to the call of the Chair, the Standing Committee on the Judiciary met on January 27, 2026, at 11:00 AM, in the House Judiciary Committee Room 410-M, with Delegate Akers in the Chair.

A silent roll call being taken, the presence of a quorum was established.

On motion of Vice-Chairman Maynor, the minutes of the previous meeting were approved.

Chairman Akers recognized the clerk for purposes of receiving subcommittee reports:

The House Subcommittee on Legal Services has had under consideration House Bill 4080 and reports the same back to the Standing Committee on the Judiciary.

The House Subcommittee on Legal Services has had under consideration House Bill 4137 and reports the same back, with amendment, to the Standing Committee on the Judiciary.

The House Subcommittee on Courts has had under consideration House Bill 4412 and reports the same back, with amendment, to the Standing Committee on the Judiciary.

House Bill 4036, Relating to stricter enforcement for parking in a handicapped designated spot

Chairman Akers recognized counsel for purposes of explaining the bill. Chairman Akers called for questions of counsel. Questions from the committee members followed. Chairman Akers called for amendments to the bill. There being no amendments offered, Chairman Akers recognized Vice-Chairman Maynor for purposes of making a motion.

Discussion from the committee members followed. Chairman Akers put the question before the committee on adoption of the motion to report the bill. House Bill 4138, Relating to persons convicted of a crime

House Bill 4137, Updating the West Virginia Law Institute

House Bill 4412, Require pornography websites to utilize age verification methods to prevent minors from accessing content
