Mr. Johnson,

Under the West Virginia Freedom of Information Act, §29-B-1-1 et seq., I am requesting an opportunity to inspect or obtain copies of public records which detail certain spending by the West Virginia Supreme Court of Appeals, its justices and employees. Please provide the following records:

1. Any and all purchases by the justices and court employees related to fuel and travel costs from 2009 to present, using a "Travel Visa" credit card issued by CitiBank and a "Fuel Card" issued by Wex Bank. Additionally, please provide any pertinent records of similar purchases made by alternate means of payment which are not specifically listed in this request, including but not limited to other forms of credit card payments, debit card payments, purchasing card payments, check payments, money order payments, money transfer payments and cash payments.

2. Any and all charges for meals purchased using public funds for the justices and clerks from 2009 through 2015.

The West Virginia Freedom of Information Act requires a response to this request be made within five business days. If access to the records I am requesting will take longer than this amount of time, please contact me with information about when I might expect copies or the ability to inspect the requested records.

If you deny any or all of this request, please cite each specific exemption you feel justifies the refusal to release the information and notify me of the appeal procedures available to me under the law.
