ADMINISTRATIVE CONFERENCE

APRIL 5, 2017

1. PUBLIC ACCESS TO ADMINISTRATIVE CONFERENCE MINUTES

The Court discussed the matter.

2. FATALITY REVIEW PROCESS

Justice Workman prepared an Order and presented it to the Court for review. This matter will be placed on the next Administrative Conference for final action.

3. <u>APPLICATION OF JUDGE CHARLES E. PARSONS TO BE A SENIOR STATUS</u> JUDGE

By a vote of 5 - 0, the Court approved the appointment of Judge Charles E. Parsons to be a Senior Status Judge as of April 5, 2017.

4. IT REQUESTS

By a vote of 5 - 0, the Court approved:

- 4.1 The maintenance/support renewal for the SolarWinds Device Tracker software at a cost of \$3,856.00 to cover the period of 5/24/17 through 5/24/18.
- 4.2 To renew the Symantec Antivirus maintenance/support used on all servers and computers within the Court network system at a cost of \$32,978.00 to cover the maintenance/support for a twelve-month period from 4/21/17 to the end date of 4/21/18.
- 4.3 The Veritas System Recovery support renewal for \$3,540.00 to cover support from 4/21/17 to 4/20/18.

6. JUDICIAL INVESTIGATION COMMISSION SALARY REQUESTS

By a vote of 5-0, the Court tabled the request from Circuit Judge Ronald Wilson, Chairperson on the Judicial Investigation Commission, on behalf of the Commission members, for a salary increase for Teresa Tarr counsel, Brian Lanham assistant counsel and Pam Schafer, Executive Assistant, until there is a review of all salaries and benefits.

7. REORGANIZATION OF THE INTENSIVE SUPERVISION OFFICERS (ISO) PROGRAM IN THE PROBATION OFFICE

After reviewing the entire Intensive Supervision Officers for Sexual Offenders, the Court directed Administrative Director Gary Johnson and Director of Probation Services Mike Lacy to submit a proposed reorganization of the Probation Services Division for the Court's consideration.

8. COURT SERVICES REVIEW

The Court postponed a review of the following Court Services items until the next Administrative Conference:

- The DV Registry employees' salary history and payments made to the DV Registry independent contractors.
- 2016 salary increases for Court Services,
- Salary history for Court Services employees.
- Reimbursement for indirect expenditures and grant modification to pay Oracle costs.

9. MISCELLANEOUS

- A. By a vote of 5-0, the Court approved a Court Facebook page with the conditions that no comments be allowed on the page and that it comply with ethics rules pertaining to any photographs posted.
- B. The Court reviewed the budget information, and no action was required.

- C. The Court reviewed the current state of the Court's legislation, and no further action was required.
- D. The EEO Utilization Report was presented for the Court's information, and no action was required.
- E. The Court approved the State Justice Institute Grant Application entitled "West Virginia Technology Technical Assistance" to allow for an evaluation of the entire court system, IT staff, and systems.
- F. If a vacancy occurs for the Drug Court Development and Training Specialist position, Mike Lacy has proposed that the LSCMI position be reassigned to the Drug Court position. The Court directed the Administrative Director to decide this personnel issue with the stipulation that the position is to be grant funded and continued employment in the position shall be dependent on continued grant funding.
- G. For the Court's information Software Computer Group agreed to waive any fees for Court personnel or employees that use Circuit Express. The Court has paid Software Computer Group the following amounts: FY 2015: \$57,599,99; FY 2016: \$64,915.31; and FY 2017: \$30,201.61; for a total amount of \$152.716.91.
- H. The Court reviewed the National Center for State Courts reports on IT, IT personnel, and AO organization and no further action was taken.

ADDITIONAL TOPICS

- By a vote of 5-0, the Court approved the advertising for, and hiring of, a project manager for Court Plus.
- The Court reviewed the National Center for State Courts report that suggested a four-year Chief Justice term. After reviewing the report, Justice Ketchum made a motion to make the Chief Justice position a four-year term to be elected by a majority of the Court in the third week of September in the fourth year of the Term, which was approved by a vote of 4 1, with Justice Davis voting against the matter.
- Justice Ketchum made a motion that Chief Justice Loughry be elected to the first four-year Chief Justice term, the first year of said term which shall include the current year starting January 1, 2017, and shall expire December 31, 2020, which was approved by a vote of 4 1, with Justice Davis voting against the matter.

- Justice Ketchum made an additional motion that the outgoing Chief Justice shall be eligible for re-election which was approved on a 4-1 vote, with Justice Davis voting against the matter.
- The Court reviewed the contract from Casto Technical Services for \$1,721.00 for water leak repair work already completed on the Fourth Floor and \$10,866.00 to repair the remaining pipes that was previously entered into by the Administrative Director.
- At the request of Justice Walker, the Court approved by a 4 1 vote, with Justice Davis voting against, a one-day seminar by Brian A. Garner (resume attached) for law clerks.
- 1. The lecture fee is \$18,500 for up to 30 participants, \$19,500 for 31 40 participants or \$20,500 for up to 50 participants. An invitation will be extended to all of the Justices, the personal clerks of the Justices, lawyers in the Office of Counsel, and the Clerk's Office. The Clerk's Office shall determine the number of participants.
- 3. Travel and other expenses, including the course book will be approximately \$2,500.00 (depending on the number of participants).

Justice Walker stated that the salaries of her staff are approximately \$89,000 less than has been permitted for this calendar year. The savings can be used for the costs of the seminar.

ADDENDUM

After the meeting, the Court was polled and approved on a 5-0 vote the purchases of furniture for the new family court offices and court rooms in Cabell County. A list will be attached to the Administrative Conference Minutes.
