I hope I explain this correctly. West Virginia Code 51-9-10 states that per diem and retirement compensation of a senior status judge shall not exceed the salary of a sitting judge. I do not know what the income limit is for Judge Rowe. Tammy, from our Human Resource Department, told me that Judge Rowe can work approximately 70 days before reaching his limit.

When senior status judges reach that limit, they get paid through contract. They have to keep track of taxes, etc. I am sending an email to judge Rowe to remind him of this limit so that he can watch it closely and let me or Jennifer Singletary know when he needs a contract.

I just wanted to give you a heads up since you will be keeping track of his per diem.
