Jennifer,

Correct, the income cannot exceed the salary of a sitting Circuit Judge.

Annual retirement under Judges is 94,500 so the per diem payments for the calendar year cannot exceed 31,500.

If a Judge should happen to retire under PERS then the limit is 20,000.

As to Judge Marks,...

He deferred his retirement until October 30, 2017 when he will turn 65 and then be eligible for full benefits.

Best guess he could receive approximately 16,000 this calendar year from Judges retirement.
