#### FOREWORD

West Virginia Code § 11-13A-6 provides for an additional tax on coal of which seventy-five percent of the net proceeds are distributed to coal producing counties and the remaining twenty-five percent to all counties and municipalities. Each county and municipality is required to create a coal severance tax fund and submit a budget to the state auditor for review and approval.

West Virginia Code § 11-13A-5a provides for an additional tax on gas and oil of which seventy-five percent of the net proceeds are distributed to the gas and oil producing counties and the remaining twenty-five percent to all counties and municipalities. Money distributed to any county or municipality should be deposited in the county or municipal general fund.

In counties with population in excess of 200,000 at least 75% must be expended within the coal, gas and oil producing areas of the county. Not more than 50% of severance tax may be used for personal services.

This report is a consolidated narrative of all county and municipal levy estimates (budgets). Specific questions regarding budgets for local governments may be directed to the West Virginia State Auditor's Office, Local Government Services Division.

#### Coal Severance Tax Fund (W.Va. Code § 11-13A-6)

Revenues listed under the Coal Severance Tax Fund column includes encumbered and unencumbered balances, estimated coal severance tax receipts for the year, interest earned, refunds and reimbursements to the fund. All expenditures are reported by categories such as, general government, public safety, streets and transportation, health and sanitation, culture and recreation, social services and capital projects.

#### Gas & Oil Severance Tax (W.Va. Code § 11-13A-5a)

Gas and oil severance tax funds are deposited into the general fund. Expenditures are reported by categories such as, general government, public safety, streets and transportation, health and sanitation, culture and recreation, social services and capital projects.

#### **General Fund (W.Va. Code § 11-8-10 and § 11-8-14)**

The general fund, along with the coal severance tax fund, constitutes the entity's general operating budget. This section of the report provides a breakdown of revenues and fund balance. Expenditures are reported under the same categories as previously stated.
