Claimant seeks to recover \$251.42 for damage to her 2006 Pontiac Grand Prix which struck a large hole in the travel portion of the Patrick Street Bridge in Charleston, Kanawha County. The Court found that Respondent was negligent in its maintenance of the bridge on the date in question, and the parties stipulated the facts and damages. An award in the amount of \$251.42 was made.

CC-14-0680 LAMAR MOSLEY

Claimant seeks to recover \$900.00 for damage to his 1995 Cadillac Fleetwood which struck a large hole in the travel portion of MacCorkle Avenue in South Charleston, Kanawha County. The Court found that Respondent was negligent in its maintenance of MacCorkle Avenue on the date in question, and the parties stipulated the facts and damages. An award in the amount of \$900.00 was made.

CC-14-0943 MARK PETTRY

Claimant seeks to recover \$526.78 for damage to his 2010 Ford Taurus which struck a large hole in the travel portion of W.Va. Route 3 near Comfort, Boone County. The Court found that Respondent was negligent in its maintenance of W.Va. Route 3 on the date in question, and the parties stipulated the facts and damages. An award in the amount of the insurance deductible of \$500.00 was made.

CC-12-0278 BARBARA PRICE

Claimant seeks to recover \$15,600.00 for damage to her property in Beckley, Raleigh County. Claimant alleges that during a substantial rainstorm, a large amount of water traveled onto her property and caused the damage. The Court found that Respondent was negligent in its maintenance of the drainage system, and the parties stipulated the facts and damages. An award in the amount of \$15,600.00 was made.

CC-13-0325 RONALD RICHARDSON

Claimant seeks to recover for his personal injuries and damage to his 2005 Dodge Dakota which occurred when the vehicle encountered a large amount of mud on Pisgah Road in Mercer County. Claimant lost control and went into a ditch, eventually striking a stone pillar. The Court found that Respondent was negligent in its maintenance of Pisgah Road on the date in question, and the parties stipulated the facts and damages. An award in the amount of \$28,000.00 was made.

CC-14-1178 THOMAS RISKO

Claimant seeks to recover \$258.29 for damage to his 2003 Chevrolet Impala which struck loose gravel and debris in a construction zone along U.S. Route 119 near Danville, Boone County. Claimant admitted that he was very familiar with the section of roadway under construction, but on the date in question, both lanes were being milled and no warning signs were present. The Court found that Respondent had notice of the condition along U.S. Route 119 on the date in question, and should have warned motorists of the hazard. An award of \$258.29 was made.

An award in the amount of \$42,500.00 was made.

Claimants seek to recover \$1,454.54 for damage to their 2005 Ford Focus which struck a large hole in the travel portion of Campbell Run Road in Wetzel County. The Court found that Respondent was negligent in its maintenance of Campbell Run Road on the date in question, and the parties stipulated the facts and damages. An award in the amount of the insurance deductible of \$1,000.00 was made.

AMOUNT CLAIMED: \$1,454.54 AMOUNT AWARDED: \$1,000.00

CC-08-0503 LONNIE R. WILCOXEN JR.

Claimant seeks to recover for his personal injuries and for damage to his 1999 Yamaha motorcycle after he lost control upon encountering a large amount of mud in the travel portion of Route 60 in Cabell County. Claimant was thrown from the motorcycle. The Court found that Respondent was negligent in its maintenance of Route 60 on the date in question, and the parties stipulated the facts and damages. An award in the amount of \$20,000.00 was made.

CC-13-0230 RONALD S. WILLIAMS and STACIE LYNN WILLIAMS

The Court found that Respondent was negligent in its maintenance of W. Va Route 82 on the date in question, and that Claimants may make a recovery for the damages to their vehicle. There was no guardrail to protect the traveling public in this area known by Respondent to pose danger to the traveling public. The parties stipulated the facts of the claim and the amount of \$300,000.00 which the Court considered fair and reasonable.

CC-13-0444 RICHARD D. COLLINS

Claimant seeks to recover \$6,867.93 in damages to his 2002 Volvo which struck rocks in the roadway on Route 52 near Switchback, McDowell County. The Court found that the Respondent had constructive notice of the risk posed by rock slides in the area, and granted an award of \$6,867.93, representing the total value of the vehicle plus towing charges.

Claimant seeks to recover \$420,000.00 for communications services rendered to Respondent for which no payment was received. Respondent admitted the validity of the claim and that sufficient funds expired in the appropriate fiscal year from which the invoices could have been paid.

CLAIM AGAINST DIVISION OF JUVENILE SERVICES

CC-15-0027 MOUNTAIN STATE JUSTICE INC.

Claimant brought this action to recover monies owed by Respondent which were ordered to be paid by the Circuit Court of Kanawha County for attorney fees and costs incurred during the ongoing law suit of State Ex Rel D. L. And K. P. v. Stephanie Bond, Acting of the Respondent, et. al., which involved the Industrial Home for Boys in Salem, WV. Respondent admitted the validity and the amount of the claim since the Circuit Court reviewed the invoices provided by Claimant and reduced these for the Order. The Court reviewed the claim and made an award pursuant to the Order of the Circuit Court.

CLAIMS AGAINST THE DIVISION OF MOTOR VEHICLES

The Court found that since Claimant was required to use Respondent's system, Respondent was in a better position to catch any errors. An award of \$347.50 was made for the over-assessment.

Respondent admitted the validity of the claim and the amount of \$32,275.00 for which the Court made an award.

Claimant seeks to recover \$9,485.00 for equipment rental services provided to Respondent for which no payment was received. Respondent admitted the validity and amount of the claim, and that sufficient funds expired in the appropriate fiscal year from which the invoice could have been paid.

CLAIM AGAINST THE REAL ESTATE COMMISSION

CC-14-0604 DEPARTMENT OF ADMINISTRATION/OFFICE OF TECHNOLOGY

Claimant seeks to recover \$3,549.53 for technical consultation services provided to Respondent for which no payment was received. Respondent admitted the validity and amount of the claim, and that sufficient funds expired in the appropriate fiscal year from which the invoice could have been paid.

CLAIM AGAINST THE REGIONAL JAIL AUTHORITY

Claimant seeks to recover \$11,655.05 in attorney fees incurred when an ethics complaint was filed against him while serving as Administrative Law Judge for the Public Employees Grievance Board. He was found to be free of any ethics violations by the WV Ethics Commission. Respondent admitted the validity and amount of the claim.

CLAIM AGAINST WEST VIRGINIA STATE POLICE

CC-14-1486 SARAH M. WEIDIG

Claimant's vehicle was damaged when she drove too close to a member of the Respondent in a parking lot at the State Fair in Lewisburg who reacted to the situation. Respondent admitted the validity and the amount of the claim. The Court accepted the admission of the Respondent and made an award to the Claimant.
