Barbara will request a power poll from the FCLB regarding mandatory reporting and what states mandate mandatory reporting and requirements as follows:

Each state has laws requiring certain people to report concerns of child abuse and neglect. While some states require all people to report their concerns, many States identify specific professionals as mandated reporters; these often include social workers, medical and mental health professionals, teachers, and child care providers.

- Each board member shall have been a resident of West Virginia engaged in active practice for a period of at least five years preceding his or her appointment.
- ➤ It is the Board's position that the intent of the legislature was to indicate that the doctor should be a resident of West Virginia and in active practice for at least five years.
- ➤ Doctors who are in active practice and are appointed to the board may remain on the board if they retire after being appointed.
- > Doctors who have retired from active practice and are no longer involved in the day-to-day issues of practicing should not be considered for appointment.
- > The Board will provide an annual review of administrative salaries and benefits.
