Doug Mongold



State Fire Marshal's Projects and Programs



West Virginia Fire Death Reduction and Public Education

The public education section continues to develop and deliver public service announcements that are delivered around the state. We continue to educate the public about many aspects of fire safety through various programs such as providing and supporting smoke alarm installations. We are also working on a statewide Community Risk Reduction program which is an integrated approach to balance emergency response capabilities with proactive measures that work together to reduce risk and loss in communities.

Review and Recommendations on Volunteer Fire Service Concerns

In accordance with §29-3-5d of the Code of West Virginia, 1931, as amended, relating to authorizing the State Fire Commission to establish and administrate pilot project programs which implement changes to standards imposed on volunteer firefighting that address problems facing volunteer fire departments in the state, including issues related to training, recruitment and retention the following pilot programs have been established:

- 1. Modular- Fire Fighter Training Pilot Program, which enables volunteer firefighters to take the 120- hour course in 4 modules during a year in place of back to back weekends and enables a firefighter to perform specific job duties after each module in place of not being able to participate in firefighter activities until after completion of the whole 120- hour course.
- 2. Modular Fire Apparatus Driver/Operator Training Pilot Program, which enables volunteer firefighters to become fire apparatus drivers / operators without taking the 120- hour firefighter I course. It is broken into modules which enable a firefighter to perform specific job duties after each module in place of not being able to participate in fire apparatus driver / operator activities until after completion of the whole course.

Senate Bill 625 Report of West Virginia Volunteer Fire Departments and County Governments

In 2018, the West Virginia Legislature directed the West Virginia State Fire Marshal's Office to produce a report based on Senate Bill 625. This report requires an assessment of many facets of the fire service in the State of West Virginia. Several of the aspects of the study will include state oversight of fire services, assessment of all funding, cost of workers compensation coverage for volunteer fire departments and financial accountability.

A survey has been sent to each of the 428 Volunteer Fire Departments in the State of West Virginia and to all County Commissioners in each of the fifty-five counties. To date, we have achieved approximately 25% participation rate, with the larger numbers being returned from the Volunteer Fire Departments. The Fire Marshal has requested that all surveys be returned by October 12, 2018, to complete the report by November 30, 2018.

The information will be utilized by the Fire Marshal's Office to assess more efficient ways to assist volunteer fire departments throughout West Virginia.

Technology and Efficiency

The State Fire Marshal along with staff is studying ways to implement greater information technology (IT) enhancement within the agency for improved efficiency when it comes to every division's specific responsibilities for streamlining job performance, record keeping, invoicing and their accounts receivable system.



The Administration Division is responsible for procurement, accounting, personnel, payroll, cash management, fringe benefits, personnel records management, FOIA requests, Fire Commission meetings, development of the annual report, website management, and fixed assets.



Procurement

The administrative personnel are responsible for the procurement of all goods and services integral to the day-to-day operations of the West Virginia State Fire Commission. In doing so, every effort is extended to ensure that equipment, supplies and services obtained are of the highest quality available. These items are obtained either by statewide contracts, internal resources, or by means of competitive bids solicited from reputable vendors who are registered to do business with the State of West Virginia. Last year the administrative division procured twenty-eight digital cameras for the inspections division, fifteen digital cameras for the investigations division, replaced eighteen desktop and thirteen laptop computers that were over five years old, replaced 25 expired sets of body armor, replaced the network server which had reached capacity, and replaced 22 VHF portable radios that were outdated.

Accounting

Personnel is also responsible for all revenue and expenditure transactions which includes payroll, travel, vendor payments, cash deposits and refunds, fringe benefits plan maintenance, and preparation of and expenditure monitoring of the annual operating budget.





Personnel

Throughout the year personnel activities included participation in the statewide WV Oasis Enterprise Resource Planning (ERP) initiative. Daily activities for the office include the completion of all personnel transactions for agency new hires, transfers, separations, reallocations, leave of absences, and promotions. Administration is also responsible for job postings, managing employee leave, and overseeing worker's compensation claims. This division also strives to ensure that the agency is following all state and federal employment regulations.



Freedom of Information Act (FOIA) Requests

The administrative personnel also receive, track, and monitor all agency Freedom of Information Act (FOIA) requests. The Administration Division received two hundred fifty-one (251) FOIA requests last year. Examples of common information requested include Investigation Reports, Inspection Reports and Incident reports from fire departments. Once a request is received, it is distributed to the appropriate internal and external employees for further processing. The Administrative personnel are responsible for invoicing and mailing responsive documents.



Training

Personnel must stay up-to-date on all agency, state, and federal policies. To do so the administrative staff attend many hours of training each year, including the State Treasurer's Conference, the State Purchasing Conference, P-Card Training, State Agency Worker's Compensation Conference, and Division of Personnel Training. Also, administration conducts training for employees on such things as Payroll, Leave, and purchasing procedures and assists them as needed on administrative matters.



Fire Services Division



The Fire Services Division consists of three different sections, Licensing and Regulatory, Public Education and Fire Department Services. All three play an important role in the operation of the Fire Marshal's Office.

Objective

The Regulatory and Licensing Section aims to provide a better and safer standard of living for the citizens of West Virginia by ensuring only qualified applicants obtain licensure, by validating and referring customer complaints, by checking for compliance with all applicable codes and regulations and by providing citizens with information on State Laws and Regulations.

Introduction

The Regulatory and Licensing Section enforces and interprets laws, rules and regulations and issues licenses relating to the electrical industry, the explosive industry, the fireworks industry, Building Code Officials, Electrical Inspectors, Home Inspectors, and Fire Protection Workers.

As charged in State Code, the licensing and Regulatory Section writes and updates in-house testing for 8 different classifications of Electrician exams as well as Indoor and Outdoor Pyrotechnician exams.














TOTAL INCOME CONSUMER FIREWORKS & SPARKLERS/NOVELTIES (\$197,555)




INCOME FROM MANUFACTURE, WHOLESALE, DISTRIBUTION & IMPORTER APPLICATIONS (\$12,260)




INCOME FROM PERMANENT APPLICATIONS (\$54,300)

TEMPORARY FIREWORKS APPLICATIONS BY DATE





Fire Department Services Section





The Fire Department Services Section evaluates, consults and assists all 439 certified fire departments in the State of West Virginia and provides information and guidance to new fire departments seeking certification.


During the fiscal year 2017-2018 the section has:


- Completed 72 evaluations of Fire Departments. 42 of the Fire Departments were Re-Certified. Out of a total of 72 Recertifications, 25 received perfect evaluations.
- Worked with the WV Division of Labor and Fire Departments concerning the safe operation of the Junior Firefighter program.
- Issued 586 Emergency Vehicle Permits (195 Apparatus and 391 Private).
- Deactivated 617 Emergency Vehicle permits (130 Apparatus and 487 Private).
- Denied 105 Emergency Vehicle Permit applications due to expired or missing documentation (27 Apparatus and 78 Private).
- Total Active permits now stand at 6288 (3229 Apparatus and 3059 Private).
- Fielded approximately 1200 calls, with the majority of those asking for assistance with the National Fire Incident Reporting System (NFIRS).
- Assisted 6 Fire Departments with grant research using data from NFIRS.
- Processed and evaluated 27 Fire Officer Equivalency Requests (12 Fire Officer 1, 15 Fire Officer 2). A total of 27 (12 Fire Officer 1 and 15 Fire Officer 2) were approved.
- Offered remote tech support for NFIRS related issues using the Bomgar Support Portal. A total of 23 remote tech support sessions were held.
- Processed 170 Freedom of Information Act (FOIA) requests for incident reports which were compiled after researching 1,315 reports.


Due to Legislation allowing for a grace period for submission of fire loss data, Fiscal year 2017-2018 data will not be available until after January 01, 2019. The following data is from Calendar year 2017 (January 01-December 31). A total of 135,531 responses (up 2,063 from last year) were reported by all West Virginia Fire Departments. Attached are charts and graphs depicting a limited breakdown of those responses.



Introduction

Public Education Section is responsible for duties that include, but are not limited to, the development and implementation of public fire and life safety programs and activities statewide, including developing a community risk reduction program, a smoke alarm initiative, a West Virginia Public Education Network, providing fire safety resources as well as public information, and the administration of the Fire-Safe Cigarette certification program for tobacco manufacturers.

We continue building strong partnerships and implement action plans around the state with agencies and organizations who will help us spread fire prevention initiatives and safety.

Through data evaluations we have identified our high-risk geographic areas and population. We are analyzing this information to target the community risk reduction for our best programs and practices. While working with the local fire departments, the goal is to provide resources to assure that all residential structures have working smoke alarms.

Objective

The Public Education Section promotes programs that aim to reduce loss of life and property through education, including but not limited to, the following:

- Fire and injury prevention for all groups, including high-risk (seniors, people with disabilities, young children)
- Train-the-trainer instruction in public fire/life safety education for firefighters and other emergency responders
- Fireworks law and safety for general audiences
- Smoke alarm education and distribution programs
- Fire safety and emergency planning for public facilities
- Public speaking for civic, governmental and advocacy organizations
- Participation in health and public safety fairs/seminars, and career days
- Membership and active participation in health/safety organizations
- Press conferences, TV, radio interviews, media promotion of fire safety and related topics
- Coordinating loan and distribution of educational materials to fire departments, safety groups, schools, businesses and the public

Special Projects

Get Alarmed West Virginia – Get Alarmed West Virginia is an initiative to get smoke alarms installed in homes across the state. Studies show time and time again that smoke alarms save lives. That is why we have partnered with various fire departments and the American Red Cross to continue to make these free installations available to residents across West Virginia. Our campaign kicked off in conjunction with the Governor's Day to Serve and ran through Fire Prevention Week.

While getting WV fire departments and volunteer organizations involved during the campaign was a major goal we accomplished, the Get Alarmed West Virginia initiative is also an ongoing effort, designed and implemented to install smoke alarms year-round.

Total alarms installed: 3,417



Second Annual Fire Safety Poster Contest – A panel of judges including West Virginia First Lady Cathy Justice, Department of Military Affairs and Public Safety Cabinet Secretary Jeff Sandy, and Betty Jo Jordan, executive assistant to the state school superintendent at the W.Va. Department of Education selected the winners of the state's second annual Fire Safety Poster Contest, with the chosen artwork featured in a 2018 Fire Safety wall calendar.

This year's contest attracted entries from 108 students from 33 counties – nearly twice as many students and nearly double the participating counties as the inaugural contest in 2016.

First Lady Justice along with Mrs. Jordan committed to helping get all 55 counties involved next year.

ESCAPe (Emergency Services Conference at Pipestem) 2018

A 6-hour Community Risk Reduction and Fire Prevention course was presented at the ESCAPe conference on February 22nd, 2018.

This program is designed to train and equip students with fire prevention and life safety education tools based on the philosophy of Community Risk Reduction. We identify the injury problem in the state and use appropriate prevention education programs and resources available for the student's own use with high-risk groups in his or her community.



Fire Safety Summit 2018

The 2nd Annual Fire Safety Summit Dinner was hosted on May 10th to join community partners interested in reducing the number of fatal fire deaths and injuries in West Virginia. The WV State Fire Marshal's Office sponsored this dinner and offered this educational evening at no cost to participants during the 2018 WV Public Safety Expo. NFPA's Regional Education Specialist, Meredith Hawes presented "Stocking Your Toolkit" NFPA Resource Guide for the Fire Service, the ABCs of educational messaging, and understanding the basics of fire prevention core messaging. The presentation included strategies for targeting specific audiences, and hands-on exercises to help participants refine their messaging based on community risk reduction, demographics, cultural factors and local needs and circumstances.

A presentation on the Home Fire Campaign was given by Pat Booker, Directive Services Manager from the American Red Cross, West Virginia Region. Discussed was how partners can participate in smoke alarm programs here in our state.

During the dinner we recognized several departments for dedication to their communities. These departments have worked diligently to install hundreds of smoke alarms in homes across WV. We recognized Clarksburg FD, Wheeling FD, Gilmer Co. VFD, Coalton VFD, Brenton VFD for their continued hard work in risk reduction. We also recognized Capt. Cindy Murphy with the Clarksburg FD. Capt. Murphy was awarded the Fire and Life Safety Educator of the Year Award for her continued efforts towards reducing death and injuries to members of her community, specifically children.

"After the Fire" Prevention Bags

Fire prevention bags have been distributed to Assistant State Fire Marshals with resources for fire departments as well as residents. Two bags have been created, one for a resident who lost their home to a fire. The second Fire Prevention bag will be for fire departments to give out in a neighborhood to residents who had deadly fires in their neighborhoods. Literature for the bags was printed by WV Correctional Industries.





Length of Service Award Program Coins

The Length of Service Award Program is an effort to enhance the recruitment and retention of firefighters by providing a recognition award at no cost to volunteer departments from the WV Fire Commission and WV State Fire Marshal's Office. The WV State Fire Marshal's Office designed challenge coins to recognize 5, 10, 15 and 20+ years of fire service to thank those who volunteer in the various communities of West Virginia.

In 2018, 270 total departments participated in the program. A total of 4,473 coins were given out.

Fire Safety Inspection & Plans Review Division

Deputy State Fire Marshal Clarence J. Leake



Introduction

The Fire Safety Inspection/Plans Review Division staff consists of one (1) Field Deputy Fire Marshal, three (3) Field Supervisors, seventeen (19) Assistant Fire Marshals, three (3) Fire Safety Plans Reviewers, one (1) Divisional Secretary and two (2) Office Assistants. The Assistant Fire Marshals are assigned to a designated geographical territory ranging from two (2) to six (6) counties. Four (4) Divisional personnel also assist with the review of plans when necessary in addition to their inspection duties. During this past year the division has been going through a transitional period with the addition of three (3) newly hired divisional members since July 1, 2016. All Assistant Fire Marshals serve as liaison for all Fire Marshal services with the local fire departments and the public.

The division's duties and responsibilities include:

- Inspection of all types of occupancies except one- and two-family dwellings.
- Issue citations for fire code violations.
- Assists the Licensing & Regulatory Division in the enforcement of the licensing programs, electrician, fire protection worker, fireworks, etc.
- Enforcement of fireworks regulations; monitoring of display sites, investigation of complaints, seizure of illegal fireworks.

- Enforcement of blasting regulations and inspection of explosives magazines and blasting complaints.
- Enforcement of forest fire burning laws
- Regulation of aboveground flammable liquid storage tanks.
- Conduct fire safety training educational seminars and public fire education.
- Aiding the Fire/Arson & Explosives Division and other law enforcement agencies.
- Assist federal government in the implementation of the Federal Hotel/Motel Fire Safety Act.
- Response to disasters
- Administers licensing tests
- Administers the Certified Fire Inspector Program for NFPA
- Assist with conducting fire department evaluations/follow-ups
- Conduct fire investigations in buildings that are normally inspected by this office.

Fire Safety Inspections

This fiscal year, five thousand two hundred sixty-three (5,263) fire safety inspections, consultations, and complaints were conducted by the division. Included in this year's report are the number of complaint and system inspections in individual charts by occupancy. Also included is a chart for the past five years of inspections by occupancy. Note that educational occupancies continue to dominate the largest number of inspections. Also included in this year's report are the number of licensing checks that were conducted. Three thousand one hundred fifty-one checks were conducted and are broken down by the type of license that is required for each craft.

In addition to fire safety inspections, a significant number of man-hours were expended conducting fire safety training and educational programs, administering licensing tests, assisting the fire investigation division and department training. Additional educational programs include: in-service training to county school maintenance and educational staffs, presentations to the West Virginia Landlords Association, Department of Health and Human Services social workers and sanitarians, West Virginia Advocate, Day Care providers and Residential Board & Care providers, Building Code officials and the West Virginia Hospital Engineers Association.

Professional development of our divisional staff continues to be a high priority. Our focus on technology will continue to simplify our business processes, making our services more accessible to our customers. Our divisional personnel are constantly striving to improve their skills and knowledge by attending advanced educational programs. This fiscal year a total of three thousand two hundred eleven (3,211) hours were spent on training.

Two of our most significant projects that continue during this past fiscal year are the Proctor and Gamble complex located in the Eastern Panhandle, shown here, and West Virginia University Hospital South East Tower Addition in Morgantown.







Numerous citations were issued this past fiscal year for various fire code violations, ranging from locked exits, illegal storage of fireworks to improper licensing and illegal/improper explosives/blasting. Most citations were written to inmates housed in the various regional jails for tampering with sprinkler heads.


One special project that this division was involved in was the National Boy Scout Jamboree located in Glen Jean. This involved scouts from across the United States and several foreign countries. Divisional personnel expended over three hundred ninety-seven hours (397.50 hours) assisting with this project which included interaction with the scouts with fire safety and assisting the fire marshals associated with the Boy Scouts.





FIRE SAFETY INSPECTIONS BY OCCUPANCY FY 2018






Plans Review Section

The Plans Review Section dedicates a significant amount of time and research to telephone calls and walk-in consultations regarding code interpretations. These direct contacts assist designers and owners with proper code requirements during the early development of the project under consideration. These contacts are not a formal review of plans; however, this procedure has proven to eliminate costly and time-consuming changes during the design and construction phase of the project. In addition, this section assists the public and business owners in answering general fire code questions thru telephone calls and various types of other correspondence.

This section accomplishes a formal review of the plans when construction documents are submitted. This is an in-depth review of all architectural and mechanical plans for code compliance. Specialized systems such as fire alarms, automatic sprinkler systems, hood suppression and smoke management systems are reviewed at the time of submittal of the construction documents.

This fiscal year one thousand four hundred eighty-six (1,486) plans were reviewed. Of these plans one hundred fifty-eight (158) were projects that exceeded one million dollars. In the past five years we have reviewed and provided construction inspections for occupancy for over seven billion dollars of construction. To become more efficient during the review, construction and final inspection for occupancy stages, on large projects both the reviewer and area fire marshal will conduct both the review process and inspection stages until the building is occupied.









Introduction

The Investigation Division's current authorized staffing level is one (1) Field Deputy State Fire Marshal, ten (10) Assistant State Fire Marshals, and one (1) Secretary, when fully staffed.

Each Fire Marshal has a designated geographical territory ranging in size from four (4) to eight (8) counties. The Fire Marshal's primary duties encompass all aspects of fire/arson identification and enforcement including determining fire origin and cause, fire death investigations, executing state or federal search/arrest warrants and subsequently providing expert testimony in criminal and civil trials. In addition, each Fire Marshal is responsible for explosives related investigation/enforcement in their respective areas.

Many non-arson related violations are identified during the course of an arson investigation, and are generally referred to other federal, state or local law enforcement agencies for investigation/prosecution.





Investigation Cases Worked

There were seven hundred, twenty (720) incidents called in to the Arson Hotline requesting an investigation in the fiscal year 2018.

Out of the seven hundred twenty (720) cases worked by State Fire Marshal investigators, one hundred fifty-three (153) of those were determined to be Incendiary, one hundred, ten (110) were classified as accidental, and four hundred, fifty-seven (457) were of Undetermined cause.

Incidents are called into the state Arson Hotline (1-800-233-3473, FIRE) and are, from there, sent to the Deputy State Fire Marshal for Investigations Division as well as regional Supervisors. Cases are assigned based on geographical area and by the investigator's case load.


The Investigation Division was tasked with investigating the largest commercial structure fire in the history of the Fire Marshal's Office. The Fire Marshal's Office was requested due to the large dollar loss that resulted. Several fire departments were called to the IEI Warehouse at 3801 Camden Avenue in Parkersburg, Wood County, on October 21, 2017 just after midnight. Fire crews arrived at the scene to find heavy fire conditions on the left end of the structure.

Six Investigators, along with the Special Operations Response truck and trailer, responded to the scene. Several man hours were put into the investigation. The damage to the structure made it impossible to determine the cause of the fire by the fire scene alone. Several interviews have taken place during the investigation. As of the date of this report, the cause of the fire remains undetermined. Investigators will continue to look at other options and will follow any leads, should they be provided, to close out the investigation.

Arrests



During the 2018 Fiscal Year, the Investigation Division handled one hundred, fifty-three (153) incidents classified as Incendiary. As a result, seventy-five individuals were arrested for arson and related charges. This is a fifty per cent (50%) arrest rate for West Virginia State Fire Marshal investigators

Each year, investigators hone their skills through continuing education and training in law enforcement, arson investigation and the use of firearms in order prevent arson in the state of West Virginia.




Fire Fatalities

There were fifty-eight (58) fatalities during the year, the result of fifty-four fires. Three (3) of these resulted in multiple fatalities. Out of the fifty-four (54), twenty-five (25) were classified as undetermined, nineteen (19) as accidental, and eight (8) as incendiary.

Although fatalities are down from the 2017 fiscal year numbers, they are still well above the national average. Through public education and programs geared toward putting working smoke detectors in West Virginia homes, the WVSFMO is working toward lowering those numbers even more.
