A quorum of the Board being present, the meeting was called to order at 1:00 p.m. by Ira Handley, President. Members in attendance were Robert Fields, Connie Grisell, John Taylor, Keith Kimble, and Bill Davis. Present by telephone conference was Sarah Lobban. Non members present were Regina Foster, Executive Director, and Mark Weiler, Assistant Attorney General.

On motion of Connie Grisell, seconded by Keith Kimble, the minutes for June 14, 2016 were approved unanimously. It was noted that the Special Meeting scheduled for July 12, 2016 was canceled.

On motion of Bill Davis, seconded by Sarah Lobban, the Board unanimously approved the Pcard expenses for May 2016 through September 2016.

On motion of John Taylor, seconded by Keith Kimble, the Financial Reports for June 2016 through September 19, 2016 were unanimously approved.

On motion of Connie Grisell, seconded by Keith Kimble, payment for the dues to The International Conference was unanimously approved.

On motion of Keith Kimble, seconded by John Taylor, the Board voted unanimously to once again split the state into north/south regions and hire Mike Talbott as the second inspector. The salary allotted for inspector will be split evenly resulting in no additional budget increase.

The discussion of fees for surrounding states was discussed and it appears that West Virginia fees are in line with those states and therefore no action is needed at this time.

Mr. Handley welcomed the new members to the Board. The first item on the Agenda was the election of the Board's President and Secretary.

John Taylor nominated Ira Handley to continue as President, seconded by Bill Davis. There being no other nominations, the members voted unanimously to continue Mr. Handley as President

Bill Davis then nominated John Taylor for Secretary. The motion was seconded by Sally Attilli and no other nominations being made, the Board voted unanimously to elect John Taylor as the Secretary.

Harding Settlement Negotiations

This was a Special meeting called for the purpose of conducting settlement negotiations in the Harding matter and was conducted via telephone. Members present by telephone were Ira Handley, John Taylor, Sally Attilli, Ron McVey, Bill Davis, Craig Rotruck and David Deal. Non members present in the Board Office were Regina Anderson, Executive Director, Connie Sloan and Mark Weiler, Assistant Attorney General.

Mr. Handley brought the meeting to order and turned it over to Mark Weiler to explain the proposal from Mr. Harding's attorney. Mr. Weiler stated that before going into Executive Session to consider the proposal he wanted to make sure that the members had no conflict of interest in the matters to be discussed. He then asked David Deal if he did business with Tri-State Mortuary Service and Mr. Deal responded "yes". When asked why, Mr. Deal responded "because he's cheaper than the others." Mr. Weiler asked him whose name was on those papers and he said Chad Harding. Mr. Weiler said "then you don't think you have a conflict because you use his services?" Mr. Deal responded, "No I do not, I don't talk with him and I hardly ever see him, I deal with his drivers. We aren't buddies or anything, we don't go to dinner or socialize and I don't know why you are picking on me."

Mr. Weiler then asked if anyone else might have a conflict, like attending church or something. There was no response. Mr. Weiler advised the Board that Mr. Harding and his attorney were in another location in the office in order to facilitate the settlement negotiations.

John Taylor moved, seconded by Bill Davis, to go into Executive Session. John Taylor, Craig Rotruck, Bill Davis, Ron McVey, Sally Attilli and David Deal voted in favor of the motion. There were no opposing votes.

The motion to return to public session was made by Sally Attilli, seconded by Bill Davis and those voting in the affirmative were John Taylor, Ron McVey, Craig Rotruck, David Deal, Bill Davis and Sally Attilli. There were no opposing votes.

Craig Rotruck, seconded by John Taylor, moved that the Board attorney offer a counter offer to Chad Harding's attorney within the parameters discussed in Executive Session. Those voting in favor of the motion were John Taylor, Ron McVey, Craig Rotruck, David Deal, Bill Davis and Sally Attilli. There were no opposing votes.

The offer as discussed in Executive Session was presented by Mr. Weiler to Mr. Harding's attorney and they responded with a counter offer. David Deal moved, seconded by Sally Attilli to go into Executive Session to discuss the counter offer. Those voting in the affirmative John Taylor, Ron McVey, Craig Rotruck, David Deal, Bill Davis and Sally Attilli. There were no opposing votes. After some discussion, Ron McVey moved, seconded Sally Attilli, to return to public session.

David Deal moved, seconded by Craig Rotruck, that the Board submit a counter offer to Mr. Harding's attorney within the terms and conditions discussed in Executive Session. Voting in the affirmative were Craig Rotruck, Ron McVey, Sally Attilli, and David Deal. Those opposed were John Taylor and Bill Davis. The motion carried on a 4-2 vote.

Mr. Weiler left the room to meet with Mr. Harding's attorney to go over the offer by the Board. Mr. Weiler informed the Board that after she had conferred with her client, they had a counter offer. Ron McVey moved, seconded by Sally Attilli that the Board return to Executive Session to discuss the offer. Those voting in the affirmative were John Taylor, Ron McVey, Craig Rotruck, Bill Davis and Sally Attilli. There were no opposing votes.

After discussing the latest proposal, Bill Davis moved, seconded by Ron McVey to return to public session. Those voting in the affirmative were John Taylor, Ron McVey, Craig Rotruck, Bill Davis and Sally Attilli. There were no opposing votes.
