In addition to the statutorily mandated fiscal and licensure reporting requirements, additional data is included to provide a better overview of the activities of OEMS. ### **Director's Message**

On behalf of the dedicated team at OEMS, I am proud to present the 2024 annual report. This past year has been a remarkable period for EMS in West Virginia, marked by significant milestones and the resilience of our workforce in the face of evolving challenges.

In 2024, West Virginia EMS agencies responded to an extraordinary **1,039,764 emergency calls**, which equates to one response every **30.3 seconds**. This impressive volume underscores the critical role our EMS providers play in safeguarding the health and well-being of our communities.


Emergency Medical Services education was expanded through a groundbreaking initiative offering free tuition for emergency medical technician (EMT) training to all state residents. This program has already welcomed more than 1,000 candidates, bolstering the EMS workforce and ensuring long-term sustainability. Furthermore, advanced simulation training vehicles were deployed across the state, providing cutting-edge recertification and training opportunities to EMTs, paramedics, and flight nurses in even the most remote regions. This year also saw significant technological advancements. Telemedicine has been successfully

integrated into pre-hospital care, allowing EMS providers to consult with specialists in real time, resulting in improved patient outcomes, particularly in rural areas. Additionally, the launch of a statewide data platform has enhanced system efficiency by enabling agencies to monitor performance metrics, optimize response times, and deliver superior clinical care.

As we move forward, our focus remains on innovation, collaboration, and ensuring that every West Virginian receives timely, expert emergency medical services, regardless of location or circumstance.



Ambulance service is provided to each of the 55 counties in West Virginia without regard to the county's individual economic standing or population.




The chart below is a breakdown of licensed ambulance providers by primary service type, and shows the statewide distribution of EMS response for 2024.



West Virginia ambulance services also provide much-needed patient care and transport services to surrounding areas. Transports to contiguous states accounted for more than 28,000 responses in 2024. 45.4% or 12,484 emergency responses ended transporting the patient out of state.




## Number of 911 EMS Responses by Month

The following chart shows the breakdown of initial provider certifications by certification level for the last year. Note that the red bars indicate a non-patient care certification.



## Vehicles




## **Disciplinary Actions**


