West Virginia Law Enforcement Training

§30-29-3, sub-part (a) (15) of the West Virginia Code stipulates that the Law Enforcement Professional Standards (LEPS) Subcommittee will:

"Submit, on or before the thirtieth day of September of each year, to the governor, and upon request to individual members of the Legislature, a report on its activities during the previous year and an accounting of funds paid into and disbursed from the special revenue account establish[ed] pursuant to section four of this article."

In furtherance of this requirement, the Law Enforcement Professional Standards (LEPS) Program of the West Virginia Division of Justice and Community Services (DJCS) is submitting the following information concerning the **3,600** plus individuals who are working as sworn law enforcement officers within the State of West Virginia as certified by the Law Enforcement Professional Standards (LEPS) Subcommittee of the Governor's Committee on Crime, Delinquency and Correction (GCCDC).

During the 2018 Training Year reporting period of July 1, 2017 through June 30, 2018 the LEPS Subcommittee met eleven (11) times as per its regular annual schedule for monthly meetings, with no meeting held during the month of November. Each meeting was conducted as prescribed by the West Virginia Secretary of State Office guidelines concerning public meetings.

Sheriff Steve Stephens, the Public-at-Large member on the LEPS Subcommittee, served as the Chair for the LEPS Subcommittee during this period. The eleven positions, as set by statute, which make up the LEPS Subcommittee were filled over the course of the year as vacancies occurred because of changes in leadership at the member organizations through the action of Department of Military Affairs (DMAPS) Secretary Jeff Sandy, CAMS, CFE, except for the position occupied by the West Virginia Human Rights Commission. That position became vacant during the spring of 2017 with the retirement of their representative who had been a long-time member. Retired Captain Sadler is working with that new Director to have the vacancy filled. The roster of the members comprising the LEPS Subcommittee is provided under Attachment 2 of this report.

A summary of the actions of the LEPS Subcommittee during this reporting period is provided on the following pages. Items carried out on behalf of, or by, the LEPS Subcommittee members or program staff:

- 25. Six (6) grant awards were recommended for approval to the Governor's Office and were subsequently awarded totaling **\$913,800** from the LEPS Fund. The 175th and 176th Basic Classes and the Civilian Support Staff awards, D. F. following, could only be awarded as the result of supplemental funding that was awarded to the Department of Military Affairs and Public Safety (DMAPS) during the 2018 Special Session of the Legislature. The inability of the LEPS Fund to fully support the cost of the entry level training remains a key issue as to the program's overall ability to meet it statutory requirements. The following awards were recommended in support of the law enforcement training effort.
 - A. **\$135,000** for the operation of the 172nd Basic Class.
 - B. **\$135,000** for the operation of the 173rd Basis Class.
 - C. **\$133,800** for the operation of the 174th Basic Class
 - D. \$134,000 for the operation of the 175th Basic Class
 - E. **\$134,000** for the operation of the 176th Basic Class
 - F. **\$242,000** for the salaries of five (5) civilian support staff personnel at the West Virginia State Police Academy.
- 26. Identified officers not in compliance as to required in-service completion for the 2017 Training Year, July 1, 2016 to June 30, 2017. These officers were brought before the Subcommittee during the October 2017 meeting. Requirements were set for them to complete to bring their certification current. Followed up to verify that required training and/or firearms qualifications were completed. One officer's certification was suspended because of failure to complete required training by designated date.
- 27. Worked with the staff of the West Virginia State Police's Professional Development Center (PDC) for the approval and dissemination of information concerning the Fall 2017 and calendar year 2018 in-service class schedule.
- 28. Continued to address funding levels within the LEPS Fund by seeking to identify new funding sources. The fund levels continue to require that only requests for funding relating to the entry level training programs receive priority for approval. A request to have the \$2 court cost fee, in place since the creation of the then Law Enforcement Training (LET) Program in 1982, increased to \$10 was introduced as legislation during the 2018 legislative session. Was approved by the Senate but did not advance out of House Judiciary for consideration.

- 29. As generally noted previously in point #25 supplemental funding of over \$500,000 was approved during the 2018 Special Session of the Legislature to allow for the continued presentation of entry level training in the state. Without this one-time appropriation entry level classes would have had to have been stopped beginning July 2018 to at least early 2019. This funding will allow for such classes to continue through the spring of 2019, but if no further action is taken to address the LEPS Fund shortfall it is projected that classes will have to be stopped by early to mid-summer 2019.
- 30. Subcommittee members, representing the Subcommittee and their associations and organizations, worked with members of the West Virginia Legislature during their 2018 session concerning revisions to CSR 149-2 et seq. that had been developed by the Subcommittee members during their spring 2017 regularly scheduled meetings. The approved changes took effect in July 2018. Prior to effective date staff distributed information on changes to the law enforcement community within the state.
- 31. Retired Captain Sadler, LEPS Program Manager, worked with the West Virginia Coalition Against Domestic Violence (WVCADV) Co-Chair concerning the development, introduction and passage during the 2018 Legislative Session of needed revisions and updates to CSR 149-3 et seq., Domestic Violence Protocol. Prior to effective date staff distributed information on changes to the law enforcement community within the state.
- 32. The LEPS Program staff appeared during the quarterly meetings of the Governor's Committee on Crime, Delinquency and Correction (GCCDC) and reported to the members the actions of the LEPS Subcommittee during the period preceding the meetings. Sheriff Stephens, LEPS Subcommittee Chair, is a member of the GCCDC and attended these meetings as well.
- 33. Worked with associations, organizations, training entities and individuals to ensure that West Virginia law enforcement officers received instruction and training in subject areas to allow them to continue to perform the job skills/tasks of a law enforcement officer in this state.
- 34. Worked with the staff of the West Virginia State Police Academy concerning program and schedule changes for the entry level training program.
- 35. Continued the implementation of the Law Enforcement Professional Standards Information System (LEPSIS) database through awareness and education programs to officers and administrators within the state.
- 36. Responded to eighteen (18) Freedom of Information Act (FOIA) requests and one (1) subpoenas for officer training records by providing the requested information.
- 37. Worked with the West Virginia Wives Behind the Badge Auxiliary program director on the scheduling and the holding of a statewide police memorial observance at the Culture Center located on the Capitol grounds during May 2018.

38. The following is a summary of actions carried out/decided by the LEPS Subcommittee members that currently are on appeal within the court system or that a notice of intent to take legal action has been made:

A. An appeal of a decision made to revoke the certification of an officer's certification as a law enforcement officer is being reviewed by a Circuit Judge in Ohio County. The involved former officer filed this appeal after Mr. Staton, acting in his capacity as Executive Director of the GCCDC, upheld the revocation action taken by the LEPS Subcommittee members.

B. An appeal of the decision made by the LEPS Subcommittee, and upheld by Mr. Staton to deny the operation of a regional entry level training program at Fairmont State University (FSU) was reversed by Judge Wilson, Marion County Circuit Court. His decision was to allow the operation of such a regional entry level training program. DJCS/GCCDC/LEPS Program appealed the matter to the West Virginia Supreme Court. The appeal is under consideration. A friend of the court brief was filed in support of this appeal by the West Virginia Deputy Sheriffs Association and the West Virginia Fraternal Order of Police.

C. A former officer who had been denied a request for accommodations to attend the entry level training program required to gain certification as a West Virginia law enforcement officer filed a Notice of Intent with DJCS concerning the actions taken in denying him that request. Required notice was made to BRIM and LEPS Program representatives have been working with the counsel assigned to review the details involved in this matter.
