2008 - 2009

While the overview may appear to be the same as 2007-2008, changes and additions have been made where necessary.

As this is the audit year for WVBOLD, the Board would like to request a consideration to:

- INCREASE APPLICATION FEE TO \$100.00 to move to a staffed administrative system.
- INCREASE RENEWAL FEE TO \$150.00 FOR EVERY TWO YEARS to move to a staffed administrative system.
- CHARGE \$10.00 FOR LICENSURE VERIFICATION to move to a staffed administrative system.
- CHANGE CURRENT LAW (inadvertently states date for renewal of a Provisional License as one year from the original date) TO READ AS THE ACTIVE LICENSE.
- LICENSE DIETETIC INTERNS TO MIRROR THE PHARMACY BOARD'S
 RECENT ADDITIONS. This allows graduating students to go
 directly into the profession and change to an ACTIVE status
 upon completion of the CDR examination

WVBOLD is cognizant of the fact that some of the above requires approval of the WV Legislature.

IT IS THE INTENT OF THE WVBOLD TO CONTRACT ADMINISTRATIVE SERVICES FROM ANOTHER WV HEALTHCARE BOARD IN 2010

OVERVIEW OF ACTIVITIES AND RESPONSIBILITIES WEST VIRGINIA BOARD OF LICENSED DIETITIANS 2008 – 2009

The West Virginia Legislature mandated the requirement to hold an active/valid license to practice dietetics in the State of West Virginia – West Virginia Code – Chapter 30 - Professions and Occupations – Article 35 – Board of Dietitians – commencing on July 1, 1997. The law, effective 90 days after March 9, 1996, mandated the formation of a Board as the WVBOLD. The WVBOLD is a regulatory and disciplinary body. It is the sole authority for the issuance of licenses to practice dietetics in the State of West Virginia. The purpose of the Board is to protect the public interest through its licensure and professional discipline of dietitians and to provide a professional environment that encourages the delivery of quality nutritional information and medical nutrition therapy in the State of West Virginia. The Board consists of five (5) members who are appointed by the Governor, by and with the consent of the Senate. Four of the members are experienced registered and licensed dietitians and one member is a layperson.

The WVBOLD maintains a code of ethics; establishes professional continuing education requirements and standards; establishes licensure and renewal requirements of duly qualified applicants; establishes procedures and guidelines for the suspension or revocation of a license; adopts procedural and interpretive rules in accordance with the provision of Chapter 29 of the code; adopts an official seal; renews licenses; issues interim provisional permits to duly qualified applicants; imposes and collects fees for the issuance and renewal of permits or licenses; suspends, revokes and reinstates license; conducts hearings on licensing issues and any other matter properly within the jurisdiction of the Board; utilizes available mechanisms/ methods to protect the health and well-being of the public in nutrition related issues; maintains a record of proceedings of the Board and submits a biennial report to the Governor describing activities of the Board.

Title 31 – Legislative Rule – Series 5 – Continuing Professional Education Requirements

Licensed and registered dietitians are proficient in the science of nutrition. They are required to hold degrees in nutrition, dietetics, public health or related field such as biochemistry, medicine or a nutrition specialty in family and consumer sciences issued by accredited colleges and universities. After or during their education, they must complete a supervised internship and pass a comprehensive examination administered by the Commission on Dietetic Registration. WVBOLD renews a contract each year with the Commission on Dietetic Registration as the approved standards for nutrition education. Professional education credits are required (20 each two years) throughout a career to maintain licensure (page 3, para. 5).

The need for qualified providers of nutrition advice has become more focused within the past 20 years. As with the specialization of medicine, the science-based nutrition field has necessitated a higher understanding and communication of nutrition prescription and advice to those in need of this service. Physicians rely upon the expertise of dietitians as a critical member of the healthcare team. Dietitians specialize in medical nutrition arenas, as cardiology, oncology, pediatrics, neonatal, renal diseases, eating disorders, weight loss, gastroenterology, inborn errors of metabolism, geriatrics, sports medicine, osteoporosis' conditions, hypertensive issues, diabetes, trauma, enteral and parenteral nutrition and others. An example: Obesity is documented as a leading preceptor for diseases causing higher healthcare cost, as well as trauma to the patient and family members. As the WV Legislature moves to address these issues, dietetics will be in the forefront among the healthcare providers.

The RD status means that the individual possesses the skills and knowledge to translate nutrition science into practical meal planning. The individual can assist with eating disorders; work with healthcare teams to assist patients/clients to change eating plan pre-post surgery; assist in goal setting for athletic performance on various levels; prescribe and counsel patients and families with a myriad of disease entities and to assist physicians and healthcare providers in assessing a patient's needs and prescribing a nutrition therapy to best benefit the patient or client.

While the credential RD is significant it, unlike the credential LD, cannot be significantly regulated in the State of West Virginia. Initials following a name do not necessarily qualify an individual to provide nutrition services. Licensure and registration provide the only assurance the public has to judge that the individual is proficient in the science of nutrition.

Licensure in West Virginia provides the vehicle to file a complaint should anyone have reason to believe the person is not providing accurate nutrition advice or falsely claiming to be a qualified dietitian. The State of West Virginia, with licensure, can regulate the term "licensed dietitian" or "dietitian". States without licensure experience self-proclaimed persons claiming to be experts with little if any actual nutrition training or with only mail-order credentials. When an individual needs trusted, accurate, timely and practical nutrition advice, they should be able to identify the qualified professional.

WVBOLD utilizes the examination by the Commission on Dietetic Registration as one component to examining an applicant's qualifications, prior to issuance of a West Virginia license.

By law, when licensure began in 1997, the examination as a route to licensure was waived (as a one time opportunity) for those who were:

- ♦ (a) Currently registered with CDR as a Registered Dietitian.
- ♦ (b) BS or higher degree, with a major in human nutrition, dietetics or food systems management or equivalent and engages in the practice of dietetics or nutrition three (3) of the previous ten (10) years.
- ♦ (c) Licensed in another state with comparable requirements.

Exemptions include: Those marketing, distributing or providing information about food/ food materials or dietary supplements; healthcare providers - where nutrition was included in the profession's scope of practice; academic institutions; various government agencies - as Veterans' Administration or WIC - who have their own standards.

In 1997, 58 individuals were "Grandfathered", in accordance with waiver (b). At the end of the 2009-2010 renewal period, only nineteen (19) remain licenses and two (2) inactive. Under the reciprocation waiver (c), one Kentucky dietitians was later granted a WV license. Many have retired from their chosen profession, i.e.: County Home Demonstration Agents or WIC Nutritionist. Some have relocated and a couple found they did not require a license in their government-based employment. Two allowed their license to expire and, after some time, applied for renewal. Those were denied, per State law as being ineligible for licensure. WVBOLD handles the "Grandfather" status renewals as a routine renewal, giving due diligence to CEU credits.

All "Grandfathered" licensee folders are maintained in green folders. This is done, not to single out – but, to alert any office staff that once the license has lapsed, it cannot be reactivated without proper credentials (consistent with other state boards). For the same reason, all provisional license information is kept in red files and those revoked, denied or deceased are filed in purple folders.

Licenses are issued throughout the year. Renewal applications must be postmarked June 30th of each year. It has been the practice of the WVBOLD Board Chairman to personally contact those not having complied with renewal in the last week of June or first week of July. Out-of-state dietitians often express surprise and are pleased to have this personal service.

WVBOLD monitors licensure compliance with continuing competence requirements of twenty (20) hours in each designated two year reporting period. A reporting of Continuing Professional Education Credits serves to ascertain the completion of the twenty hours by licensees. The applicant renewing licensure is charged with the responsibility of reporting educational activities (date, event and CEU credits) on the CEU Form accompanying the renewal application. A visual scanning is performed by the Board Chairman and Board Secretary prior to issuance of the renewed license. At the completion of the Renewal Period, a listing of all licensees required to submit the CEU credits in that given two year period is compiles. The list is, then, submitted to a Huntington-based company, with whom the WVBOLD has an agreement. 10% of the list is randomly selected to have a full audit of their CEUs. The audit is conducted by Board Member and Professional Inquiries Liaison – Betty Forbes – Director of Dietetic Education at West Virginia University.

WVBOLD is committed to collaboration with other healthcare related licensing agencies and organizations in West Virginia and nationally. The purpose is to identify needs and to improve public access to and information about education, licensure, practice, discipline and accountability for healthcare professionals.

WVBOLD developed a website and maintains a toll-free public telephone line. The telephone number is published in all telephone blue page directories in West Virginia and promotes the use of the credential "LD" as a means for the public to identify those qualified to deliver nutrition advice and counseling.

The American Dietetic Association and the West Virginia Dietetic Association issues press releases to West Virginia newspapers encouraging them to recognize the term "LD" and the qualified provider of nutrition information.

A complaint form is found on the website. Efforts are ongoing to refine the process for complaint management. While complaints are rare, numerous inquiries are received from healthcare institutions and the public with questions concerning acceptable duties of other nutrition personnel, i.e.: Certified Dietary Managers, Diet Technicians, etc. Inquiries from dietitians assist them in the assignment of duties to the same personnel.

The presence of the WVBOLD has increased public awareness of the services of a qualified dietitian tremendously. By the number of inquiries one can safely say that the public needs are being addressed. Nursing Homes, Personal Care Homes, Exercise Entrepreneurs and hospitals utilize the Board to determine what duties can be performed by their nutrition staff members.

OFFICIERS AND RESPONSIBILITIES OF THE BOARD:

The Board maintains an office at 723 Kanawha Blvd., East – Room 105 – Union Building - Charleston, WV 25301.

In accordance with State law, open meetings are conducted. Board meetings are posted in the State Register. The agenda for each meeting accompanies each posting. Notice of each meeting and the agenda are posted on the office door. Officers are elected annually.

The Board Chairman is elected to preserve order and conduct all proceeding by parliamentary rules and insures conformity thereto by members, appoints all committees and signs required documents. The office is not staffed with an Executive Director or Secretarial Services however, the Board Chairman serves in both capacities on a continuous basis. This involves a presence at least three times a week and as inquiries or requests are received. The telephone rolls over to the Board Chairman's home where all inquiries and request (verification of license, inquiries as to licensure requirements, inquiries from the public who are selecting a qualified dietitian and request of State agencies) are met in a timely manner. Licensed dietitians utilize this service from 7:00 am to 10:00 pm. Emails are monitored daily. During the renewal periods the Board Chairman assumes the responsibility of obtaining the renewal applications from the State Treasurer's Office and is in the office on a daily basis. The 2009 goal is to

provide a listing of licensed dietitians on the website.

The Vice-Chairman also serves as the Board Treasurer. This person acts as Chairman in the absence of the Board Chairman and call special or emergency meeting of the Board by joint action with the Chairman. As Treasurer, this position maintains all financial records to be in compliance with the requirements of the State of West Virginia.

The Board Secretary is to maintain the database, prepare documents - as licenses and rosters, prepare and process meeting minutes and is active in the renewal process.

The Professional Inquiries Liaison fields questions pertaining to Continuing Education Credits, talks with the public concerning the educational route to licensure and audits the 10% chosen annually, at random for the auditing of their CEUs.

The Lay Member is a vital part of the WVBOLD. The person currently in this position is cognizant of the need for licensure of the profession of dietetics. He was formerly a healthcare foodservices representative of one of the largest companies in the United States and remains in the healthcare field. The person represents the citizens of the State of West Virginia in all actions of the Board. He votes on new applicants, discusses the need for changes in procedures and speaks to the public needs.

Board members of the WVBOLD are active participants in meetings and activities across the country on matters of licensing, professional regulation and changing healthcare as it relates to dietetic and nutrition.

Two members of the WVBOLD hold membership in the Association for West Virginia Boards. This enables a healthy exchange of ideas and discussions on key issues facing boards in West Virginia.

Board members attend the Annual Training Seminar for WV State Licensing Boards by the State Auditor's Office. They find this most helpful in the operation of the Board.

The Board Chairman served on the American Dietetic Association's Political Action Board 2002-2005, serving as chairman of ADAPAC 2003-2004. The Board Chairman serves as the Public Policy Coordinator for the West Virginia Dietetic Association. This group is responsible for promoting dietitians as the nutrition experts and advising the WV elected U. S. Congressional officials in such issues and concerns. In this role, the WVBOLD keeps abreast of issues surrounding not only dietetics but, the entire healthcare delivery system.

Four Board members are members of and some attend the annual meeting of the American Dietetic Association (FNCE), West Virginia Dietetic Association, Educational Alliance and serve on other healthcare coalition groups.

The WVBOLD maintains close working relationships, often making decisions that do not require formal Board actions. The Board Chairman and Vice-Chairman are in frequent contact in regards to routine Board business and for various State offices request. The Board Chairman and the Board Secretary meet at the Board Office periodically to conduct all secretarial type duties, such as issuing licenses, licensure verification and processing mail. The Board Chairman has contact with the Professional Inquiries Liaison, cognizant that this individual is best qualified to assist the issues relating to the Continuing Professional Education arena and to advise inquirers who are considering the dietetic profession. The Lay Board member is a very involved individual, with contact 2-3 times weekly.

While it is not the duty or responsibility of the WVBOLD to recommend dietitians to the public, the Board receives numerous inquiries as to how to locate a qualified dietitian for nutrition or medical nutrition therapy. The inquirer is referred, according to the need, as to the nearest medical facility or dietitian(s). The Board continues to give assistance to WV hospitals and nursing homes, PEIA programs and the WV Department of Health and Human Resources. The Board has been contacted by these groups for a listing of licensed dietitians for the creation of a

bid list for licensed dietitians in a designated area. Other institutions have requested and received the same service. It is the intent of the WVBOLD to continue to grow with the professional needs of dietitians as related to the public interest, to attend training as offered by the State of West Virginia and to fully comply with State codes.

All applicants are voted on by ALL Board members prior to issuance of a license. This keeps Board members quite involved in the daily business of the Board. Board members act in a volunteer role for such actions. This eliminates the need for formal Board meeting during certain periods of time. Actions requiring Board votes is, again, voted on at the scheduled Board meeting. Minutes of Board meeting are posted promptly on the website by the Board Secretary.

NOTE: THE 2009 AUDITOR'S SEMINAR REVEALED THAT THE BOARD IS NOT TO CONDUCT BUSINESS VIA THE INTERNET AND VOTE AGAIN AT THE FOLLOWING BOARD MEETING. TO COMPLY WITH THIS NEW INFORMATION, THE WVBOLD WILL ADDRESS THIS ISSUE AT THE JANUARY 12, 2010 BOARD MEETING.

It should be noted that all WVBOLD members, except the Chairman (who is available most days and most times), are engaged in demanding full-time positions – in leadership roles. In addition, the Board does not employ clerical or managerial staff. Most of the work is done, without compensation, as a dedication to the licensing of the profession and ultimately as a service to the citizen of the State of West Virginia.

COMPLAINTS IN 2008-2009:

Dietitians continue to call the Board with questions regarding the Scope of Practice for dietitians, often questions about Wellness Centers and nutrition counseling. Two identified calls were from dietitians with questions concerning the counseling in Wellness Centers in a specific location. The dietitians asked if they could talk with the Centers to determine whether or not there was a violation. In both cases, the dietitians were asked to submit formal complaints. No complaints were received and an informal conversation with both determined that the Centers appreciated being informed as to nutrition counseling practices.

One call was received from a hospital administrator questioning a contract dietitian (with an LLC Dietetic/Food Services company) permitting a Diet Technician to prescribe/calcuate tube feedings. The following day the dietitian for that facility called with the same question. A formal complaint was requested and received. WVBOLD Board Chairman called the contracting dietitian (a former president of WVDA) to apprise her that a letter was being sent for clarification. A reply indicated that competencies for diet technicians had been underway. The contracting dietitians answered formally that no dietetic personnel.— except a licensed dietitian would prescribe or calculate tube feedings.

One pharmacist called to ask about a member of his company to provide nutrition counseling because, he saw so much obesity and his employee had been successful in losing weight. The professional scope of practice as it relates to physicians, nurses and pharmacist was explained, along with the scope of practice for dietitians.

Five calls were received from persons considering dietetics – online education. These calls were referred to Board member – Professional Liaison, Betty Forbes.

For the reasons listed above, the Board believes it has changed the policies for the questioned issues, without the expense of a formal complaint. It is made clear to the caller in each incident that the formal complaint process is available to them.

In December 2009, a call was received from a North Carolina hospital administrator to verify a license. Inquiry revealed that the person did not hold and never held a WV license. The number given had not been assigned in 1998. The reason for verification was questionable dietetic practices. One week later a WV dietitian, employed by a state agency, called to verify his license, asking what year WV Grandfathered dietitian—that he had been

Grandfathered. The WV dietitian was alerted to the issue. As a result this person did not gain employment in WV.

Notes of 2008-2009:

The Board would, again, like to express appreciation that the WV Legislature mandated an Annual Training Seminar for West Virginia State Licensing Boards by the State Auditor's Office. This has proven to be most beneficial to the "WVBOLD. This, also, allows for interaction between boards.

WV Treasurer's Office E-Government was utilized for the 2009-2010 renewals. The majority of dietitians utilized this service. Unfortunately, many dietitians did not adhere to the policy of submitting the CEUs or they submitted when it was not their year. This will be more strongly addressed in the 2010-2011 process. Discussion with other WV boards reveal the same issues – incomplete applications, etc. Any "problems" identified with the WV Treasurer's Office will be corrected in the next renewal process.

Calls were made to 37 persons not renewing. Most were appreciative. A few bordered on abusive behavior. The 2010-2011 renewal process will <u>only</u> send a certified letter to those not renewing that their license has been placed in the Lapsed Status. It will be emphasized in newsletters that the Board should be notified of any change in address. A "I changed my address" is often heard as the "reason" a license was not renewed in a timely manner.

Perhaps of interest to auditors: Numerous/many caller to West Virginia are amazed at the quick turn-around time for new applicants or verification of licensure. One caller asked how long it would take to verify a license. When told "I can get back to you within thirty minutes", the called said "thirty days". "No, thirty minutes". This was met with shock and the statement "No other state does it that fast". Similar statement have been made concerning the approval of an application. The comment "Most states say two months" is a common one.

IMPORTANT: 2010 GOAL:

The Board is actively searching for another state board to contract for administrative duties. The goal is to complete this in 2010.

As the Board is in the process of seeking a merger with another healthcare board for administrative duties, the Board has asked Dee to remain on the WVBOLD for the purpose of assisting with this process. I. DIETITIANS INDEPENDENT PRACTICE.

Submitted by Jill Johnston, LD – This would require a chance to the Scope of Practice..Licensed Independent Practitioners – such as Nurse Practitioners or Physician Assistants are licensed to write orders on patient charts. Dietitians require a cosignature from a physician for all orders (including oral supplements, diet changes, TF, TPN, etc). The definition of an LIP from TJC is "Any individual permitted by law and by the organization to provide care and services, without direction or supervision, within the scope of the individual's license and consistent with individually granted clinical privileges".

ACTION: At this time, healthcare institutions have such privileges approved by the said medical staff. When the code is revised, at a later date, this should be considered.

II. REVIEW OF RENEWAL PROCESS

ACTION: The WV Treasurer's Office will mail postcards to licensed dietitians by May 1st apprising licensees of the online availability. Those requesting a paper copy will be required to submit a check for \$5.00.

III. Licensure Verification Online.

ACTION: Once renewals are complete, the database will be submitted to the WV Treasurer's Office to post online.

IV. AUDITING OF ALL LICENSEES FILES

ACTION: An audit is being performed to verify that the database and files are consistent as they are placed into the fireproof file cabinet.

V. WV LEGISLATURE PASSES ADDITION TO CHAPTER 30 CODE.

ACTION: Acknowledgement that boards can legally merge administrative duties in an efficiency move.

VI. FALL WV AUDITOR'S SEMINAR FOR ALL WV BOARDS ANNOUNCED.

ACTION: All Board members are encouraged to attend the WV Auditor's Seminar in October.

VII. WVBOLD NEWSLETTER PROPOSAL

Comments of Board Chairman - Helen Lodge

I would like to thank the Board members for the cooperation I received as I reviewed the renewal applications for completion and the correct reporting of CEUs. This was the most difficult renewal period. 37 dietitians had not renewed on June 30th. I, personally, made complimentarily calls to each of the 37. In most cases, the dietitians were quite grateful...in others, it was outright verbal abuse. It is suggested that in 2010 only a certified letter stating that the individual license has expired be mailed to the lapsed status individuals. 31 renewals were returned due to not reporting CEUs.

I would, especially, like to thank the Board members for their prompt replies addressing the new applications, renewal issues on an individual basis, special request, numerous questions, etc.

Each file, some 750, are being checked for accuracy in the original date of licensure, education, etc. Many computer dates (mistakes) have been discovered. You will recall that records were kept in boxes during the early years of licensure – perhaps the reason for some errors. An attempt was made to correct the database, with the best information available. A log was kept of time spent – 39+hours.

The reviewed database, to date, is believed to be accurate and up-to-date. This delayed the listing to be submitted for the 10% auditing selection. I appreciate the cooperation and understanding on this issue.

I appreciate all the good wishes during my surgery, starting with testing in August, surgery on September 22nd and recovery in October and continuing. I can assure you the functions of the Board did not suffer. Even while hospitalized for two days, the mail was picked up on one of the days. I had surgery on Tuesday and came to the office on Saturday afternoon. Telephone calls were monitored. Fortunately, no action was required.

An order was submitted to have DSL attached to the office computer to facilitate on-line licensure verification. Verizon had promised to come between 8 am and 12 pm. I was at the office at 7:30 am, called for a verification at 10:30, was told we were next, waited until 1:20 pm, called them that I was in the office alone, just exhausted from waiting and would have to leave. I left my cell phone number and did not hear from Verizon. I will contact them next week to arrange for another appointment.

While I attended the FNCE on October 19 and 20th, mail was picked up and opened as we were expecting a verification from an applicant who was licensed in 8 states. Again, there was no mail requiring immediate action. Telephone calls were, again, monitored,

I am in the process of addressing the request of the Auditing of the WVBOLD. Please note that I will be requesting information shortly for this report...including the past three years.

We have attempted to function with Dee not being able to come to the office for routine chores. At this time, as we have no action on merging our administrative duties with another board, I suggest that we accept the resignation and request an appointment be made by the Governor's office. It is, further, suggested that the applicant be from the immediate area to be accessible to the office.

Review of 2009-1010 licensure renewal:

Complaint - Provisional Licenses Expiration on an annual basis. This will require a change in the law.

Unusual number of reinstatement licenses not completed in their entirety. Unusual number of renewals did not submit educational hours as required necessitated lots of telephone calls and additional work.

Courtesy calls made to all licensees who did not renew – abuse to caller. 8371.25 CEU Credits/Hours reported

Overall consensus – dietitians felt the procedure a smooth one.

Update of Verification of Licensure online. Lelia Miller, State Treasurer's Office is working with WVBOLD to complete this in 2009. It is necessary to complete the database review prior to this action. <u>Action:</u> Helen will continue to verify the database with information in each file.

Completion of review of ALL files – 759. Lila Miller had observed that a few numbers were issued twice and some not issued at all. COMPLAINTS, INQUIRIES, INVESTIGATIONS AND CLARIFICATIONS

2008 - 2009

COMPLAINTS IN 2008-2009:

Dietitians continue to call the Board with questions regarding the Scope of Practice for dietitians, often questions about Wellness Centers and nutrition counseling. Two identified calls were from dietitians with questions concerning the counseling in Wellness Centers in a specific location. The dietitians asked if they could talk with the Centers to determine whether or not there was a violation. In both cases, the dietitians were asked to submit formal complaints. No complaints were received and an informal conversation with both determined that the Centers appreciated being informed as to nutrition counseling practices.

One call was received from a hospital administrator questioning a contract dietitian (with an LLC Dietetic/Food Services company) permitting a Diet Technician to prescribe/calcuate tube feedings. The following day the dietitian for that facility called with the same question. A formal complaint was requested and received. WVBOLD Board Chairman called the contracting dietitian (a former president of WVDA) to apprise her that a letter was being sent for clarification. A reply indicated that competencies for diet technicians had been underway. The contracting dietitians answered formally that no dietetic personnel.— except a licensed dietitian would prescribe or calculate tube feedings.

One pharmacist called to ask about a member of his company to provide nutrition counseling because, he saw so much obesity and his employee had been successful in losing weight. The professional scope of practice as it relates to physicians, nurses and pharmacist was explained, along with the scope of practice for dietitians.

Five calls were received from persons considering dietetics – online education. These calls were referred to Board member – Professional Liaison, Betty Forbes.

For the reasons listed above, the Board believes it has changed the policies for the questioned issues, without the expense of a formal complaint. It is made clear to the caller in each incident that the formal complaint process is available to them.

In December 2009, a call was received from a North Carolina hospital administrator to verify a license. Inquiry revealed that the person did not hold and never held a WV license. The number given had not been assigned in 1998. The reason for verification was questionable dietetic practices. One week later a WV dietitian, employed by a state agency, called to verify his license, asking what year WV Grandfathered dietitian—that he had been Grandfathered. The WV dietitian was alerted to the issue. As a result this person did not gain employment in WV.

WEST VIRGINIA BOARD OF LICENSED DIETITIANS

COMPLAINT CASE ID # 2008 - 1

RESOLUTION TO COMPLAINT

The administrator from Stonewall Jackson Hospital called about September 1, 2008 about a Diet Technician or Dietary Manager (perhaps a Nutrition Therapy Assistant) being allowed to calculate tube feedings. The administrator stated that the dietitian contracted to supply dietitians to the hospital was Diane Keegan from Keegan Associates. A couple days later (September 4, 2008), Evangeline Samples (licensed dietitian at that hospital) e-mailed the WVBOLD with the same question – can a Nutrition Therapy Assistant prescribe and calculate tube feedings. It was her understanding that Nutrition Therapy Assistants would have introduced into their competency level the calculation of tube feedings....to quote "Correctly calculates the nutritional components of tube feeding formulas". Evangeline stated that Diane has strongly urged her to "teach them tube feedings"....that she wanted them to calculate the feeding and then make recommendations without Evangeline's input.

The WVBOLD asked the Board Chairman to contact Diane Keegan, apprising her that a letter was being mailed to her for clarification. A call was made to Diane, who felt the request has been misinterpreted. The letter was sent on October 8, 2009. Diana immediately replied to the satisfaction of the Board. A letter was sent, and copied to Ms. Samples (November 4, 2008) that the matter had been investigated and that it is the belief of the Board that Ms. Keegan understands the scope of practice to practice dietetics in the State of West Virginia. Any further concerns should be submitted to the Board, who would immediately investigate.

ARE YOU SCHEDULED TO BE AUDITED FOR THE 2009-2010 RENEWAL PERIOD?

How to know if you are to report CEUs? If your original date of licensure occurred in: 1997, 1998, 1999, 2001, 2003, 2005 or 2007 you are to submit 20 hours/credits of CEUs.

If so, pull out those CEU credits, organize them according to date, record the program and the number of CEU credits.

You will receive a postcard about May 1, 2009 giving you instructions for renewing online. If you require a paper renewal form, send a check for \$5.00 to WVBOLD to the Board office. A paper application will be mailed to you.

Online renewal is strongly encouraged. Once your renewal is confirmed, the WV Treasurer's Office will process your charge and forward, via U.S. Postal Services, your renewal and CEUs (if applicable). WVBOLD will review your CEUs—a quick scan—check for a change in name, address, telephone number, cell phone number, FAX and employer. Any changes will be made in the database and a 2009-2010 license mailed to you.

Be certain to list the CEUs in chronological order. If you require an extension, make the request in writing to the WVBOLD. Allow time for the Board to consider your request—keeping in mind that you must hold a valid license to practice dietetics in the State of West Virginia on July 1, 2009.

Remember there IS NO GRACE PERIOD. When the "BIG BEN" strikes 12: 00 am on July 1, 2009, you must be licensed.


Once the Renewal Period is completed, a listing is compiled of all dietitians with CEUs due this year. This list is sent to a Huntington firm, where 10% of the list will be randomly selected for audit. If selected, you will be notified to send all supporting materials to Betty Forbes. Do not sent your only copy—send a copy to Betty. She will evaluate and apprise you of the acceptance of your CEUs.


As we prepare for on-line verification, each of the 772 files are being reviewed for accuracy of the complete file — to include information stored in the database. We have found that in (perhaps 4) applications, the same number was issued to two dietitians. This is being corrected and the dietitians whose number is affected is being written a letter—with a new number—and a new license. Files also revealed that the original date of licensure may not correspond with the application date—these are being corrected and will be reflected on the next set of labels for mailing.



Weeks of time and labor were spent reviewing each of the 772 files to determine the accuracy of each record.

This was done to confirm information prior to going on-line to the public.

The reasons for this procedure:

In the early days of licensure, the WVBOLD did not have an office – records were kept in hospital offices and home of the Board Secretary (in boxes). Once an office was obtained, the records were placed in file cabinet however, never checked for accuracy. The term of the Board Secretary expired and the new one had a full-time profession.

In March 2009, the Board Chairman took on the responsibility of reviewing each file for accuracy, completing "A's" to "R's". The 2009-2010 Renewal Period started in May 2009, necessitating the attention of the Board Chairman. With many file changes: new licensed dietitians, inactive licensees changing to active, active changing to inactive and some moved into lapsed status — it became necessary to start with "A's" again.

This has been done since September, having the files up-to-date and as correct as possible for the WV Treasurer's Office to post "ON-LINE" verification for the Public.

• Lila Miller, WV Treasurer's Office, informed WVBOLD that the program will be rolled out for the WVBOLD to "play" with for a couple weeks prior to going on-line to the public - anticipated in early January 2010.
