FUNCTIONS OF THE STATE BOARD OF MASSAGE THERAPY

The Functional objectives of the State Board of Massage Therapy are to administer the provisions of the West Virginia Laws, Rules and Regulations governing the profession of Massage Therapy in such a manner as to protect the public's health, safety and welfare.

The program of this agency can be generally classified into Administration and Enforcement. The Administrative functions include the categories of:

- 1. Process and qualify application for licenses
- 2. Issue licenses to qualified applicants
- 3. Provide educational information
- 4. Investigate complaints
- 5. Investigate unlicensed activity
- 6. Conduct hearings for possible suspension or revocation of license
- 7. Renew licenses every two years

The State Board of Massage Therapy consists of three licensed Massage Therapists, a lay person and an Osteopathic Physician or Chiropractor, each appointed by the Governor of West Virginia and with the consent of the Senate of the West Virginia Legislature for terms staggered initially from the first day of July 1997, the Governor shall appoint three members for the term of one year and two members for the term of two years then subsequent appointees shall be for a term of two years or until their successors are appointed.

The meeting is brought to order by Joan Wysong, Chairperson. Present are Joan Wysong, John Skelton, Marsha Starr, Roland Meffert, Amy White, and Julie Parke, Administrative Secretary for the Board. Greg Skinner, Board Attorney is absent.

A motion is made by Skelton and seconded by Meffert to approve the minutes of the Jan. 31, 2005 teleconference meeting. All in favor.

A motion is made by Starr and seconded by White to approve the Internal Control Policy for the State Purchasing Card which state that any purchase over \$500.00 must be approved by the Board. All in favor.

A motion is made by Skelton and seconded by Starr to approve a policy concerning late renewals. After a lapse of sixty days, the licensee must reapply for a new license with 25 CEUs. All in favor.

A motion is made by Skelton and seconded by Starr that facials do not fall under the scope of practice of massage therapists, with the exception of facial massage. Massage therapists are not allowed to perform facial packs, chemical treatments, extraction, or electric current treatments. Wysong suggests sending a letter to all spas not in compliance making them aware of this policy. All in favor.

A motion is made by Starr and seconded by White to come out of executive session. All in favor.

A motion is made by White and seconded by Meffert to accept the hearing examiner's report in its entirety and to have Greg Skinner draft the final order concerning complaint no. 04-10. All in favor.

A motion is made by Starr and seconded by Skelton to have Greg Skinner file for injunctive relief in circuit court against complaint no. 04-05 which will remove all advertising of massage therapy services and massage related business. All in favor.

The consent will strongly suggest that he will cease and desist using breast massage or any massage technique that exceeds normally accepted boundaries. All in favor. Acknowledge the limitations of and contraindications for massage and bodywork and refer clients to appropriate health professionals.

Consistently maintain and improve professional knowledge and competence, striving for professional excellence through regular assessment of personal and professional strengths and weaknesses and through continued education training.
