### **CE Audit**

The board's continuing education rule requires 40 hours of continuing education per biennial license renewal period. Continuing education classes are pre-approved if offered by the following organizations: the American Optometric Association, the West Virginia Optometric Association or other state optometric associations, and the American Academy of Optometry. Pre-approved continuing education classes also include international optometric sponsored meetings, regional optometric extension program congresses, postgraduate courses offered at any accredited college of optometry, the Southeastern Educational Congress, the National Contact Lens Congress, the Optometric Center of New York, and the Council on Optometric Practitioner Education [COPE]. All other courses must be submitted to the board office at least 30 days in advance for approval.

The Board has endorsed the use of the Association of Regulatory Boards of Optometry (ARBO) OE Tracker database. This database allows providers to scan attendance data from continuing education (CE) events. This tool allows the Board as a member of ARBO to download the CE records of all licensees. The Board has decided to go to a 100% sample of licensees for CE audit using OE Tracker. Those licensees who do not have sufficient CE hours in in the OE Tracker database will have to provide hard copy proof of attendance. Our first sample of 87 licensees revealed that 36 met or exceeded their CE requirements using the OE Tracker database alone. Of the total OE Tracker and paper records 77 met or exceeded CE requirements. 10 did not meet minimum criteria. Board action is pending on these licensees.

### **State Optometry Law Exam Available On Line**

Each applicant must pass an exam on West Virginia optometric law. This exam has been given in paper form often in conjunction with the oral exam. This places more stress on candidates on the day of the oral practical exam. The Board is working with the National Board of Examiners in Optometry (NBEO) to make the WV optometry law exam available on line. The exam will be available through the NBEO's website at www.optometry.org. The site will give an immediate report of the candidate's score to both the candidate and to the WV Board of Optometry. This option will allow students to take only one test on exam day. It will also be an aid to endorsement candidates to meet our license criteria.

### Web Site

The West Virginia Board of Optometry hosts its web site at **www.wvbo.org**. License verification, "Find an Optometrist," news and newsletters as well as the Board's rules are posted on the web site. Complaint forms, corporate forms, application forms and a CE Tally Sheet are also available. License renewal is conducted on the site as well.



Complaint Report 2009

AR 4

**OPTOM 09-01** Ramsey/Spencer Eye glass prescription release dispute. The committee found that there was no violation of optometric law.

**OPTOM 09-02** Herman/Hedrick Eye glass lens return policy dispute. Dr. Herman followed his policy as posted refunding frame cost but not prescription lens cost. No violation of optometric law.

**OPTOM 09-03** Ratcliff, C/Hudson contact lens prescription release dispute. No violation of optometric law. Patient received contact lens prescription.

**OPTOM 09-04** Simpson/Ward Diagnosis/referral dispute. Dr. Simpson signed a Consent Order agreeing to a written reprimand and to take 9 continuing education hours above the normal 40 hours required. Three hours are to be in medical legal issues. Three hours are to be taken in practice management, and three credit hours are to be taken on kerataconus.

**OPTOM 09-05** McClure/Lavell Dr. McClure is an ophthalmologist. The complaint was forwarded to the WV Board of Medicine.

**OPTOM 09-06** Mowery/Billings Lens dispute. Complainant requests a refund for cost of lenses. It is under investigation.





## West Virginia Board of Optometry License Exam on July 12

The West Virginia Board of Optometry will hold its summer 2009 license exam on July 12 beginning at 9:00 a.m. in the board office at 179 Summers Street, Suite 231, Charleston, WV 25301. The deadline for applications to be received in the board office is June 12, 2009.

The exam is oral and includes questions on pharmacology, laboratory procedures, ocular manifestations of systemic diseases and ophthalmic science (e.g.: optics). There is a written multiple choice jurisprudence exam administered simultaneously.

The requirements for an application are listed in West Virginia Code, §14.1. Some important requirements to remember are:

- A certified, sealed transcript from the applicant's undergraduate and optometry school must be sent to the board office.
- The applicant must take

and successfully pass the exam from the National Board of Examiners in Optometry (NBEO) parts I, II, and III. A copy of the exam results must be sent to the board office.

- Two 2" x 2" color photographs must accompany the application.
- The fee for the exam is \$300.00.

The application may be requested from the board office at 1-800-250-4150. downloaded from the board's web site at www.wvbo.org or requested by postal mail.

A copy of §14-1 on the board's application procedure may be downloaded from the web site under "Laws and Regulations Governing Optometry." The rules to study for the jurisprudence exam are listed in this section.

### **Lattisse**

As you may know, Allergan Pharmaceuticals has introduced Lattise to enhance the growth of eye lashes. It has caused no small amount of controversy throughout the country with state boards of optometry trying to decide if this is something optometrists can provide for patients and, if so, how?

As you know, laws vary from state to state. In West Virginia we are not restricted in the topical application of any pharmaceutical agent.

The question for many boards with similar topical prescriptive authority centers on the concern of whether or not providing a

within the purview of the scope of optometric practice.

Recently, the Ohio Board of Optometry ruled that cosmetic applications for prescription medication is not within the purview of optometry in that state, and therefore, the only way optometrists in that state can provide Lattisse prescriptions is for patients that have a medical diagnosis of hypotrichiasis or madaro-

The West Virginia Board of Optometry does not feel our laws in any way prohibit optometrists from being involved in prescriptive patient care for cosmetic

cosmetic prescriptive service falls purposes. If so, then we would not be able to provide perioperative care for refractive surgery or even prescribe contact lenses, which are, for the most part, the ultimate cosmetic prescriptive service.

> The West Virginia state law does expressly prohibit the dispensing of pharmaceuticals by optometrists; therefore, you are not allowed to sell Lattisse from your office.

> It can indeed be prescribed and the office visit can be billed to insurance companies if you have an appropriate medical diagnosis. While hypotrichiases or madarosis may be the primary

diagnosis to support that treatment, it would be a good idea to have a secondary diagnosis for additional documentation supporting your decision that the decrease in lashes is indeed causing a medical condition. Examples would be blehparitis or dry eye or other ocular surface disease processes.

Otherwise, the board suggests that you should charge the patient for your time and expertise, but it would be private pay, and then you write the prescription for Lattisse for cosmetic reasons.

# **Employment Of an Optometrist**

In this ever changing economy it would be unrealistic to believe that the way we all practice will not be affected in some way or another.

Some of us may see a decrease in our income; some of us may flourish, and some may have to find new opportunities in which to offer services. One thing we all need to keep in mind is that the service we offer is not a right, but a privilege that we all worked very hard to attain. That privilege is granted to us by the great state of West Virginia through our licenses to practice optometry.

Now may be a good time to review the laws that govern those privileges to practice and which can be found on the board web site.

The board has had several requests for clarification as to who or what kind of entity the

law permits an optometrist to work for as an employee.

Our laws are very clear and expressly prohibit the employment of an optometrist by ANY entity that is not either an individual who is licensed to practice optometry in West Virginia or a corporation that is recognized by the West Virginia Board of Optometry as an optometric corporation. The board may only grant optometric

corporation status to a corporation that is owned in whole by one or more licensed optome-

Of particular interest is the ability for an optometrist to be employed by another professional licensed under a different Chapter 30 regulatory board.

The answer is very specifically spelled out in the laws concerning the privilege to practice optometry. In short, you may only

be employed by an entity that is either a licensed optometrist or a licensed optometric corporation. Employment by any other person or corporation will place you in violation of state law. As such, you will be subject to the penalties and discipline set forth in those laws.

We hope this helps, and if you would have any questions regarding an employment opportunity,

please feel free to contact Pam at the board office. The West Virginia Board of Optometry is more than willing and happy to assist you in determining if an opportunity to practice is within the limitations of the privileges granted you through your license.

The West Virginia Board of Optometry will be conducting its random continuing education (CE) audit for the period from August 1 2006 through July 31, 2008 in August. All optometrists are required to keep proof of CE for the current and previous licensing periods.

A printout of the personal OE Tracker record will be provided to each licensee selected. The OE Tracker record will be considered to be proof of attendance. Certificates will be required for classes

not contained in the OE Tracker printout.

OE Tracker is a computerized repository for CE records. The West Virginia Optometric Association has used the system. Attendance is recorded by use of an electronic scanner. You may go to the Association of Regulatory Boards of Optometry web site at www.arbo.org for more information.

### **CE Audit**

The board's continuing education rule requires 40 hours of continuing education per biennial license renewal period. A minimum of 12 hours of study must be in pharmacology or therapeutics courses. A maximum of six hours may be in practice management. A maximum of ten hours may be taken by correspondence or via the Internet. Continuing education classes are pre-approved if offered by the following organizations: the American Optometric Association, the West Virginia Optometric Association, and the American Academy of Optometry. Pre-approved continuing education classes also include international optometric sponsored meetings, regional optometric extension program congresses, postgraduate courses offered at any accredited college of optometry, the Southeastern Educational Congress, the National Contact Lens Congress, the Optometric Center of New York, and the Council on Optometric Practitioner Education [COPE]. All other courses must be submitted to the board office at least 30 days in advance for approval.

The board conducted a continuing education audit in the fall. Twenty percent of the licensees were chosen. The board used OE Tracker to establish a baseline for the continuing education records required. The OE Tracker system is operated by the Association of Regulatory Boards of Optometry [ARBO]. Each chosen licensee was sent a copy of his/her OE Tracker record. Licensees were required to submit proof of continuing education for those courses not listed in the OE Tracker record. The board found no violations or deficiencies in the records of the sample.

# **Continuing Education Requirements and Audit**

The Board's continuing education requirements are listed in 14-1-8.

The requirements are:

- A minimum of twelve hours of studying pharmacology or therapeutic courses;
- A maximum of six hours of study in practice management;
- A maximum of ten hours of optometric study may be taken by correspondence or via the Internet:

All continuing education study must be sponsored by one of the organizations listed in subsection 8.4 of this section or pre-approved by the Board as outlined in subsection 14-1-8.6.

Remember that all CE must be COPE approved or be an educational meeting of one of the approved organizations e.g.: West Virginia Optometric Association, Regional Optometric Extension Programs, National Contact Lens Congress, listed in 14-1-8.4. All

other programs must be approved in advance by the Board.

The 40 required hours are to be acquired during each two year renewal period.

The Board conducted a random audit of proof of CE hours for 40 optometrists in Summer 2007. There were no violations of CE requirements for optometrists in the sample. Please retain the current and previous renewal period proof of CE for audit.

A CE Tally Sheet has been developed by the Board to help optometrists record their CE hours.

# **Release Of Contact Lens and Eye Glass Prescriptions**



The "Fairness to Contact Lens date of the prescription unless Consumers Act," H.R. 3140, became effective on February 4, 2004. The Federal law requires an optometrist to give a copy of a patient's contact lens prescription to him/her once the contact lenses have been fitted to the patient's eyes. The law also states that a contact lens prescription shall expire not less than one year after the issue

sooner for medical reasons to be listed in the patient's medical record.

The rule leaves the date of expiration for a contact lens prescription up to the laws of each state. West Virginia has no prescription expiration in its laws. Therefore the expiration date goes back to the Federal law which is no

shorter than one year. The prescription expiration date may be shorter than one year for medical reasons documented in the patient's file.

It is up to an optometrist to use his best professional judgment in establishing an expiration date for a contact lens prescription (as long as it meets the Federal requirement).

# **Board Successfully Completes Legislative Audit**

West Virginia law requires each state agency to be audited by the Legislature's office of post The Board began the process with the Legislative Auditor's office in October 2006. It began with presenting evidence on state mandated processes for operation of a licensing board as required in West Virginia Code 30-5.

Some of the processes examined are the register of licensees for required information, the Board's complaint procedures and processing of complaints over the previous years and its register of applicants. The auditor reviews the last three years

of financial records to be sure that the board is self sustaining. The auditor also reviews the boards last three years of Annual Reports for compliance with statutory requirements.

The auditor also reviews all disciplinary cases for the last three years to ensure that the Board has protected the public and followed proper due process procedures. The auditor reviews all office procedures.

This was the first legislative audit for the Board of Optometry. It was completed very successfully. The auditor found only one violation which had already been self corrected. The Board had misin-

terpreted the posting requirement in West Virginia's Sunshine Law missing the deadline by 1-3 days for filing with the Secretary of State. The Board had discovered the problem and corrected it on its own prior to the audit.

The Board was found in compliance with all other requirements. The audit report was complimentary of the Board's office procedures. The audit report was presented to the Joint Committee on Government Operations. A lobbyist for the AMA commented that the Board must be doing something right to have received such a clean report.

The Legislature continued its



approval by renewing the Board for eleven years, one of the highest total of years among all boards reviewed and scrutinized by the Legislative Auditor and the Legislature's Government Operation committees in 2007.


Ms. Sherry Cooper is in charge of Ms. Christie Utt, Deputy Attorney the expiration date for an eye government relations for the American Optometric Association. She states that it is up to the optometrist to decide the date of contact lens prescription expiration (as long as it meets the Federal standard). However, the standard of care for an eye exam is yearly. Many optometrists use one year from the release of the prescription as the expiration date.

General, agrees that an optometrist has a right to set an expiration date by using his/her best professional judgment as long as the Federal standard is met. An optometrist also has a right to refuse to fill an expired prescrip-

An eye glass prescription is to be given to the patient at the completion of the eye exam. Once again,

glass prescription should be set using the optometrist's best professional judgment.

The expiration date to use could be based on the yearly eye exam standard. The eye glass prescription expiration date could also be longer than one year if it is in the best professional judgment of the optometrist.




