ANNUAL REPORT FISCAL YEAR 2010

This report is being submitted by the Board of Optometry to meet the requirements of the State of West Virginia and its various subdivisions. The Board began 2010 by working with the Legislature to modernize and re-write the Optometric Practice Act, §30-8, which was passed by the Legislature. The Board then began the work of reviewing all of its legislative and procedural rules for compliance with the new practice act. Each rule was re-written to improve it and to conform with the new law for consideration by the 2011 Legislature. The Board also worked with the Department of Motor Vehicles to design a new vision screening form, the DLAB-2.

The Board has a "Highlights" page near the front of this report outlining some of our accomplishments for the 2010 fiscal year.

The sole function of the Board is to ensure excellent eye health care for the citizens of West Virginia, and it is in furtherance of this goal that our efforts are directed. Our mission statement is printed below.

Annual Report 2010 Highlights

Senate Bill 230 Expands Scope of Practice

The West Virginia Legislature passed Senate Bill 230 re-writing the Board's enabling statute and expanding the scope of practice for optometry on March 13, 2010. The bill becomes effective on June 13, 2010. This bill allows optometrists to prescribe and dispense contact lenses that deliver pharmaceutical agents. It codifies seven minor surgical procedures. SB 230 also allows use of diagnostic lasers, laboratory tests and epinephrine by injection. It gives the board of optometry permission to develop legislative rules to expand injection authority to include additional pharmaceuticals by injection.

The most exciting new provision allows the Board to **expand scope of practice by legislative rule** if new procedures are being taught in 50% of accredited schools of optometry. The Board is currently polling accredited optometry schools to find new items for expansion and the methods they use for certification. This bill also adds an opportunity for the Board to add new drugs or drug indications to the formulary by approval of the board.

New rules are being written for the 2011 Legislative Session to comply with SB 230 requirements and possibly pursue a further expansion of scope. The board is open to input from member boards. The scope section of Senate Bill 230 is available on our web site, www.wvbo.org, under "Laws and Regulations Governing Optometry".

**Complaint Report for 2010
Dr. David Laughlin, Complaint Chairman**

OPTOM 10-01 Dr. Stout and Patricia Allen She had her cataracts removed and needed new glasses. She received excessive tests and two pairs of glasses she could not see through. Her bill was \$977. She had already paid \$286. **Dr. Stout responded saying it was his billing company's fault with no patient records. The records were requested, received. There was a finding of no fault.**

OPTOM 10-02 Dr. Moore and Bobbie McFarland. Mr. McFarland said that Dr. Moore referred him to the surgeon in his office for a second opinion on possible cataract surgery. Mr. McFarland chose to go to Dr. Stephen Cassis instead. Mr. McFarland said that Dr. Cassis said the patient did not have cataracts. Dr. Moore's response was received. There was a finding of no fault.

OPTOM 10-03 Dr. Stout and Debra Bowser. Ms. Bowser was an assistant for a now retired optometrist and questions Dr. Stout's charges. Ms. Bowser states she was quoted \$68.00 for an eye exam. She says she explained that one insurance only paid \$25 and the other pays nothing. She said she normally pays the exam fee and then is reimbursed. She was asked for both insurance cards, and she gave them to the clerk. She says she asked for pressure tests in both eyes. She chose not to order new lenses. Her bill was \$590. An ophthalmologist has checked her eyes and does not concur with Dr. Stout's charges. Dr. Stout responded timely and said that he had adjusted her bill to under \$300.

OTPOM 10-04 Dr. Knapp and Shenandoah Walraven Ms. Walraven accuses Dr. Knapp of having sex with an underage boy. She asks for revocation of Dr. Knapp's license. Dr. Knapp responded That she is innocent of the allegations and has not been indicted and charges have been filed against her. She said that the Walravens had a 17 count indictment issued against them. Ms. Walraven called. I had sent the Dr. response letter, but forgot to enclose the dr. response. I told her I would send it to her. She said she does not want the case to close. She is suing Dr. Knapp. I told her that the final decision will not be made until the board meeting in late October. I called Det. Parks. He said 16 is the legal age of consent. There has been no indictment of Dr. Knapp yet. Dr Knapp was found to have no fault by law enforcement. No disciplinary action was required.

OPTOM 10-05 Dr. Stout against Dr. Hanna. Dr. Stout complained that Dr. Hanna had a MD with her name. I believe you spoke with Dr. Hanna, and she will try to have the advertisement removed. Dr. Stout was punished in 2000 for being listed under Ophthalmology. He paid a fine of \$200 and \$100 in administrative costs. She will try to fix it. The advertisement was removed. Dr. Stout was fined \$1000 for this before.

OPTOM 10-06 Dr. Stout and Brandon Miller. Mr. Miller states that he called and requested a "basic, routine" eye exam. He was quoted \$198.00. He authorized no additional charges. He was seen on 5/26/10. On or about June 10, 2010 he received a statement from his insurance stating that a claim had been filed for \$590. He contacted

the office and they refused to refund any charges. He wrote a letter to Dr. Stout and received the same reply. Dr. Stout replied that he gave a refund, therefore there was no problem.

OPTOM 10-07 Dr. Toompas and Noelle Juliano. She claims that Dr. Toompas made the wrong prescription for contacts. When she complained Dr. Toompas wrote the same prescription. She went to Lori Angotti who gave her a different, correct prescription. She wants to be reimbursed for some of her fees. Complaint has been sent to the committee and Dr. Toompas. Dr. Toompas has responded and provided a refund.





A Word from the President, Matthew Berardi, O.D.

The West Virginia Board of Optometry has undergone some changes. On June 11, 2010, the newly revised Chapter 30, Article 8 of the W.Va. Code went into effect. It gave this Board the ability to promulgate legislative rules that change your scope of practice. These new abilities come with new responsibilities. The Board of Optometry is now responsible for keeping all licensees aware of changes in scope as well as education requirements for scope expansion.

We have created three new officer positions in an effort to accomplish our new duties. Dr. James Campbell was appointed as Education Officer. He will advise the Board on what new procedures are being taught in Optometry and will work with our association on future education needs. Education on the EpiPen, complete with trainers that were donated by Mylan Pharmaceuticals, will be offered at the upcoming WVOA conference. Dr. Glenn Bailey was appointed as Rules Officer. He will lead our efforts in legislative rule writing. He will be working with our Executive Director, Pamela Carper, who has previous experience in this area. Dr. Greg Moore was appointed as Legislative Liaison, and he will represent the Board before the Legislative Rule Making Review Committee.

Promulgating rules has created a new financial obligation; as a

result, we increased the license renewal fee. Dr. Moore and Pam Carper were able to reduce our spending in many areas last year and we will continue to make efforts to control our budget. Rules must be reviewed by legal staff in order to meet all requirements. This increased financial obligation required an increase in fees.

In redesigning the DLAB-2 form for the Department of Transportation, I referred to forms utilized by other states. I hope to submit a revised version in 2011, so please submit any suggestions to the board office.

On scope of practice I found that the Virginia Board of Optometry has a form on their website listed under the heading "Guidance Documents" titled "LISTING OF CPT CODES DEEMED BY THE VIRGINIA BOARD OF OPTOMETRY TO REFLECT PROCEDURES WITHIN THE SCOPE OF OPTOMETRIC PRACTICE." They began working on this in the 1980s in an effort to help with insurance billing. They continue to update it as new procedures come to their attention. During the time that I am president, I hope to bring a similar document to our website. I believe this will establish a means of keeping you informed of procedures within the scope of optometric practice in West Virginia. This board will rely on optometrists in our state to make us aware of any new procedures they discover. A doctor



recently asked this board if his license allowed him to remove skin tags from eyelids with chemical cauterization. The doctor was told that his license allowed him to administer any drug for topical application to treat conditions of the human eye and its appendages. In Review of Optometry, May 2010, page 87, Dr. Jeff Yunker, OD, describes this procedure. I must admit, I did not realize I could offer my patients this procedure. I believe a list of procedures that reflects our scope of practice will allow us to practice optometry that best serves the needs of our patients.

On behalf of the Board of Optometry, I want to thank those members of the West Virginia Optometric Association for the many hours they spent at the capitol building to ensure passage of Senate Bill 230. Your efforts will impact your profession forever. This board will work to reward your efforts and expand our scope of practice.

Remember that the license period has changed. It is now from July 1, 2010 - June

WOW! What a crazy year! As you all know the WVOA was very successful in passing legislation that is considered groundbreaking for the government oversight of physician level providers who do not hold an MD degree.

This legislation allows optometrist licensed in WV to achieve the privilege to treat the eye or its appendages with the most minimal restriction in legislative code in history. There are only two things optometrist in WV can not do under legislative code, use therapeutic lasers or inject into the globe of the eye. Anything else may be promulgated through the rules committee by the board provided it is taught at 50% of the accredited schools and colleges of optometry. This is an awesome responsibility for our current and future boards. This was given in no small part because of the oversight and diligence previous boards have provided and proven to the legislature that we are indeed capable of monitoring our own. Rest assured, we will grant no optometrist additional privileges who has not proven themselves to be clinically competent to provide those services.

While that is the change making all the news, I will clarify

and point out a few other changes that were accomplished without much attention by the mainstream or industry media.

- It has always been illegal for an optometrist in WV to be employed by anyone other than another licensed optometrist. This has not changed. If you are in any type of employment contract with ANY person that is not a WV licensed OD or an entity that is not 100% owned by WV licensed OD's you are in violation of state law. It is important to note that the person violating this law would be the optometrist – not the entity offering employment. As such, the licensed optometrist is the one who would pay any penalty imposed from this violation of the law. Please review those penalties in that they can be substantial

- For those in corporate settings we did take out the language that prohibited leasing from a commercial or mercantile establishment. This would have been hard to defend in court based on the letter of the law. The intent of the law remains the same – no employment or permitting a corporate entity to provide the professional services that only a licensed Optometrist can provide. We enhanced the language with regard to keeping those lease agreements from being de facto employment contracts. Please review those and feel free to contact the board or your attorney if you feel there is a need for clarification.

- For those in ophthalmological practices, it is still illegal for you to be employed by an ophthalmologist. That does not preclude certain working arrangements however; it does preclude you from being an employee of that ophthalmologist. The legislative code for medical doctors also precludes you from employing an ophthalmologist although that is not restricted in the codes governing optometry.

- We now have the legal au-

thority to order any lab testing you may feel appropriate in the treatment and management of eye disease. Most of us were doing this before so it may not seem like a big change, but it is now permissible by legislative code. This should help in any case where insurance companies may deny such a test although we have not had that issue for some time now.

The board now has full authority with regard to expansion of our oral formulary for any new drug or new drug application that we feel pertinent to the treatment and management of eye disease. If you are aware of any oral meds currently not on our formulary please send all information on that medication to Pam for the Board's consideration. The actual policy for this is being defined in the rules process and should be completed in the next legislative session.

Please go to the web site and see all of the proposed rule changes and feel free to ask any board member if you would have a question concerning these. Once we are through that process we will notify each of you how those changes will affect you and your practice.

Now it is time for me to look back on my term as President of the WV Board of Optometry. As with all things in life we can look back and see where we made mistakes and where we made strides. This past year has been no different. In the final analysis, I am confident that the WV Board of Optometry was an integral and effective part of the most significant change in the history of optometry since the 1976 legislation.

The '76 legislation laid the groundwork for expanding scope privileges through changes in legislative code. The 2010 legislation will be remembered as the legislation that laid the groundwork for removing from the legislative codes specific scope issues yet maintaining legislative

oversight by permitting the Board to oversee expansion of practice scope to stay consistent with advancements in science yet maintaining legislative oversight through the rule making process.

I want to personally thank our optometric members: Dr. Glenn Bailey, Dr. Matt Berardi, Dr. Jim Campbell, Dr. David Laughlin and our lay members: Ms. Lori Gemono, and Mr. Ray Kenner, Esq., our general council Nicole Cofer, Esq., and last but certainly not least our Executive Director Pam.

I have no doubt that each of these board members went well above and beyond what is normally expected in these rolls.

As for the other optometrists on the board, I can't even begin to express here how honored I am to serve on a board with these gentlemen. A chain is only as strong as its weakest link and although we all have various backgrounds and practice modalities, there is not a one of them that is anything short of the best possible example of what our profession is and should embody.

In our July meeting our Secretary Treasurer, Dr. Matt Berardi, was elected to the office of President. He has picked up the gavel and has worked tirelessly in his first month. He has incorporated changes to the Board that I would have never thought of. I am sure as each member takes their role as our Board President you will be better served.

I am very proud of the way the WV Board of Optometry handled every situation that arose during my Presidency. I am extremely proud of the effect we were able to impart on the legislation which passed.

It is an honor and a privilege to serve the citizens of WV as a member of the WV Board of Optometry and I will forever reflect on my time as President of this esteemed body as one of, if not the, highlight of my career.

West Virginia Board of Optometry License Exam Statutory Date is February 13, 2011

The West Virginia Board of Optometry will hold its winter 2011 license exam on February 13 beginning at 9:00 a.m. in the board office at 179 Summers Street, Suite 231, Charleston, WV 25301. The deadline for applications to be received in the board office is January 13, 2011.

The exam is oral and includes questions on pharmacology, laboratory procedures, ocular manifestations of systemic diseases and ophthalmic science (e.g.: optics). There is a written multiple choice exam on jurisprudence administered simultane-

ously. You may also choose to take the jurisprudence exam through the National Board of Examiners in Optometry on its website at www.optometry.org. The fee is \$25. Go to "Laws and Regulations Governing Optometry" on our website at www.wvbo.org to study for the jurisprudence exam.

The requirements for an application are listed in West Virginia Code, §14-1. Some important requirements to remember are:

- A certified, sealed transcript from the applicant's undergraduate and optometry

school must be sent to the Board office.

- The applicant must take and successfully pass the exam from the National Board of Examiners in Optometry (NBEO) parts I, II, and III including the examination on injections. A copy of the exam results must be sent to the Board office.

- A copy of your birth certificate is to be enclosed.

- Two 2" x 2" color photographs must accompany the application.

- The fee for the exam is \$300.00.

The application may be requested from the board office at 1-800-250-4150, downloaded from the board's web site at www.wvbo.org or requested by postal mail.

Please check with the office around December 13 to be sure that the exam date has not been moved due to unforeseen circumstances.

§14-1 on the application process is posted on the web site under "Laws and Regulations."

The Board's Proposed Legislative Rules

The Board's enabling statute, §30-8, was completely rewritten by Senate Bill 230 effective on June 11, 2010. All of the Board's legislative rules must be re-written to comply with the bill. Some changes were minor, such as re-labeling sections of the rules to match the new legislation.

The Board has added three new rules, §14-9 on Contacts That Contain and Deliver Pharmaceutical Agents, §14-10 on Continuing Education, §14-11 on Injectable Pharmaceutical Agents.

§14-9 sets up a certificate to allow optometrists to prescribe and dispense contact lenses that deliver pharmaceutical agents for a reasonable and customary fee. An optometrist

may not dispense these contacts based on an outside prescription.

§14-10 is on Continuing Education takes CE out of §14-1, Rules of the Board. This will allow the Board to make adjustments to continuing education requirements as the scope of practice increases. It also modernizes the pre-approved sponsor list, and makes the CE approval process and documentation required more clear. A two year period to acquire the required hours in continuing education is retained.

§14-11 sets up requirements to obtain the privilege of administering injectable pharmaceuticals. The Board will keep a list of approved courses for training in injection techniques

and the pharmaceuticals approved for administration. The Board will also maintain a list of approved injection sites and pharmaceuticals permissible for inspection by the public. Those optometrists who gain the privilege must obtain certification from the American Heart Association or American Red Cross in basic life support.

The Board has re-written §14-2 on oral pharmaceutical agents. It now includes the statutory categories of oral antibiotics, oral nonsteroidal anti-inflammatory drugs and oral carbonic anhydrase inhibitors so all oral pharmaceutical categories will be listed in the rule together. It also outlines criteria for the Board to approve new oral drugs. A list of approved new drugs will be maintained by the

Board for public inspection.

§14-1 Rules of the WV Board of Optometry, adds a definition section that clearly defines the two examinations required for licensure, the National Board of Examiners in Optometry Examination and the West Virginia Examination. The rule changes the license renewal period from two years to one year beginning on July 1, 2012. The two year period for acquiring required continuing education hours is retained in proposed §14-10. The rule adds the new forms of permits and licensure required in the new law.

§14-5, Fees, adds new fees for the new permits.

The proposed rules are posted on the web site from the home page and under "Rules and Regulations Governing Optometry."

The WV Health Information Network for Electronic Health Records

The West Virginia Health Information Network was formed under the oversight of the Health Care Authority to facilitate exchange of health records

through the use of Electronic Health Records.



HIGHLIGHTS 2009

CE Audit

The board's continuing education rule requires 40 hours of continuing education per biennial license renewal period. Continuing education classes are pre-approved if offered by the following organizations: the American Optometric Association, the West Virginia Optometric Association or other state optometric associations, and the American Academy of Optometry. Pre-approved continuing education classes also include international optometric sponsored meetings, regional optometric extension program congresses, postgraduate courses offered at any accredited college of optometry, the Southeastern Educational Congress, the National Contact Lens Congress, the Optometric Center of New York, and the Council on Optometric Practitioner Education [COPE]. All other courses must be submitted to the board office at least 30 days in advance for approval.

The Board has endorsed the use of the Association of Regulatory Boards of Optometry (ARBO) OE Tracker database. This database allows providers to scan attendance data from continuing education (CE) events. This tool allows the Board as a member of ARBO to download the CE records of all licensees. The Board has decided to go to a 100% sample of licensees for CE audit using OE Tracker. Those licensees who do not have sufficient CE hours in the OE Tracker database will have to provide hard copy proof of attendance. Our first sample of 87 licensees revealed that 36 met or exceeded their CE requirements using the OE Tracker database alone. Of the total OE Tracker and paper records 77 met or exceeded CE requirements. 10 did not meet minimum criteria. Board action is pending on these licensees.

State Optometry Law Exam Available On Line

Each applicant must pass an exam on West Virginia optometric law. This exam has been given in paper form often in conjunction with the oral exam. This places more stress on candidates on the day of the oral practical exam. The Board is working with the National Board of Examiners in Optometry (NBEO) to make the WV optometry law exam available on line. The exam will be available through the NBEO's website at www.optometry.org. The site will give an immediate report of the candidate's score to both the candidate and to the WV Board of Optometry. This option will allow students to take only one test on exam day. It will also be an aid to endorsement candidates to meet our license criteria.

Web Site

The West Virginia Board of Optometry hosts its web site at www.wvbo.org. License verification, "Find an Optometrist," news and newsletters as well as the Board's rules are posted on the web site. Complaint forms, corporate forms, application forms and a CE Tally Sheet are also available. License renewal is conducted on the site as well.



OPTOM 09-01 Ramsey/Spencer Eye glass prescription release dispute. The committee found that there was no violation of optometric law.

OPTOM 09-02 Herman/Hedrick Eye glass lens return policy dispute. Dr. Herman followed his policy as posted refunding frame cost but not prescription lens cost. No violation of optometric law.

OPTOM 09-03 Ratcliff, C/Hudson contact lens prescription release dispute. No violation of optometric law. Patient received contact lens prescription.

OPTOM 09-04 Simpson/Ward Diagnosis/referral dispute. Dr. Simpson signed a Consent Order agreeing to a written reprimand and to take 9 continuing education hours above the normal 40 hours required. Three hours are to be in medical legal issues. Three hours are to be taken in practice management, and three credit hours are to be taken on kerataconus.

OPTOM 09-05 McClure/Lavell Dr. McClure is an ophthalmologist. The complaint was forwarded to the WV Board of Medicine.

OPTOM 09-06 Mowery/Billings Lens dispute. Complainant requests a refund for cost of lenses. It is under investigation.







West Virginia Board of Optometry License Exam on July 12

The West Virginia Board of Optometry will hold its summer 2009 license exam on July 12 beginning at 9:00 a.m. in the board office at 179 Summers Street, Suite 231, Charleston, WV 25301. The deadline for applications to be received in the board office is June 12, 2009.

The exam is oral and includes questions on pharmacology, laboratory procedures, ocular manifestations of systemic diseases and ophthalmic science (e.g.: optics). There is a written multi-

ple choice jurisprudence exam administered simultaneously.

The requirements for an application are listed in [West Virginia Code, §14.1](#). Some important requirements to remember are:

- A certified, sealed transcript from the applicant's undergraduate and optometry school must be sent to the board office.
- The applicant must take

and successfully pass the exam from the National Board of Examiners in Optometry (NBEO) parts I, II, and III. A copy of the exam results must be sent to the board office.

- Two 2" x 2" color photographs must accompany the application.
- The fee for the exam is \$300.00.

The application may be requested from the board office at 1-800-250-4150, downloaded from the board's web site at www.wvbo.org or requested by postal mail.

A copy of §14-1 on the board's application procedure may be downloaded from the web site under "Laws and Regulations Governing Optometry." The rules to study for the jurisprudence exam are listed in this section.

Lattisse

As you may know, Allergan Pharmaceuticals has introduced Lattisse to enhance the growth of eye lashes. It has caused no small amount of controversy throughout the country with state boards of optometry trying to decide if this is something optometrists can provide for patients and, if so, how?

As you know, laws vary from state to state. In West Virginia we are not restricted in the topical application of any pharmaceutical agent.

The question for many boards with similar topical prescriptive authority centers on the concern of whether or not providing a

cosmetic prescriptive service falls within the purview of the scope of optometric practice.

Recently, the Ohio Board of Optometry ruled that cosmetic applications for prescription medication is not within the purview of optometry in that state, and therefore, the only way optometrists in that state can provide Lattisse prescriptions is for patients that have a medical diagnosis of hypotrichiasis or madarosis.

The West Virginia Board of Optometry does not feel our laws in any way prohibit optometrists from being involved in prescriptive patient care for cosmetic

purposes. If so, then we would not be able to provide peri-operative care for refractive surgery or even prescribe contact lenses, which are, for the most part, the ultimate cosmetic prescriptive service.

The West Virginia state law does expressly prohibit the dispensing of pharmaceuticals by optometrists; therefore, you are not allowed to sell Lattisse from your office.

It can indeed be prescribed and the office visit can be billed to insurance companies if you have an appropriate medical diagnosis. While hypotrichiasis or madarosis may be the primary

diagnosis to support that treatment, it would be a good idea to have a secondary diagnosis for additional documentation supporting your decision that the decrease in lashes is indeed causing a medical condition. Examples would be blepharitis or dry eye or other ocular surface disease processes.

Otherwise, the board suggests that you should charge the patient for your time and expertise, but it would be private pay, and then you write the prescription for Lattisse for cosmetic reasons.

Employment Of an Optometrist

In this ever changing economy it would be unrealistic to believe that the way we all practice will not be affected in some way or another.

Some of us may see a decrease in our income; some of us may flourish, and some may have to find new opportunities in which to offer services. One thing we all need to keep in mind is that the service we offer is not a right, but a privi-

lege that we all worked very hard to attain. That privilege is granted to us by the great state of West Virginia through our licenses to practice optometry.

Now may be a good time to review the laws that govern those privileges to practice and which can be found on the board web site.

The board has had several requests for clarification as to who or what kind of entity the

law permits an optometrist to work for as an employee.

Our laws are very clear and expressly prohibit the employment of an optometrist by ANY entity that is not either an individual who is licensed to practice optometry in West Virginia or a corporation that is recognized by the West Virginia Board of Optometry as an optometric corporation. The board may only grant optometric

corporation status to a corporation that is owned in whole by one or more licensed optometrists.

Of particular interest is the ability for an optometrist to be employed by another professional licensed under a different Chapter 30 regulatory board.

The answer is very specifically spelled out in the laws concerning the privilege to practice optometry. In short, you may only

be employed by an entity that is either a licensed optometrist or a licensed optometric corporation. Employment by any other person or corporation will place you in violation of state law. As such, you will be subject to the penalties and discipline set forth in those laws.

We hope this helps, and if you would have any questions regarding an employment opportunity,

please feel free to contact Pam at the board office. The West Virginia Board of Optometry is more than willing and happy to assist you in determining if an opportunity to practice is within the limitations of the privileges granted you through your license.

The West Virginia Board of Optometry will be conducting its random continuing education (CE) audit for the period from August 1

2006 through July 31, 2008 in August. All optometrists are required to keep proof of CE for the current and previous licensing periods.

A printout of the personal OE Tracker record will be provided to each licensee selected. The OE Tracker record will be considered to be proof of attendance. Certificates will be required for classes

not contained in the OE Tracker printout.

OE Tracker is a computerized repository for CE records. The West Virginia Optometric Association has used the system. Attendance is recorded by use of an electronic scanner. You may go to the Association of Regulatory Boards of Optometry web site at www.arbo.org for more information.
