In the past, some PEIA reports have been voluminous spreadsheets, as is the enclosed, and are essentially impossible to upload. 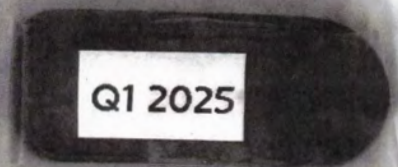
