MINUTES OF THE WEST VIRGINIA BOARD OF PHARMACY CHARLESTON, WEST VIRGINIA, JULY 26, 2017

The Board convened in the Board Office Conference Room, 2310 Kanawha Boulevard, East, Charleston, West Virginia, at 9:00 a.m., on Wednesday, July 26, 2017, with President Dennis Lewis presiding. Present at the meeting in person were Board members: Dennis Lewis, Vicky Skaff, David Bowyer, Chuck Jones and Sam Kapourales; the following Board members were present by teleconference on speakerphone: John J. Bernabei and Everett Frazier. Staff present in the office were Acting Director and CSMP Administrator Michael Goff, CFO John Smolder, and Board Inspector Buck Selby. Staff present on the conference call were Board Inspectors, Roger Shallis, David Gerkin and Don Klamut; and Board Investigators Fred Wagoner and David Lucas.

Members of the public attending the meeting were Mark Polen of Rite Aid/LGCR Gov't Solutions, Betsy Wright of Kroger, John Long of CVS Health, Justin Taylor of Bailey & Wyant and Michael Taylor of Bailey & Wyant.

Mr. Lewis stated that a quorum was present, and noted that proper notice of this meeting had been filed with the Secretary of State and posted on the Board's website. The Agenda was also posted on the Board's website and made available through the Office. Mr. Lewis opened the meeting with prayer.

First, Mr. Lewis wanted to make an adjustment to the agenda by moving Item 10 (Review previous meeting minutes) and making it the first item for discussion. The minutes from the June 11 & 12 and June 26 were reviewed by board members, and minor corrections were suggested. Motion was made to approve the minutes with corrections by Everette Frazier and seconded by Sam Kapourales. All in favor with no votes against, motion carried. David Bowyer recused himself on this vote.

Next, Mr. Lewis introduced the newest board member, David Bowyer followed by his swearing in.

Then the Board discussed several Title 15 Rules:

- Series 1, Centralized Prescription Processing, due to no public comments, a motion was made by Vicky Skaff to move forward with the next steps in filing this rule, seconded by Chuck Jones. All in favor with no votes against, motion carried.
- Series 8, CSMP reporting related to drugs of concern/Gabapentin, comment was made by NACDS requesting an 18-month grace period be considered by the board. Board concluded not to accept this proposal and a motion was made by Vicky Skaff to move forward with the next steps in filing this rule, seconded by David Bowyer. All in favor with no votes against, motion carried.
- Series 12, Immunizations, comment was made by the WV Board of Medicine which concurred with the proposed updates to the rule. A motion was made by Sam Kapourales to move forward with the next steps in filing this rule, seconded by Vicky Skaff. All in favor with no votes against, motion carried.

Series 14, Centralized Prescription Processing, comment was made by NACDS requesting the board to consider several language changes related to centrally filled prescription must be returned to the original pharmacy and not shipped directly to the patient from the central fill location. Board concluded not to accept this proposal and a motion was made by Vicky Skaff to move forward with the next steps in filing this rule, seconded by Chuck Jones. All in favor with no votes against, motion carried.

A PT Training Program was submitted to the Board by Village Pharmacy. After review, David Bowyer made a motion to approve their PT training program. Seconded by JJ Bernabei. All in favor with no votes against, the motion carried.

The Board discussed Pharmacy Technician (PT) Training Programs. A motion was made by Sam Kapourales, that future PT Training Program submissions be reviewed by the Acting Executive Director, Michael Goff, and then he recommend the training program for approval if they meet all established criteria. Seconded by Vicky Skaff. All in favor with no votes against, motion carried.

The Board reviewed the amended Complaint Handling Procedures, and a motion was made by Vicky Skaff and seconded by Chuck Jones to accept the proposed changes. All in favor with no votes against, the motion carried.

Acting Executive Director Michael Goff presented information regarding a part-time attorney, compared to a full-time position. After discussion, the Board concluded that a full-time attorney would be better suited to address their future goals. A motion was made by Vicky Skaff and seconded by David Bowyer to proceed with the hiring process for a full-time attorney. All in favor with no votes against, the motion carried.

Acting Executive Director Michael Goff gave a brief discussion about how the office is taking a more proactive approach to the Suspicious Order reporting process. For a number of months, Suspicious Order reports have been collected until the end of the month, and then a representative from the AG's office would pick them up, take them to their office, scan them, and return us the paper copies with a digital copy of the scanned documents. Beginning two weeks ago, the reports are scanned at the Board office and a digital version is forwarded to the AG, while another digital copy is sent to our Chief Compliance Officer to begin evaluating the reports. He will be providing feedback about his findings so we can better understand the reporting process, and to determine ways to address them going forward, working with both the wholesale distributors and pharmacies. Charles "Buck" Selby discussed his review of the initial suspicious orders for two wholesalers. He reported that some of the suspicious orders were "suspicious" themselves, and that it appears that a large number of the suspicious orders were insignificant in actual quantities involved, and that there appeared to be several reports for the same order being repeated for days. Mr. Selby also suggested that Michael LeMasters' Best Practice Guidelines for MAT be placed on the agenda to be considered at the next Board meeting, and that the Board should consider addressing the issue of pharmacies being cut off by distributors for ordering MAT products to fill patient orders. No action was taken since this was for informational purpose.

Motion was made by Vicky Skaff and seconded by David Bowyer to go into Executive Session to discuss wholesale litigation and other matters. All in favor with no votes against, the motion carried.

President Dennis Lewis declared the Board back into public session. John J. Bernabei and Sam Kapourales are no longer present.

A motion was made by Chuck Jones, and seconded by Vicky Skaff, to accept the offer related to Complaint 2016-08-61. All in favor with no votes against, the motion carried. David Bowyer recused himself on this vote.

Motion was made by David Bowyer to adjourn. Seconded by Everett Frazier. All in favor with no votes against, the motion carried.

The Board convened in the Board Office Conference Room, 2310 Kanawha Boulevard, East, Charleston, West Virginia, at 10:00 a.m., on Friday, September 1, 2017, with President Dennis Lewis presiding. Present at the meeting in person were Board members: Sam Kapourales; the following Board members were present by teleconference on speakerphone: Dennis Lewis, John J. Bernabei, Vicky Skaff, David Bowyer, Everett Frazier and Chuck Jones. Staff present in the office were Acting Director and CSMP Administrator Michael Goff and CFO John Smolder.

No members of the public attended the meeting.

On each of the two days, President Lewis called the meeting to order and stated that a quorum was present. President Lewis further stated that proper notice of the meeting had been filed with the Secretary of State's office. The agenda for the meeting had previously been posted on the Board's website and made available through the Board's office. The meeting was opened with a prayer. President Lewis then briefly explained the new organizational chart for the Board and stated that the chart will soon be on the Board's website.

- 1. The first item the Board took up was approving the minutes from June 26, July 26, and September 1, 2017. Motion to approve the minutes was made by Board Member Bernabei. Board Member Frazier seconded the motion. The motion passed unanimously.
- 2. The Chief Financial Officer, John Smolder, then gave his financial report. Mr. Smolder stated that all deadlines had been met on time except for the deadline regarding fixed assets. The report reveals that the financial state of the Board is very good. Mr. Smolder's report was accepted by the Board with a motion by Board Member Bowyer. Board Member Skaff seconded the motion. The motion passed unanimously.
- 3. Michael Goff, the Acting Executive Director of the Board and CSMP Administrator, then gave his Executive Director report. Mr. Goff stated that almost ten thousand licenses have been processed the last cycle. Currently, the staff is working with the vendor to create the new licensing database, which will include updating and enhancing the Board's website. Mr. Goff stated that the new direction of the Board is to be more progressive in dealing with compliance, suspicious orders and other pharmacy related matters. This will include collaborating with other agencies and stakeholders. He also announced that the recently approved rules will be taken up at the Legislature later this month. Mr. Goff's report was accepted by the Board with a motion by Board Member Bernabei. The motion was seconded by Board Member Frazier and passed unanimously.
- 4. President Lewis removed the West Virginia Medical Association introduction and update from the agenda.
- 5. Mike Brown, Executive Director of WV Restore, then gave a brief overview and an update on the WV Pharmacists Recovery Network ("WVPRN"). According to his report, there are currently seventeen clients in the program that are board ordered/referred and twelve that are self-referred/reported. There is currently one student enrolled in WVPRN.

- Motion was made by Board Member Bernabei to enter an executive session. The
 motion was seconded by Board Member Bowyer and passed unanimously. The
 Board then began a brief executive session.
- 7. Next, the Board took up the Complaint Committee's Disciplinary Recommendations. The Complaint Committee's Disciplinary Recommendations were adopted by motion by Board Member Frazier, which was seconded by Board Member Bowyer, and passed unanimously.
 - TO DO: Mr. Hatfield will determine a way to incorporate Letters of Caution into disciplinary records. Additionally, Mr. Hatfield will review the complaint form utilized by the Board to determine its legal sufficiency.
- 8. Members of the Board were presented with official badges.
- 9. President Lewis removed Cardinal Health Suspicious Order overview from the agenda.
- 10. Next, Chief Compliance Officer Selby presented a newly proposed suspicious order form. This item was not listed on the agenda. The form was approved with the understanding that Mr. Selby will update the form based on discussions with all major wholesalers. Motion was made by Board Member Kapourales to accept the form. The motion was seconded by Board Member Frazier and passed unanimously.

TO DO: Mr. Selby will update the form based on discussions with all major wholesalers.

- 11. Chief Compliance Officer Selby then gave his Inspector's Report. Mr. Selby stated that inspections are ongoing and up to date. The final review of the 2017 Law Book has been completed and the Law Book is now approved for printing. Mr. Selby has been working with staff and Big Picture Software on transitioning to new licensing software. Board Member Skaff motioned that the Inspector's Report be accepted. The motion was seconded by Board Member Bernabei and passed unanimously.
- 12. Chief Compliance Officer Selby next presented a proposed procedure on new pharmacy permit applications. The purpose of this procedure is to allow a period for the applicant to apply for and receive additional licenses and third-party insurance contracts. Motion was made by Board Member Skaff to accept the proposed procedure. The motion was seconded by Board Member Bernabei and passed unanimously.
- 13. Chief Compliance Officer Selby then gave his review of transferring unfilled controlled substance prescriptions. Mr. Selby stated that the Board should promulgate a procedure regarding the transfer of controlled substance prescriptions. Mr. Selby put forth a draft procedure which was previously reviewed and approved by several inspectors and pharmacists. Motion was made by Board Member

- Bowyer to approve the procedure, which was seconded by Board Member Frazier, and passed unanimously by the Board.
- 14. The next item of business was a review of USP 800 by Inspector Klamut. Mr. Klamut stated that compliance with USP 800 will be very expensive for facilities but some are already working on becoming compliant because they have the funding immediately available. Mr. Klamut's report was accepted without motion. TO DO: Board Member Bernabei will draft language for a motion to be made at the next Board meeting regarding USP 800 compliance.
- 15. Next, Mike LeMasters presented a brief overview of his MAT Program guidelines. The Board determined that if pharmacies in West Virginia follow the guidelines set forth by Mr. LeMasters, or create their own guidelines mirroring the guidelines put forward by Mr. LeMasters, then the Board will assist them if they have any issues with suppliers related to ordering MAT products. Motion was made by Board Member Bernabei to adopt Mr. LeMaster's guidelines as official guidelines for pharmacies in West Virginia. The motion was seconded by Board Member Bowyer and passed unanimously.
- 16. Acting Executive Director and CSMP Administrator Michael Goff then gave his Controlled Substances Monitoring Program Report. Mr. Goff stated the new CSMP vendor contract was finally awarded, and construction should begin around the first of October. Current CSMP statistics were discussed, including that nearly all categories of West Virginia drug doses dispensed have decreased, with the exception of buprenorphine. A brief overview of the current CDC grant was provided, which mentioned the new staff projects and workflow integration plans. Motion was made by Board Member Skaff to accept the report, which was seconded by Board Member Kapourales, and passed unanimously.
- 17. Motion was made by Board Member Skaff to approve Penn-Way Pharmacy's PTT Training Course. The motion was seconded by Board Member Bowyer and passed unanimously.
 - TO DO: Mr. Goff and Mr. Hatfield will work together to create criteria checklists for approving training courses and granting collaborative practice applications. In the future, Mr. Goff and Mr. Hatfield will review training courses collaborative practice applications and time extensions for Pharmacy Technician training prior to Board meetings and make recommendations to the Board as to whether such courses or applications should be approved. The Board will then consider Mr. Goff and Mr. Hatfield's recommendations and vote to approve or deny the extensions, training courses and collaborative practice applications.
- 18. Motion was made by Board Member Skaff, which was seconded by Board Member Kapourales, and passed unanimously to approve the following applications for collaborative pharmacy practice: Charles K. Babcock, Laura P. Welch, Dipti Patel.

- 19. Motion was made by Board Member Skaff, which was seconded by Board Member Bowyer, and passed unanimously to grant the following second extensions of time for PT training/retraining: Kristen Hatfield, Tiffany Turner, Amanda Shelton, Heather DeVor, and Virginia Taylor.
- 20. The Continuing Education Committee was then discussed. Board Member Bowyer accepted the position of Chairman of the Continuing Education Committee. The Board was unanimously in favor of Board Member Bowyer accepting this position.
- 21. Next, the Board discussed Disaster Response and Mitigation Protocols. Board Member Bowyer and Chief Compliance Officer Selby agreed to work together on formulating Board protocols modeled after those provided by the NAPB.

TO DO: Board Member Bowyer and Mr. Selby will work together to formulate Disaster Response and Mitigation Protocols.

- 22. The creation of varying levels of pharmacy technicians was discussed, including advance practice pharmacy technicians and "pharmacy assistants". to allow for a person to work in a pharmacy without having passed the national exam. The policy behind these proposed changes is to allow pharmacies to retain and utilize certain employees without having passed the national exam.
 - TO DO: The law will need to be changed to allow for differently defined duties for individuals working in pharmacies. Additionally, determination of whether nuclear technicians need to be certified as pharmacy technicians must be addressed.
- 23. The next Board meeting was scheduled for Sunday, December 10, 2017 in Charleston, West Virginia.
- 24. Motion to adjourn was made by Board Member Skaff, seconded by Board Member Kapourales, and passed unanimously.

On Sunday, December 10, 2017, the West Virginia Board of Pharmacy ("the Board") convened at the Board office, located at 2310 Kanawha Boulevard East, Charleston, West Virginia for the Board's quarterly meeting and completed items one through eight of the meeting agenda. On the following day, Monday, December 11, 2017, the Board reconvened at the Board office to complete the meeting. The meeting was open to the public. For efficiency purposes, the minutes from both days have been combined into the present document.

On each of the two days, President Lewis called the meeting to order and stated that a quorum was present. The agenda for the meeting had previously been posted on the Board's website and made available through the Board's office. The meeting was opened with a prayer. However, because notice of the meeting was not adequately provided, all items discussed on December 10 and December 11 were not voted on until December 13, 2017.

- 1. The first item the Board took up was approving the meeting minutes for the Board's meeting on September 17 and 18, 2017. There were no changes.
- 2. The Chief Financial Officer, John Smolder then gave his report and the Board's budget was presented. It is projected that the Board's funds will not be swept by the Legislature at the end of the fiscal year.
- 3. The Acting Executive Director, Mike Goff, then gave his report. Mr. Goff stated that Board staff is currently working on providing additional data for the Board's licensing database that is under construction. The online service fee of 2.5% for online license renewals was discussed. It was proposed that the licensee will pay this 2.5% fee directly to the vender. This proposal would be voted on at the Board's meeting on December 13, 2017.
 To do: Mr. Goff and Mr. Hatfield will look into potentially requiring identification to be checked when controlled substances are delivered via mail order. Additionally, Mr. Goff and Mr. Hatfield will look into purchasing exemptions for large expenditures. Board Member Jones suggested looking at BRIM legislation which provides for such exemption.
- 4. Dr. Brad Henry, President of the WV Medical Association then gave a brief presentation. Dr. Henry stated that he believes it is widely believed that Gabapentin should be a scheduled drug. Dr. Henry further stated that he believes controlled substance prescriptions should be limited to thirty (30) day supplies.
- 5. Replacing Dr. Robert Turner on the Controlled Substance Monitoring Program Advisory Committee with Dr. Edward Eskew was discussed.
- 6. Board Member Bowyer gave the Continuing Education Committee's update. Board member Skaff suggested removing outdated Continuing Education seminars from the Board's website. The process for approving Continuing Education seminars was discussed.
- 7. Board Member Skaff gave a complaint status update. According to Board Member Skaff's handout, from the period of January 1, 2017 to December 10, 2017 there were six (6) revocations of pharmacy technician and pharmacy technician trainee licenses; nineteen (19) dismissals; seven (7) letters of caution; six (6) reprimands; five (5) reprimands/suspensions; three (3) suspension referrals; two (2) denials of licensure; and one (1) pending disciplinary decision.
- 8. The Board then went into Executive Session to discuss disciplinary cases.

- 9. The General Counsel, Ryan Hatfield, then gave his report. Mr. Hatfield gave a disciplinary case overview. Mr. Hatfield proposed a new complaint form which meets all legal requirements. Finally, Mr. Hatfield updated the Board on pending litigation. The Board stated that Mr. Hatfield and Mr. Goff will use their discretion in referring Board licensees' discipline from other jurisdictions to the Complaint Committee.
- 10. Dr. Rahul Gupta, West Virginia State Health Officer, then gave a brief presentation. Dr. Gupta stated that post mortem autopsies were being performed on the bodies of all individuals who overdose from opioids in the state to determine the profile those individuals to determine risk factors. Dr. Gupta stated that the results from these inspections would be presented on December 15, 2017. Dr. Gupta further stated that a meeting would occur on December 21, 2017 for a panel to produce steps for preventing deaths.
- 11. Buck Selby, Chief Inspector, then gave his Inspector's report. Mr. Selby suggested that pharmacies should be inspected each year. Mr. Selby also suggested that the Board hire a full-time pharmacist to work in-house at the Board office.
 - To do: Mr. Goff will work with Walgreens on applications related to in state purchases and new registrations.
- 12. Board Member Bowyer and Mr. Selby then presented a draft of the Disaster Response and Mitigation Protocol.
- 13. Mr. Goff then presented the Controlled Substances Monitoring Program report. Currently, the information is protected by law. Mr. Goff stated that he is researching ways to expand the law to allow for greater disclosure.
- 14. Requests for second extensions of time for PT training/retraining was discussed by Mr. Goff. Mr. Goff stated that he will provide the names for the extensions when the Board votes on December 13, 2017. Mr. Goff further stated that all three applications meet the required criteria for extensions.
- 15. Collaborative Pharmacy Practice applications for the following individuals were considered: Lisa Garavaglia; Ashley Modany; and Prashanth Iyer.
- 16. Board Member Bernabei then discussed USP 800. Board Member Bernabei stated that the deadline for implementation had been extended from July 2018 until December 2019.
- 17. The Legislative Rule governing Central Fill was then discussed. The Board discussed changing "originating pharmacy" to "originating or dispensing pharmacy" throughout the rule. This change will be voted on at the Board's December 13, 2017 meeting.
- 18. Board Member Skaff and Mr. Hatfield then discussed the following legislation: Renal Dialysis Profucts; Pharmacy Technician Exemption for cashiers; Pharmacy Technician Reciprocity; Licensing Fee Change; pending legislation; and possible new legislation. Updating rules governing collaborative practice was discussed. Enhancing the Practice Act

to help get services reimbursed by insurance like the State of Washington does was also discussed.

To do: Mr. Goff and Mr. Hatfield will look into possible legislation creating a felony for the diversion of drugs less than one thousand dollars (\$1,000).

19. The next meeting was scheduled for March 18 and 19, 2018, in Morgantown, West Virginia.

- 1. The first item the Board took up was the election of officers and committee appointments. Board Member Jones motioned that all officers and committee appointments remain the same. Board Member Bowyer seconded this motion. The motion passed unanimously.
- 2. The Board voted to accept the minutes of the March 17 and 18, 2018 meeting. Board Member Jones made motion to accept the minutes. Board Member Skaff seconded the motion. The motion passed unanimously.
- 3. The Board voted to accept the minutes of the May 25, 2018 meeting. Board Member Skaff made motion to accept the minutes. Board Member Bowyer seconded the motion. The motion passed unanimously.
- 4. The Board voted to accept the minutes of the June 1, 2018 meeting. Board Member Bowyer motioned to accept the minutes. Board Member Skaff seconded the motion. The motion passed unanimously.
- 5. Mr. Goff then gave his Executive Director's Report. Mr. Goff gave a brief office update, explained the upcoming NarxCare/CSMP integration project, reviewed the issues related to the newly enacted SB 273, presented an ARCOS data overview and spoke about upcoming meetings the Board will be involved with. Board Member Jones motioned to accept the Executive Director's report. Board Member Skaff seconded the motion. The motion passed unanimously. To Do: Ryan and Mike will reach out to DEA to determine how DEA treats ARCOS data in regard to FOIA requests. The Board will replicate DEA's response.
- 6. The Chief Financial Officer John Smolder reported the statistics for renewals on the new online system since it went live May 1st. He mentioned the budget increase for the current FY, then went over the Cash Flow Summary, Fund Balance, Cash Balance and Net Income Statement.
