

President Bernabei called the meeting to order and recognized that a quorum was present. Notice of the meeting was previously posted on the West Virginia Secretary of State's website. The agenda for the meeting was also previously posted on the Board's website and made available through the Board's office. The meeting was opened with a prayer.

1. Motion was made by Board Vice President Lewis to approve the June 11, and 12, 2023, Board Meeting Minutes, and the July 28, 2023, Board Meeting Minutes. The motion was seconded by Board Member Rucker. The motion passed unanimously without discussion.

2. The Executive Director gave his report. Mr. Goff welcomed Rob Duncan to his first regular Board meeting since being appointed to the Board. Director Goff then gave a brief office update, which included applicant criminal backgrounds, recent legislative/agency contacts and a number of items that would be elaborated on further in upcoming reports. Mr. Goff mentioned some NABP meetings that he, Board members and staff would be attending in the next months. Motion was made by Board Vice President Lewis to approve the report. The motion was seconded by Board Member Kapourales and passed unanimously.

3. The Chief Financial Officer then gave his report. Mr. Smolder gave FY2018, 2019, 2020, 2021, 2022 and 2023, Year End Summaries along with FY 2024 YTD comparison. Mr. Smolder then followed with the cash balance and remaining Fiscal Year Budget along with reports that are provided on a quarterly basis. Mr. Smolder finalized his report with the Safety Committee Update meeting of no change since March for the new office. Motion was made by Board Vice President Lewis to approve the report. The motion was seconded by Board Secretary Bowyer and passed unanimously.

4. The General Counsel then gave his report. Mr. Morris gave an update on discipline, stating that all complaint cases were up-to-date and statutorily compliant. Mr. Morris then gave an update on the last legislative meeting he attended with DRPA Capehart. Mr. Morris then briefly discussed the deficient pharmacist continuing education problems that have been discovered recently during inspections and audits and offered that the issue would be discussed more in-depth about the issue during the executive session. Mr. Morris concluded his report by discussing the upcoming NABP meetings he would be attending in the coming months. Motion was made by Board Secretary Bowyer to approve the report. The motion was seconded by Board Member Misiti and passed unanimously.

5. The Director of Professional and Regulatory Affairs (DPRA) then gave her report. DPRA Capehart provided an update on the current state of COVID-19 in WV and COVID-19 vaccines, seven collaborative pharmacy practice agreement providers (Rachel Broschious-Schauble, Alice Mary Gahbauer, Angela Goodhart, Mary Ann Painter, Carrie Clutter, Briana Kocher, and Heather A. Johnson). Motion was made by Board Vice President Lewis to allow pharmacy technicians to register with a CPR class that does not have a "hands-on" component, but when the immunizing technician renews, he/she will need CPR with a hands-on component as is WVBOP policy. The motion was seconded by Board Member Duncan and passed unanimously. Motion was made by Board Vice President Lewis to approve the report. The motion was seconded by Board Member Kapourales and passed unanimously.

6. Motion was made by Board Member Kapourales to enter Executive Session to discuss complaint cases. The motion was seconded by Board Vice President Lewis and passed unanimously without discussion.
7. The Board exited Executive Session. Motion was made by Board Vice President Lewis to find probable cause to pursue disciplinary action in Complaint Case Nos. 2023-03-34B, and 2023-06-61, to dismiss Complaint Case No. 2023-05-50, and to accept the recommendations of the complaint committee in the remaining cases. The motion was seconded by Board Member Misiti and passed unanimously.
8. The Chief Compliance Officer (CCO) then gave his report. CCO LeMasters stated that a total of 211 inspections were conducted during the period from June 1, 2023, through August 31, 2023. The Board had received 1,309 suspicious order reports, of which 323 were zero reports, during the period from June 1, 2023, through August 31, 2023, with 31 reports requiring further investigation. After inquiries into each, no further action was required, as all 31 cases were resolved. LeMasters discussed the utilization of unscheduled inspections to aid in monitoring licensees throughout the period between annual/biennial inspection. The Chief Compliance Officer presented an update on the Drug Supply Chain Security Act (DSCSA) and continued methods to incorporate items into the inspection process to monitor for licensee compliance with the requirements of DSCSA. LeMasters then spoke of his visit to the Marshall University School of Pharmacy white coat ceremony, where he was the keynote speaker. Then he spoke about certification and training courses, which the inspectors and he had completed during the last quarter. To close his report, LeMasters discussed the topics covered during a meeting of the inspectors, which was held on September 5, 2023. Motion was made by Board Secretary Bowyer to approve the report. The motion was seconded by Board Member Rucker and passed unanimously.
9. DRPA Capehart then gave her update on the Legislative Session. DRPA Capehart summarized each of the rules that had changes that the Board approved in the July 2023 meeting, including, W. Va. CSR § 15-1, § 15-3, § 15-7, § 15-12, § 15-14, and § 15-15. DRPA Capehart then explained that these rules were reviewed by the Legislative Joint Rules Committee on September 13, 2023, and passed with minor modifications.
10. DRPA Capehart then gave her update on training programs, permits, and licensing. DRPA Capehart recommended for Board approval the following Technician Trainee Programs that meet the requirements for approval: Pill Box Pharmacy, BlueWells Family Pharmacy Db a Southview, Right way Drug, Inc., Mutual Drug, Hometown and Man Pharmacy, Rivers Health, Cabin Creek Health Systems, NEO Nuclear Pharmacy Technician Training Program, Hurley's Drug Pharmacy Technician Trainee Program, WVU Medicine, and Reynolds Memorial Hospital. Motion was made by Board Member Kapourales to approve the pharmacy programs listed above. The motion was seconded by Board Member Misiti and passed unanimously. Motion was made to approve the pharmacy technician training programs listed above by Board Secretary Bowyer. The motion was seconded by Board Member Rucker and passed unanimously. Motion was made to place a two-year limit on all pharmacy technician trainee training programs by Board Secretary Bowyer. The motion was seconded by Board Member Kapourales and passed unanimously. Two new Pharmacist Immunization Programs were recommended for Board approval including CE Impact Pharmacist Immunization Program and University of Wisconsin School of Pharmacy Immunization Program. Motion was made

by Board Secretary Bowyer to approve the pharmacy technician training programs listed above. The motion was seconded by Board Member Rucker and passed unanimously.

11. The Controlled Substances Monitoring Program Administrator then gave his report. Mr. Goff gave a brief update of the CSMP contract and related grant funding. Director Goff also discussed some of the work performed by staff epidemiologists, including samples of data dashboards, stimulant flyers and other information. Motion was made by Board Member Kapourales to approve the report. The motion was seconded by Board Member Rucker and passed unanimously.

DOPPS Acree also provided a copy of the notification sent to licensees regarding the OTC naloxone trainings since the last Board Meeting for review. Lastly, buprenorphine access concerns were discussed. Berkeley County specifically experiencing difficulty with getting prescriptions filled for patients recently released from the ED with a prescription for buprenorphine/naloxone or buprenorphine alone. Motion was made by Board Member Misiti to approve the report. The motion was seconded by Board Member Duncan and passed unanimously.

Mr. Smolder then followed with the cash balance and remaining Fiscal Year Budget along with reports that are provided on a quarterly basis. Mr. Smolder finalized his report with the Safety Committee Update meeting of no change since March for the new office. Motion was made by Board Secretary Bowyer to approve the report. The motion was seconded by Board Member Duncan and passed unanimously without discussion.

DPRA Capehart including a summary of the changes that have occurred with COVID-19 vaccines and the transition of COVID-19 therapeutics from US government provided to the traditional commercial market. DPRA provided two meetings with health systems for establishing CPAs. The NABP Survey of Pharmacy Law for WV was completed and

returned. The WV Pharmacy Law Book 2023 was completed and distributed. Closing pharmacy statistics will be examined in the coming months. A request from CAMC Teays Valley was presented to use drone delivery. There were questions and a policy procedure manual will be requested to be addressed at the next meeting. Motion was made by Board Member Misiti to approve the report. The motion was seconded by Board Secretary Bowyer and passed unanimously without discussion.

Motion was made by Board Member Misiti to find probable cause to pursue disciplinary action in Complaint Case Nos. 2022-10-71B, 202307-66B, 2023-09-76, 2023-09-79, 2023-09-80, to accept the recommendations of the complaint committee in the remaining cases, and to allow Mr. Morris to negotiate and offer consent agreements to settle the cases where possible. The motion was seconded by Board Member Duncan and passed unanimously without discussion.

9. The Chief Compliance Officer (CCO) then gave his report. CCO LeMasters stated that a total of 212 inspections were conducted during the period from September 1, 2023, through November 29, 2023. The Board had received 1,208 suspicious order reports, of which 285 were zero reports, during the period from September 1, 2023, through November 29, 2023, with 139 reports requiring further investigation. After inquiries into each, no further action was required, as all 139 reports were resolved. LeMasters explained that the large increase in inquiries was directly related to the 110 SOR which were generated when a large health system in the state changed its primary wholesaler. LeMasters discussed inspection report updates and continued work with those licensees which hold Controlled Substance Permits from the Board of Pharmacy. The Chief Compliance Officer then spoke about the revised USP 795 and 797 Chapters, which are now official, and the efforts to educate both the team of inspectors and licensees of the changes in the revised chapters. LeMasters went on to speak of his attendance at the 2023 NABP Executive Officer, Compliance Officer, and Legal Counsel Forum. To close his report, LeMasters discussed the topics covered during a meeting of the inspectors, which was held on November 13, 2023. Motion was made by Board Member Duncan to approve the report. The motion was seconded by Board Member Kapourales and passed unanimously without discussion.

10. The Controlled Substances Monitoring Program Administrator then gave his report. Mr. Goff provided a brief overview of some CSMP stats and information that would be included in the CSMP Annual Report. On Sunday, March 10, and Monday, March 11, 2024, the West Virginia Board of Pharmacy ("Board") convened at its office in Charleston, West Virginia, for its regularly scheduled quarterly meeting. The meeting was open to the public.

President Bernabei called the meeting to order and recognized that a quorum was present. Notice of the meeting was previously posted on the West Virginia Secretary of State's website. The agenda for the meeting was previously posted on the Board's website and made available at the Board's office. The meeting was opened with a prayer.

1. Motion was made by Board Member Misiti to approve the December 3 and 4, 2023, Board Meeting Minutes. The motion was seconded by Board Vice President Lewis. The motion passed unanimously without discussion.
2. The Executive Director gave his report. Mr. Goff gave a brief update on the office and the recently concluded Legislative session. Director Goff also discussed an upcoming meeting with the staff of the Board of Medicine, the Board of Osteopathic Medicine and the Board of Registered Nurses, to be held at our office. Mr. Goff also mentioned the upcoming NABP National Meeting, which will be held in Fort Worth, Texas, this May. Motion was made by Board Vice President Lewis to approve the report. The motion was seconded by Board Secretary Bowyer and passed unanimously without discussion.
3. The Chief Financial Officer then gave his report. Mr. Smolder gave FY2018, 2019, 2020, 2021, 2022 and 2023, Year End Summaries along with FY 2024 YTD comparison. Mr. Smolder then followed with the cash balance and remaining Fiscal Year Budget along with reports that are provided on a quarterly basis, also stated the Budget would be due on May 1st, 2024, for FY 2025 and would have it ready in April for Board approval. Mr. Smolder finalized his report with the Safety Committee Update meeting of no change. Motion was made by Board Member Rucker to approve the report. The motion was seconded by Board Vice President Lewis and passed unanimously without discussion.
4. The General Counsel then gave his report. Mr. Morris gave an update on discipline, stating that all complaint cases were up-to-date and statutorily compliant. Mr. Morris then gave a detailed comparison analysis of all 2022 and 2023 complaint cases, explaining that while there was a 21% increase in the overall cases, the number of cases where probable cause was found was substantially the same. Mr. Morris further explained that the largest category increase in complaint cases related to customer service issues. Mr. Morris concluded by reporting that a "Recent Board Actions" tab has been added to the website under the "Public" tab, where all completed disciplinary actions will be reported for a rolling period of twelve months. Motion was made by Board Vice President Lewis to approve the report. The motion was seconded by Board Member Misiti and passed unanimously without discussion.
5. The Director of Professional and Regulatory Affairs (DPRA) then gave her report. DPRA Capehart updated the Board that NABP will no longer be providing the newsletters as part of NABP membership. There will be 3 levels of subscription service with WV still responsible for the content in the newsletter. Capehart to attend webinar in April for more information. At this time Board permits DPRA Capehart to determine direction regarding

newsletter and report back if subscription is needed. General update provided regarding Region III SAMHSA meeting on pharmacy access of buprenorphine in Charleston, WV in February 2024 and COVID-19 vaccines and therapeutics. Motion was made by Board Secretary Bowyer to approve the report. The motion was seconded by Board Member Rucker and passed unanimously without discussion.

6. Motion was made by Board Vice President Lewis to enter Executive Session to discuss complaint cases and license reinstatement applications/petitions. The motion was seconded by Board Secretary Bowyer and passed unanimously without discussion.
7. The Board exited Executive Session. Motion was made by Board Vice President Lewis to find probable cause to pursue disciplinary action in Complaint Case Nos. 2022-11-85, 2023-12-103B, 2023-12-105, and 2023-12-109, to table 2023-12-110 for further investigation, to accept the recommendations of the complaint committee in the remaining cases, and to allow Mr. Morris to negotiate and offer consent agreements to settle the cases where possible. The motion was seconded by Board Member Misiti and passed unanimously without discussion. Motion was made by Board Secretary Bowyer to deny Phillip E. Michael, II's petition for reinstatement of a pharmacist license, deny David M. Wasanyi's pharmacist reinstatement application, deny Jennie M. Burdette's pharmacist reinstatement application, and deny Michael L. Andria's request for pharmacist license reinstatement without retaking the West Virginia pharmacy law exam.
8. The Chief Compliance Officer (CCO) then gave his report. CCO LeMasters stated that a total of 235 inspections were conducted during the period from November 30, 2023, through February 29, 2024. The Board had received 1,426 suspicious order reports, of which 292 were zero reports, during the period from November 30, 2023, through February 29, 2024, with 79 reports requiring further investigation. After inquiries into each, no further action was required, as all 79 reports were resolved. LeMasters discussed the updated NABP BluePrint Inspection forms which are ready to be used for inspections of applicable facilities in West Virginia. The CCO then spoke about the comments and praise that inspectors have received from local DEA team members and a meeting with counsel for OIG related to OHFLAC licensee issues. LeMasters went on to speak about the North Carolina Board of Pharmacy Compounding Summit, which was a conference that Tom Robinette, Assistant Chief Compliance Officer, and LeMasters had recently attended. To close his report, LeMasters discussed the topics covered during a meeting of the inspectors, which was held on February 26, 2024. Motion was made by Board Vice President Lewis to approve the report. The motion was seconded by Board Secretary Bowyer and passed unanimously without discussion.
9. The Controlled Substances Monitoring Program Administrator then gave his report. Mr. Goff discussed the renewals of the annual CSMP and NarxCare contracts, and also the grant funding of both items. Director Goff also mentioned work being performed by staff epidemiologists, including updating various state data maps. Motion was made by Board Member Misiti to approve the report. The motion was seconded by Board Member Rucker and passed unanimously without discussion.
10. The Directory of Overdose Prevention and Patient Safety then gave her report. DOPPS Acree discussed the available nonprescription opioid antagonists available as well as including a FAQ on the Board's website regarding both prescription and nonprescription opioid antagonists. Proposed legislation was presented to the group for discussion as well as sent to the ODCP, DoHS, WVOEMS, and the State Health Officer. Data from the SOR

was presented in reference to MOUD (buprenorphine products) to demonstrate the issue of access within the state. Four previously created (NABP and CDC) PSA's were presented for potential for use. Discussion was made regarding permissions (DOPPS will provide this during the next meeting in June). Lastly, progress on the Halo Initiative was provided to the group for discussion. Motion was made by Board Secretary Bowyer to approve the report. The motion was seconded by Board Member Duncan and passed unanimously without discussion.

11. The Board then received information from representatives of CAMC regarding drone delivery of prescriptions between two buildings at their Teays Valley location. The Board asked CAMC to provide complete process and procedure documents for its review.
12. Training programs, permits, licensing: DPRA Capehart presented Pharmacy Technician Trainee Citizen's Drug Store, Ore's Clendenin Pharmacy, Clay Family Pharmacy, and Anile Pharmacy. All are on-the-job training programs. Collaborative Practice applications and/or notifications received from RPhs Painter, Clutter, Hogue, and Llayton. Motion was made by Board Vice President Lewis to approve the report. The motion was seconded by Board Member Misiti and passed unanimously without discussion. ProACT, Marshall Pharmacy and Dr. Zach Hansen have been selected to participate in a study designed by Dr. David Fiellin and Dr. Paul Joudrey, and other researchers at the Yale School of Medicine and other academic centers participating in the National Institutes of Health — National Institute on Drug Abuse (NIH-NIDA) Clinical Trials Network (CTN). The funded study was designed to compare the effectiveness of methadone versus buprenorphine in patients at high risk for leaving treatment. Participation in this study requires them to dispense methadone for Opioid Use Disorder (OUD). DEA has issued an exception to 21 CFR 1306.07(a) and 1306.04(c) by the DEA. WV BOP to issue a letter of acknowledgement of their participation in the study for the dates of the study. Motion was made by Board Secretary Bowyer to approve the letter. The motion was seconded by Board Member Misiti and passed unanimously without discussion.
13. Board President Bernabei then gave a brief Medical Cannabis Advisory Board update.
14. Board Member Duncan then gave his CE Committee update.
15. Board Secretary Bowyer then gave a brief NABP update.
16. The Legislative Report was then presented by DPRA Capehart. The Legislative Update 2024 table was provided for the benefit of the group. All of the WV BOP Proposed Rules passed and once signed will be filed with the WV Secretary of State. The following bills have passed but are awaiting signature: HB 5105 passed to eliminate vaccine requirements in virtual public schools and parochial/private schools. SB 475 relating to recovery residences; SB 668 increasing the annual amount of pseudoephedrine to be purchased OTC; SB 679 relating to hemp derivatives and kratom; SB 453 PEIA/PBM transparency reimbursement bill; SB 325 340b bill.
17. President Bernabei and Board Member Duncan then discussed the problems currently impacting pharmacies related to pharmacy reimbursements and how these problems may further develop over time.
18. President Bernabei then opened the floor to discuss any new information not previously discussed. No new information was received.
19. The Board selected June 2nd and 3rd, 2024, as the dates for the next quarterly board meeting. The meeting location will be determined at a later date.

20. Board Vice President Lewis moved to adjourn. Board Secretary Bowyer seconded the motion, which passed unanimously without discussion.

1. Motion was made by Board Member Rucker to elect Dennis Lewis, President, David Bowyer, Vice President, and Jenna Misiti, Secretary. The motion was seconded by Board President Bernabei. The motion passed unanimously without discussion.
2. Motion was made by Board President Bernabei to re-appoint James Rucker and David Bowyer to the Complaint Committee. The motion was seconded by Board Member Misiti. The motion passed unanimously without discussion.
3. Motion was made by Board President Bernabei to appoint Rob Duncan to the CPE committee. Board Member Rucker seconded the motion. The motion passed unanimously without discussion.
4. Motion was made by Board Secretary Bowyer to approve the March 10 and 11, 2024, Board Meeting Minutes and the April 15, 2024, Budget Board Meeting Minutes. The motion was seconded by Board Vice President Lewis. The motion passed unanimously without discussion.
5. The Executive Director gave his report. Mr. Goff gave a brief office update and mentioned that Mr. Tom Robinette was planning on retiring from pharmacy inspections later this year. He also discussed the recent joint meeting with staff from the Board of Medicine, the Board of Osteopathic Medicine and the Board of Nursing. Motion was made by Board Member Misiti to approve the report. The motion was seconded by Board Secretary Bowyer and passed unanimously without discussion.
6. The Chief Financial Officer then gave his report. Mr. Smolder gave FY2018, 2019, 2020, 2021, 2022 and 2023, Year End Summaries along with FY 2024 YTD comparison. Mr. Smolder then followed with the cash balance and remaining Fiscal Year Budget along with reports that are provided on a quarterly basis. Mr. Smolder finalized his report with the Safety Committee Update meeting that the office had on May 28, 2024. Motion was made by Board Vice President Lewis to approve the report. The motion was seconded by Board Member Misiti. The motion passed unanimously without discussion.
7. The General Counsel then gave his report. Mr. Morris gave an update on discipline, stating that all complaint *cases* were up-to-date and statutorily compliant. Mr. Morris then explained he has been working with DPRA Capehart and the Legislative Committee preparing for the upcoming legislative session. Finally, Mr. Morris discussed a comparative report requested by Board Secretary Bowyer relating to discipline reported by all states to the NABP's clearinghouse compared to the Board's discipline cases. Motion was made by Board Member Rucker to approve the report. The motion was seconded by Board Vice President Lewis. The motion passed unanimously without discussion.
8. The Director of Professional and Regulatory Affairs (DPRA) then gave her report. DPRA Capehart updated the Board that articles and preparation for the mid-June/July Newsletter is in preparation at this time. Attended the NABP webinar regarding newsletter changes and still would prefer to try in-house at this time. COVID-19 vaccination type will be

selected next week by FDA. DPRA Capehart presented the concept of the Universal Pharmacy Jurisprudence Exam (UPJE) being planned by NABP for launch 2026. Board requested regular updates on its progress. The participation in the self-administered hormonal contraceptive program is growing as Walmart pharmacies just launched the program state-wide. WV has had 6 pharmacies closed (2 Chain pharmacies, 4 "regional" chain pharmacies) and 6 pharmacies (3 Independent pharmacies, 3 pharmacies affiliated with FQHCs) open between December 2023 and April 2024. DPRA Capehart has provided multiple WV Pharmacy Law Update CEs throughout the spring and will continue into the fall. Finally, Dr. Ginger Scott is retiring from WVU School of Pharmacy and a letter of appreciation from the Board was provided for her service to WV and the Board since 2001. Motion was made by Board Member Duncan to approve the report. The motion was seconded by Board Member Misiti. The motion passed unanimously without discussion.

9. Motion was made by Board Vice President Lewis to enter Executive Session to discuss complaint cases and license reinstatement applications/petitions. The motion was seconded by Board Secretary Bowyer. The motion passed unanimously without discussion.

10. The Board exited Executive Session. Motion was made by Board Vice President Lewis to find probable cause to pursue disciplinary action in Complaint Case *Nos.* 2024-02-18B and 2024-04-30, and to accept the recommendations of the Complaint Committee in the remaining cases, and to allow Mr. Morris to negotiate and offer consent agreements to settle the cases where possible. The motion was seconded by Board Member Misiti and passed unanimously without discussion. Motion was made by Board Secretary Bowyer to accept the settlement offer in Complaint Case No. 2023-12-109. The motion was seconded by Board Member Rucker. The motion passed unanimously without discussion.

11. The Chief Compliance Officer (CCO) then gave his report. CCO LeMasters stated that a total of 218 inspections were conducted during the period from March 01, 2024, through May 24, 2024. The Board had received 899 suspicious order reports, of which 291 were zero reports, during the period from March 01, 2024, through May 24, 2024, with 54 reports requiring further investigation. After inquiries into each, no further action was required, as all 54 reports were resolved. LeMasters discussed a meeting with representatives from the Accreditation Commission for Health Care in which the representatives agreed to enhance communication between their agency and the Board. The CCO then spoke about continued efforts with licensees that hold Controlled Substance Only permits with the Board. LeMasters went on to speak about working with licensees that may be experiencing reporting issues to the Controlled Substances Monitoring Program. The CCO continued his report with discussion about his recent attendance at the 2024 APhA national meeting, the recently announced upcoming retirement of Tom Robinette, Assistant Chief Compliance Officer and Inspector, and the addition of Brandon Dolly to the team of inspectors. To close his report, LeMasters discussed the topics that were covered during a meeting of the inspectors, which was held on May 20, 2024. Motion was made by Board Vice President Lewis to approve the report. The motion was seconded by Board Secretary Bowyer and passed unanimously without discussion.

12. Motion was made by Board Vice President Lewis to accept and follow the guidance from USP as it relates to USP 800. The motion was seconded by Board Member Misiti. The motion passed unanimously without discussion.

13.The Controlled Substances Monitoring Program Administrator then gave his report. Mr. Goff gave an update on the dispensed drug numbers, which included that most drug types continue to decrease, with the exception of stimulants. He also briefly discussed some of the projects staff epidemiologists were working on. Motion was made by Board Vice President Lewis to approve the report. The motion was seconded by Board Member Misiti. The motion passed unanimously without discussion.

14.Board President Bernabei then gave a brief Medical Cannabis Advisory Board update and invited a representative from The Foundry, a medical cannabis dispensary, to speak.

15.Training programs, permits, licensing: DPRA Capehart presented Pharmacy Technician Trainee Programs: Pharmalogic, Beckley Pharmacy #2, WVU Medicine Potomac Valley Hospital, Senior Life Rx Pharmacy, Bioscrip, Reed's Drug Store, Boone Memorial, and Reed's Pharmacy. All are on-the-job training programs. Collaborative Practice or notifications received from RPh Haileigh Hogue. Motion was made by Board Secretary Bowyer to approve the report. The motion was seconded by Board Vice President Lewis. The motion passed unanimously without discussion.

16.Board Member Duncan then gave his CE Committee update.

17.The Directory of Overdose Prevention and Patient Safety then gave her report. DOPPS Acree discussed legislative changes to the Access to Opioid Antagonist Act. Provided feedback received from WVDoHS and WVODCP regarding opioid antagonist reporting/ tracking. DOPPS Acree will continue to work with these two agencies until an agreed upon draft has been created. Blocked orders of buprenorphine (both mono-product and combo-product) were presented by month (Mar — May) showing an increase in doses blocked each month. Lastly DOPPS Acree provided a draft of resources for the state intended to be included on the BOP website with the intention of creating a resource for every county. A motion was made by Board Secretary Bowyer to approve the report. The motion was seconded by Board Member Duncan. The motion passed unanimously without discussion.

18.Motion was made by Board Vice President Lewis to create a committee to review the feasibility of creating a scholarship program funded by the Board. The committee members were to include Board Member Duncan, Board Secretary Bowyer, DPRA Capehart, and Mr. Morris. The motion was seconded by Board Member Misiti. The motion passed unanimously without discussion.

19.The Legislative Report was then presented by DPRA Capehart. The Board Legislative Committee will be meeting June 6, 2024 to continue discussion of necessary

modifications to legislative rules for the upcoming session. Additionally, rules may be necessary for recently passed bills including SB 668 and SB 325. These proposed changes will be presented to the full Board for approval. The staff will be creating a long-range plan for necessary changes and updates. Motion was made by Board Secretary Bowyer to approve the report. The motion was seconded by Board Member Duncan. The motion passed unanimously without discussion.

20.President Bernabei then opened the floor to discuss any new information not previously discussed. No new information was received.
