Mr. President and Mr. Speaker:

During the April 2018 Post Audits Subcommittee meeting, we reported multiple errors on the Volunteer Fire Department's *Statement of Expenditures* required to be submitted to the Legislative Auditor each year by February 14, in compliance with W.Va. Code §12-4-14. After noting that several of the departments reported either negative ending balances or significant large balances in their state accounts, we requested each department to submit bank statements for December 2017 and January 2018 in an attempt to verify these amounts were correct. Out of the 428 VFDs, only 236 (55%) responded. For the remaining 192 VFDs, the Legislative Auditor's Office was unable to make contact with a department representative or if a representative was contacted, the VFD did not supply the information requested.

Several things were noted through our analysis of the information that was collected. Most importantly, the ending balance on the *Statement of Expenditures* for 2017 and the ending balance on the bank statements only matched for 97 of the 236 departments reviewed. In other words, only 41% of the ending balances reported to the Legislative Auditor through the current reporting mechanism could be verified as correct. Of the remaining 139, one department's funds appeared to be so integrated with funding from other sources, that we were unable to determine an accurate amount for its state funding balance; five departments never submitted a *Statement of Expenditures* for 2017; 21 VFDs submitted a *Statement of*

Expenditures for a fiscal year ending on a different date than December 31, 2017, making it impossible to compare them to their bank statements; and 112 submitted bank statements that did not match their Statement of Expenditures balance.

Of the 236 departments, we also noted that, as of December 31, 2017, 22 departments had more than \$100,000 remaining in their state accounts, with one account having over \$330,000 in its state account. In contrast, 176 departments had balances in their state accounts of less than \$50,000. While there were 22 departments with an account balance in excess of \$100,000 that is not necessarily a negative connotation, as some departments will accumulate funding to pay for expensive equipment upgrades. A breakdown of the balances for the departments that cooperated with our request can be noted in the figure below.

Of the 192 departments that either did not send in the bank statements as requested, or were unable to be contacted, 171 filed the yearly *Statement of Expenditures*. These ending balances reported to be between \$0 and \$318,944. Unfortunately, as noted earlier with the departments that submitted their bank statements, these amounts may not be accurate. As noted above, many of the departments report on a Fiscal Year ending on a date other than December 31; therefore, the information can be over 8 months old before the *Statement of Expenditures* is filed on February 14 of each year.

A list of the 236 departments and their December 31, 2017 bank statement balances is attached to this letter for your convenience. We have also attached a list of those departments that did not submit bank statements and the ending balance as stated on their Statement of Expenditures, with the caveat that these amounts are self-reported and may be incorrect. As of the date of this report, there are 21 departments that did not provide bank statements and have failed to file their *Statement of Expenditures*.

Based on these results, and the internal operational methods of the Post Audit Division, the Legislative Auditor has determined that the annual *Statement of Expenditures* is an antiquated method for analyzing transactions that is no longer applicable and generally does not provide an accurate representation of the transactions of the volunteer fire departments in a given year. Additionally, requiring representatives of these fire departments to complete this document places an unnecessary burden on the individuals who have volunteered their time to their communities to provide a lifesaving service, not to spend their time filling out financial documents or interpreting WV Code.

The Legislative Auditor recommends the Legislature modify WV Code §12-4-14(g)(B) by removing the *Statement of Expenditures* and instead require all VFD's to submit bank statements for the state account, with check images, for January – December of the previous year. This will align the statutory requirements with current methodologies, increase the efficiency of the VFD audits, eliminate the timing differences and inaccuracies of the data, and allow the VFD representatives to focus on fighting fires.
