## EDUCATION

- Employment of 50 personnel dedicated to serving Region 2 counties.
- The Advantage Valley District Western Consortium partnered with Mountwest CTC to serve over 6,500 students in 16 high schools / career and technical centers in Cabell, Mason, Putnam, Wayne and Collins Career Center/South Point High School, Ohio. Our consortium awarded over 8,300 EDGE college credits this past year. Approximately 450 high school seniors visited MCTC and RCBI. The Career & Technical Education Expo hosted over 900 high school seniors visiting over 30 area business and industry reps and colleges.
- 2,413 audiological evaluations, hearing aid checks, central auditory evaluations, hearing screenings, auditory training checks, earmold impressions, consultations, and technical assistance.
- Targeted professional development for 3,202 participants with 165 sessions.
- Regional academic activities for over 500 students.
- Project TEIR – Math Science Partnership grant through the WVDE (2011-2014)-26 participants.
- Sustained technical assistance in targeted schools including principal, academic coaching, as well as diagnostic evaluations.

**MAJOR ACCOMPLISHMENTS:**

- Provide elementary mathematics teachers in grades 3-5 the opportunity for sustained, research-based professional development designed to improve both mathematics content knowledge and instructional practice.
- Offers participating teachers a variety of professional development experiences including participation in four mini-institutes held on Saturdays per grant year, monthly on-line professional learning communities and a two-week summer mathematics institute.
- All sessions focus on modeling the utilization of providing quality and research-based mathematics instruction using engaging, high quality instructional materials to address alignment with common core/NextGen standards; balanced assessments that support student learning and integration of technology utilizing 21<sup>st</sup> century instructional materials.
- Marshall University professors representing both the College of Science and College of Education were heavily involved in researching the alignment of the common core/NextGen standards to the content included in the three elementary adopted mathematics textbooks (i.e., Everyday Math, Investigations and Math Expressions) to promote teacher knowledge of the application of mathematics with real world experiences..

**SUMMARY OF STRATEGIC PLAN RESULTS:**

Year one (SY 2011-2012) focused on fractional development and common assessments that support student learning. Year two (SY 2012-2013) focused on elementary algebraic and geometric measurement strand and year three (SY 2013-2014) focused on geometry including a continuation of the balanced assessment philosophy.

The ESL Cohort has provided practicing teachers the opportunity to obtain ESL certification and has benefitted counties by addressing the crucial shortage of both highly qualified and effective ESL teachers.




## RESA 2 PROGRAM ALLOCATIONS




## RESA 2 SUPPLEMENTARY GRANT FUNDS


