

- PreK-12 professional development sessions for **6,798** participants
- Adult Basic Education (ABE) professional development for **99** participants
- Substitute teacher training for **164** participants

MAJOR ACCOMPLISHMENTS:

- Provided the following training sessions: 40 Developmental Assets, Bullying and Suicide Prevention, Pregnancy Prevention, and Obesity Prevention/ Nutrition Education.
- Administered Search Institute 40 Developmental Assets training to school and community members and coordinated a monthly program at a local middle school.
- Coordinated a Regional Adolescent Health Educational Forum for professionals throughout the region, offering CEU's for Social Workers and Nurses.

The Adolescent Health Coordinator attended community meetings throughout the region and contributed by providing educational sessions and materials to community members. MAJOR ACCOMPLISHMENTS:

- Provided technical assistance to local Adult Basic Education (ABE) programs, which served 2,529 adult students during Fiscal Year 2013.
- Administered the SPOKES Career Readiness Program, which enrolled 348 adult students referred by the West Virginia Department of Health and Human Resources during FY13.
- Distributed \$32,739 in state funds to GED® testing centers to cover the cost of more than 740 participants in the GED® test.

MAJOR ACCOMPLISHMENTS:

• 422 student tests performed

• 82 auditory processing evaluations

• Testing performed at clinics in Berkeley, Hampshire and Pendleton counties

SUMMARY OF STRATEGIC PLAN RESULTS:

The Audiology service does not have a program-specific strategic plan. It is my goal to provide additional outreach programs to the schools such as classroom noise readings and teacher inservices. In the past year, I organized calibration of school-based equipment and consulted with Special Education Director on purchase of new equipment.

PROGRAM TITLE: Head Start/Pre-Kindergarten and Early Head Start

PURPOSE: The programs provide a comprehensive approach to preparing children birth to age five for future school and life success. Children learn through developmentally appropriate child development services; children are screened and receive follow-up health and nutrition services; adult education and family literacy activities support family involvement in their child's preparation for school; and social services connect parents with resources to meet their individual family needs.

MAJOR ACCOMPLISHMENTS:

- 406 Head Start children ages 3 to 5 were educated in 23 classes at 11 sites in Berkeley, Jefferson, and Morgan Counties.
- 114 pregnant women, infants and toddlers were served in Early Head Start through home-based and center-based programs.
- 140 pre-kindergarten children age 4 were served through collaborations with community partners.
- All children were screened for development, speech, hearing, vision, dental, mental and physical health; follow-up services were also provided.

SUMMARY OF STRATEGIC PLAN RESULTS:

RESA 8 utilized research-based strategies to support increased vocabulary development, phonemic awareness, and social-emotional development. It engaged in family literacy initiatives to assure the direct involvement by parents in their child's learning.

MAJOR ACCOMPLISHMENTS:

- Over 7700 Computer Repair service calls completed
- Supported Searchsoft, eWalk, mobile equipment and routers.
- Installed software and provided training for whiteboards in classrooms
- Refurbished donated computers and placed them in classrooms
- Recycled old equipment that was no longer in service

SUMMARY OF STRATEGIC PLAN RESULTS:

Computer Repair completed over 7,700 requests with an average turn-around-time of less than 3.7 days for repairs on hardware and software. The program evaluations averaged a score of 4.64 out of 5.0. Technicians obtained training and certifications to support their efforts in providing outstanding service to the school systems.

During 2012-2013, RESA 8 provided technical assistance and workshop opportunities for 6,613 teachers and administrators in the implementation of the West Virginia Next Generation Content Standards and Objectives. Teachers and administrators were able to deepen their understanding of the instructional shifts and student learning outcomes that contribute to student academic success with the Next Generation Content Standards and Objectives framework. RESA 8 sponsored regional academic fairs that facilitated student participation in project based learning, collaborative learning experiences, and presentation skills.

RESA 8 PST provides fire departments, EMS squads, law enforcement, industry, and the general community with a wide variety of cost-effective training.

MAJOR ACCOMPLISHMENTS:

- 5,730 participants were enrolled in 675 classes
- Coordinated the Eastern Panhandle Training Weekend, and supported training weekends in Mineral and Pendleton Counties
- Implemented new EMT and EMR Curriculum to meet new National Education Standards. RESA 8 PST published a preceptor guide that is used statewide
- Transitioned Rescue Training to meet NFPA 1006 Standards
- Implemented policies and procedures to meet new Legislative Rule for Fire Service Training
- More Fire Service classes being offered in blended learning format online for cognitive knowledge and hands-on for psychomotor skills
- RESA 8 PST had a lead role in WVDE becoming IFSAC Accredited

SUMMARY OF STRATEGIC PLAN RESULTS:

Class evaluation forms and commitment statements help maintain student, instructor, and program integrity. Instructor in-services were held. PST Instructors were certified and recertified according to WVDE procedures. Program Evaluations mailed to instructors and departments received a mean response of 4.50 with 5 being the highest rating.

MAJOR ACCOMPLISHMENTS:

- Provided Non-Violent Crisis Intervention training (CPI) to 185 teachers, paraprofessionals, and bus drivers representative of all eight counties and the West Virginia Schools for the Deaf and Blind.
- Coordinated training for all middle and high school principals in the implementation of Support for Personalized Learning with the West Virginia Department of Education
- RESA 8 county directors of special education met on a monthly basis with the RESA director
 to review additional needs, concerns and current issues. Activities were designed and
 implemented to address these issues.
- The RESA 8 Director of Special Education served as a liaison between the state office of special programs and local directors to provide updates and information about state initiatives.
- In conjunction with the county directors of special education and the West Virginia Schools for the Deaf and the Blind, collective and individual needs of the local education agencies were identified and professional development was provided.

SUMMARY OF STRATEGIC PLAN RESULTS:

The goal to increase student achievement was accomplished through delivery of training in coteaching, differentiated instruction, writing and math strategies. Efficient and effective systems were fostered through regional delivery of high quality professional development, lending library of professional journals and books, and cooperative purchasing.

PURPOSE: As defined by Part C of the Individuals with Disabilities Education Act: to enhance the capacity of families with children, who either have or are at risk of having delays in their development, by providing services and supports in a natural environment.

MAJOR ACCOMPLISHMENTS:

- 512 children referred
- 439 children received services under IDEA
- 100 percent of all eligible children went to IFSP within 45-calendar days

SUMMARY OF STRATEGIC PLAN RESULTS:

The WV Birth to Three Regional Administrative Unit continues to participate in community- based events to raise public awareness about early intervention services provided under Part C of IDEA, allowing us to identify children between the ages of birth through 35-months of age who have or may be at risk of having developmental delays. One-hundred percent of all eligible children receive an evaluation, assessment and initial IFSP within 45-days of referral. The Child Outcome Summary Form (COSF) is used at the initial IFSP, six-month review and upon exit from the system to measure child progress and family satisfaction.
