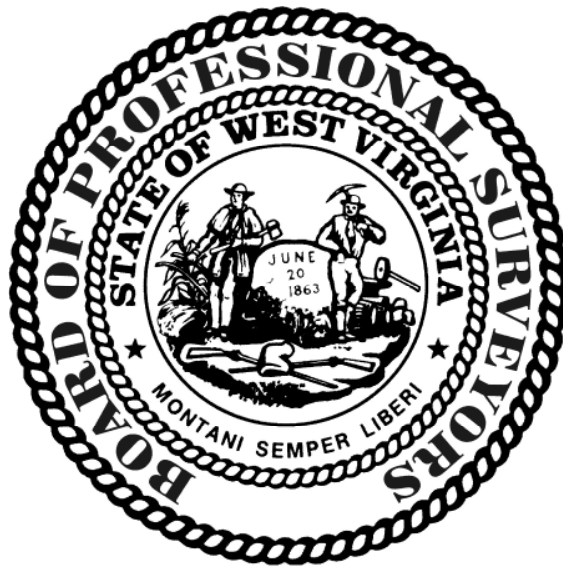

STATUTORY HISTORY



West Virginia Code § 30-13A – June 10, 2010

West Virginia Code § 30-13A is accompanied by four (4) Legislative Rules and one (1) Procedural Rule that govern or detail licensing, continuing education, complaints, fees, and minimum standards, associated with professional surveying.

Series 1 – Legislative Rule 23CSR1 – ~~April 1, 2012~~ May 1, 2014

Examination and Licensing of Professional Surveyors in West Virginia

Revised during the 2014 West Virginia Legislative Session (H.B. 4039)

Significant changes include:

- Provides for review and consideration of military veterans service for licensure
- Provides for active licensees deployed for military service an exemption from the annual renewal fee
- Changes “exam” to “examination” throughout the rule
- Changes specific W. Va. Code references to “W. Va. Code §30-13A-1 *et seq.*”
- Deletes references to the 8-years experience applications on or before December 31, 2012.

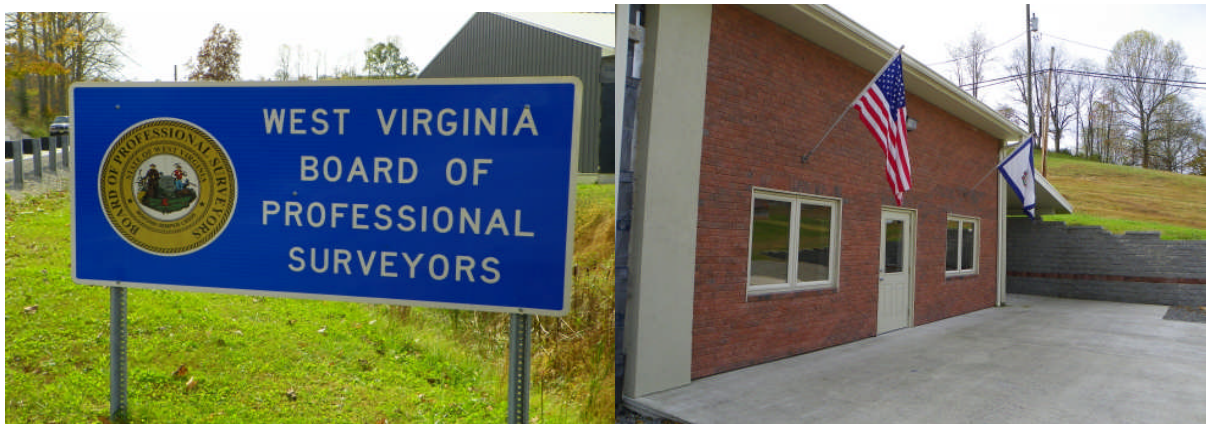

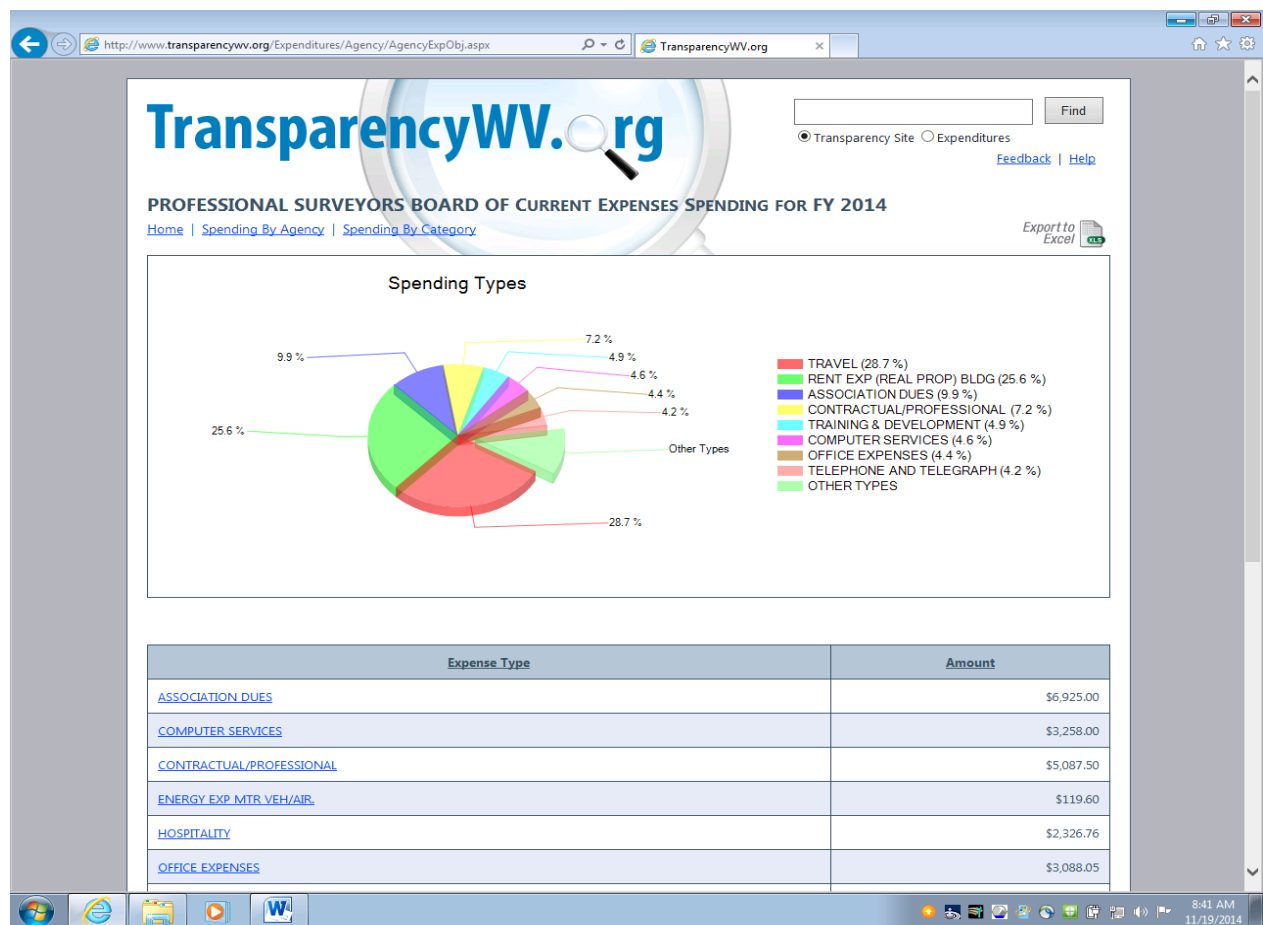
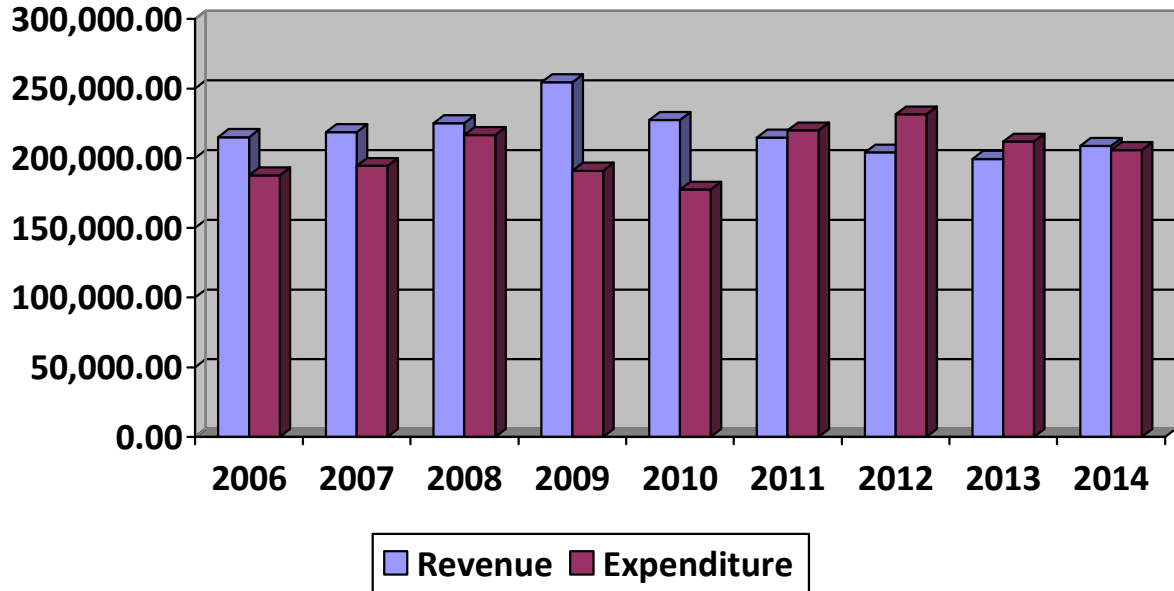

(2006-2014)



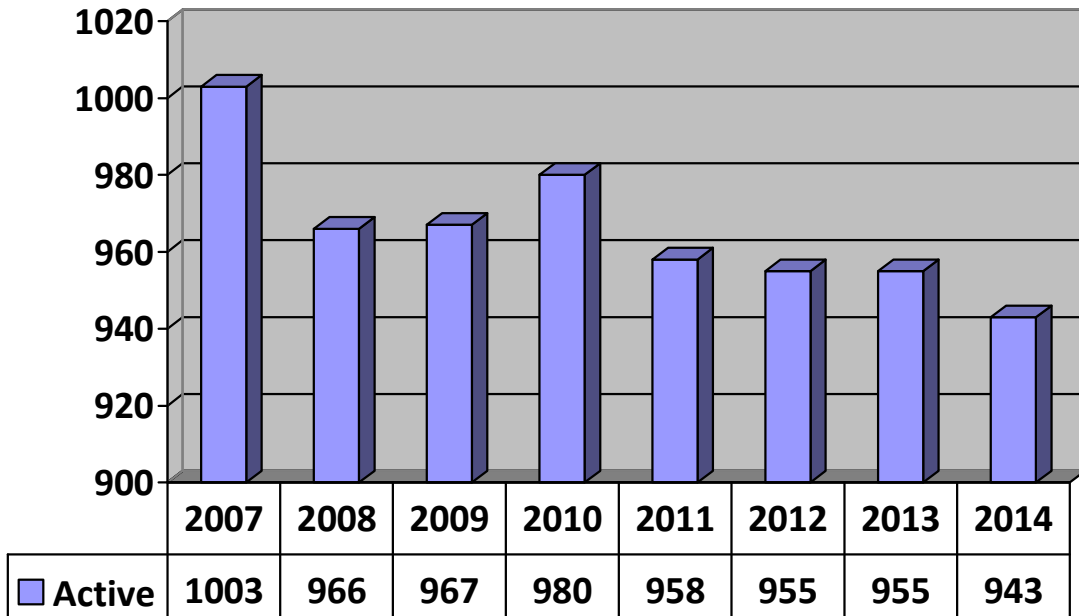

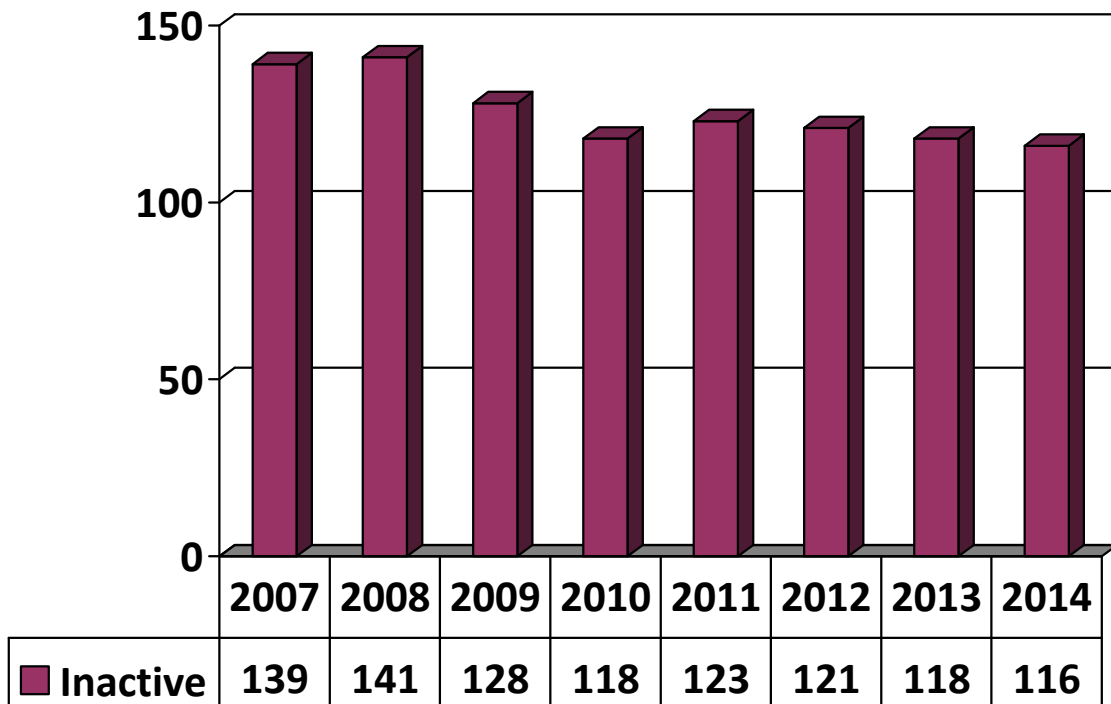

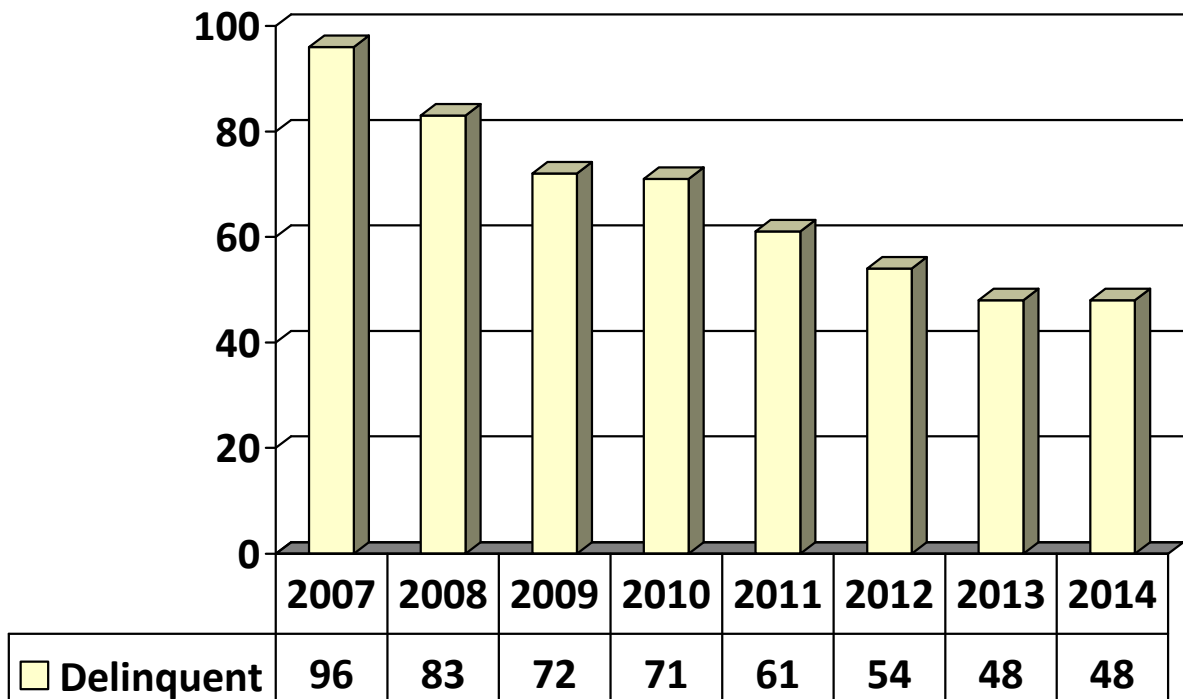
PROFESSIONALSURVEYORS 8-YEAR REVIEW

PROFESSIONAL SURVEYORS 8-YEAR REVIEW DELINQUENT (2007-2014)

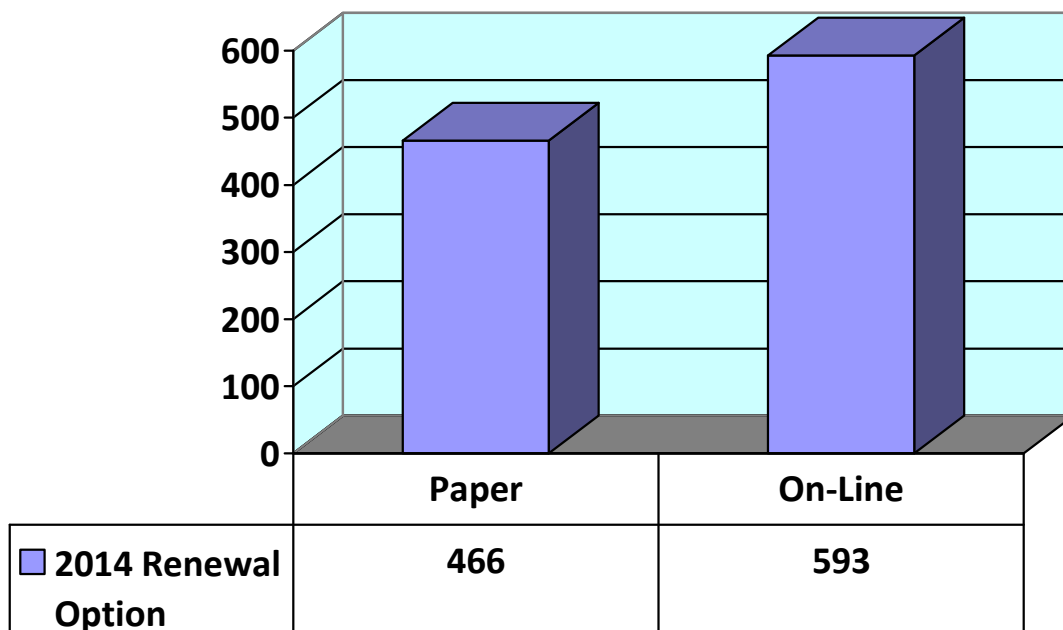


LICENSE RENEWAL (Active & Inactive)
