

ACTIVE (2011 - 2020)




PROFESSIONAL SURVEYORS 10-YEAR REVIEW

INACTIVE (2011 - 2020)




PROFESSIONAL SURVEYORS 10-YEAR REVIEW DELINQUENT (2011-2020)





WVBPS INVESTIGATION TEAM

The Complaint Investigation Team assist the Board in the review and investigation of complaints by summarizing complaint allegations and reviewing the surveyor's response; providing technical review and evaluation of the facts as they relate to the law, rules or regulations; and to make recommendations to the Board for further action. The Investigation Team, which is chaired by Board Member Lantz Rankin, P.S., consists of other licensed professional surveyors who also function as contract investigators. The members represent different regions throughout the state and do not investigate complaints within their respective areas.
