

Division of Personnel requires those applying for above base levels to be registered with Board. This keeps out-of-state applicants from even applying. PHS worked up changes to allow for Out-of-State applicants with experience and/or registration in another state. The changes are Public Health Sanitation Proposal

The current language in the DOP qualifications for the Sanitarian 2, Registered Sanitarian, Sanitarian Supervisor and Sanitarian Chief excludes candidates who may qualify but are not currently required to register with the WV State Board of Sanitarians. Sanitarians or Environmental Health Specialists are employed by other states, federal agencies or private companies will hold national or state certifications as Registered Environmental Health Specialist (REHS) or Registered Sanitarian (RS).

Certification as a Registered Sanitarian by the West Virginia State Board of Sanitarians.

#### Sanitarian Chief

Certification as a Registered Sanitarian by the West Virginia State Board of Sanitarians
